Dear Mr. Detra:

This is in response to your letter to Brigadier General Mountcastle of April 23, 1998, for information concerning awards to the 188th Aviation Company in Vietnam.

In order to be awarded a decoration, the unit itself must be cited in Department of the Army general orders (DA GO). Enclosed is a statement of service for the 188th Aviation Company, which shows that it is authorized two decorations for its service in Vietnam: the Meritorious Unit Commendation (Army) for the period May 4 to December 31, 1967 (cited in DA GO 48, 1968); and the Republic of Vietnam Cross of Gallantry with Palm for the period May 4, 1967, to May 17, 1968 (DA GO 21, 1969, as amended by DA GO 46, 1969). Although the company was cited in DA GO 22, 1968, for the Republic of Vietnam Cross of Gallantry with Palm for the period March 1, 1966, to March 26, 1967, it was not awarded credit for the decoration because the company did not arrive in Vietnam until May 4, 1967.

If the company were active, streamers would be authorized for the two unit decorations. Campaigns, however, are displayed by companies by means of silver bands on the unit guidon rather than by streamers.


This replies to your letter dated February 5, 1998, requesting information on unit colors.

Companies are not authorized shoulder sleeve insignia (SSI) in their own right. They wear the patch of their next higher command. Distinguishing flags are authorized for organizations, to include, Major Army Commands and other organizations authorized SSI. Guidons are authorized for the following types of units: companies, batteries, troops, detachments, etc. Therefore, the 188th Assault Helicopter Company would not have been authorized an SSI or a distinguishing flag.

Unauthorized flags are used for the same reason that unauthorized patches are worn. The commander approves use of these items to increase the esprit or camaraderie of the unit.

Dear Mr. Detra,

This is in response to your letter of December 28, 1997, concerning the 188th Aviation Company and 269th Aviation Battalion.

I regret that I am unable to assist you in having the battalion's records copied for you. You must realize that the Center of Military History would be charged the same \$525 and that if the records are copied for you, other veterans would want the same service. Because of resource constraints, the Center cannot afford such expenses.

Guidons used in Vietnam were normally disposed of upon the units' inactivation, since it was considered cheaper to make a new one than to store it. For a description, however, you should write to the Director of The Institute of Heraldry,

The Institute can also recommend a company that could make a guidon to the correct specifications.
