In response to your inquiry of July 30, 1998

, the following checkmarked paragraph(s) apply:

The Department of the Army does not prepare histories of individual units, but they are sometimes compiled by unit personnel or private organizations. Such histories may be available in bookstores, in libraries, from the publishers, from the units themselves, or from various veterans' associations. They are often published in limited quantities, however, and are frequently out of print. Large collections of unit histories are maintained by the U.S. Army Military History Institute, Carlisle Barracks, Pennsylvania 17013-5008, and the New York Public Library, Fifth Avenue and 42d Street, New York, New York 10018.

We have no record that a history has ever been written for the 308th Aviation Battalion, or for any element of the 101st Aviation.

Enclosed is a bibliography for the 10th and 269th Aviation Battalions. These publications may be available at your library, through interlibrary loan, or at bookstores specializing in military publications.

[X] Remarks: None of the units in question existed during World War II. The 269th Aviation Battalion was reorganized and redesignated August 17, 1987, as Headquarters and Headquarters Company, 18th Aviation Brigade, at Fort Bragg, North Carolina. A copy of the unit's Statement of Service is enclosed. A copy of an article from the November 1987 issue of Army magazine concerning the brigade's activation is also enclosed.

Company A, 9th Battalion, 101st Aviation, was constituted and activated on December 16, 1989, and shares in the lineage and honors of the 9th Battalion, 101st Aviation. A copy of the battalion's Lineage and Honors Certificate is enclosed. Lineage and Honors Certificates are prepared only for color-bearing organizations that are not subordinate elements of a color-bearing organization. Since Company A, 9th Battalion, 101st Aviation, is a subordinate element of the 9th Battalion, 101st Aviation, it is not entitled to a separate Lineage and Honors Certificate.
