

magazine, no later than the May/June issue and further provided no less than two-thirds of the membership responding has voted in the affirmative.

B.) An amendment, having been duly published, may be adopted by a vote of two-thirds of the regular members, in registered attendance, present and voting in affirmative, at the Annual Meeting.

C.) When a change or amendment to the Constitution is proposed, a Constitution Committee shall be appointed by the President and shall have jurisdiction over proposed changes or amendments to the Constitution and shall submit their recommendations to the Membership through the Board of Governors.

D.) No amendment to this Constitution may be considered until the text has been reviewed by a Constitution Committee and its recommendation has been submitted to the Board of Governors.

E.) Any such proposed amendment shall be examined by the Constitution Committee before submitting the same to the Board of Governors and thereafter, to the Membership. The Constitution Committee is authorized to correct the form of such amendment for the purpose of avoiding repetitions, illegalities and constitutional provisions, and to assure accuracy in its text, references, clearness and preciseness in its phraseology, but not materially changing its meaning and effect.


