

Article 1.- The export subsidy level be set as follows:

- SIXTEEN PIASTERS (VN\$16) for each kilogram (net) for cotton wool actually exported.
- SIXTEEN PIASTERS (VN\$16) for each kilogram (net) of duck feathers actually exported.
- FIVE HUNDRED PIASTERS (VN\$500) for each ton (net) of cattle bone actually exported.
- FIFTY TWO PIASTERS FIFTY CENTS (VN\$52.50) for each kilogram of black tea exported and actually sold on the market.
- TWENTY PIASTERS (VN\$20) for each kilogram (net) of black tea exported and actually sold for minimum FOB Saigon price of US\$434.34 per ton of 1,000 kilogram.
- TWENTY PIASTERS (VN\$20) for each liter of Nuoc Mam (fish sauce) exported.
- An additional export subsidy at the suggestion of the Export Subsidisation Committee, for handicraft products listed hereunder:

Lacquerware; porcelain (earthenware, china and porcelain); stone, earthen statues; mother-of-pearl products; silver and brass products; ivory and horn; wood; children's toys; dolls; leather; stuffed animals; hand-bag; belt; lamp and shade; musical instruments; bamboo; rattan; grass, hemp, 'buong' leaves; 'lat coi' fibres, coconut fibres; silk paintings; paper paintings; mass production; industrial drawings; handwoven silk and cotton cloths; ready-made garments; embroidered fabric; woollen rug; Vietnamese conic hat of latania leaves; caps; knitted or nylon products; imitation jewels; flowers made of paper, cloth or plastic; paper products, joesticks, carved candles; pastry mould of metal.

Article 2.- The export subsidy as provided under Article 1 above will be paid to the exporter by cheque from the Economy Ministry, on the strength of the following papers:

- Export licence from the Foreign Trade Directorate, already audited and amended by the Directorate of Custom, if there is at hand.
- Attestation of foreign exchange recovered from the Directorate of Foreign Exchange.

A part from these two documents; the exporter of black tea must present supporting document on the quantity of black tea actually sold.

Article 3.- Export subsidy stipulated under Article 1 applies to related export licences signed from January 1, 1969 to December 31, 1969.

Article 4.- Export subsidy mentioned in this interministerial decision will be

borne by the Export Subsidisation Account opened at the National Treasury.

- Article 5.- The Assistant for Commerce and the Secretary General of the Economy Ministry, the Cabinet Chief and Secretary General at the Finance Ministry, the Director General of Customs, the Director General of Foreign Exchange, the Director of Foreign Trade, are charged, each according to his function, with the execution of this interministerial decision.
