## Preface



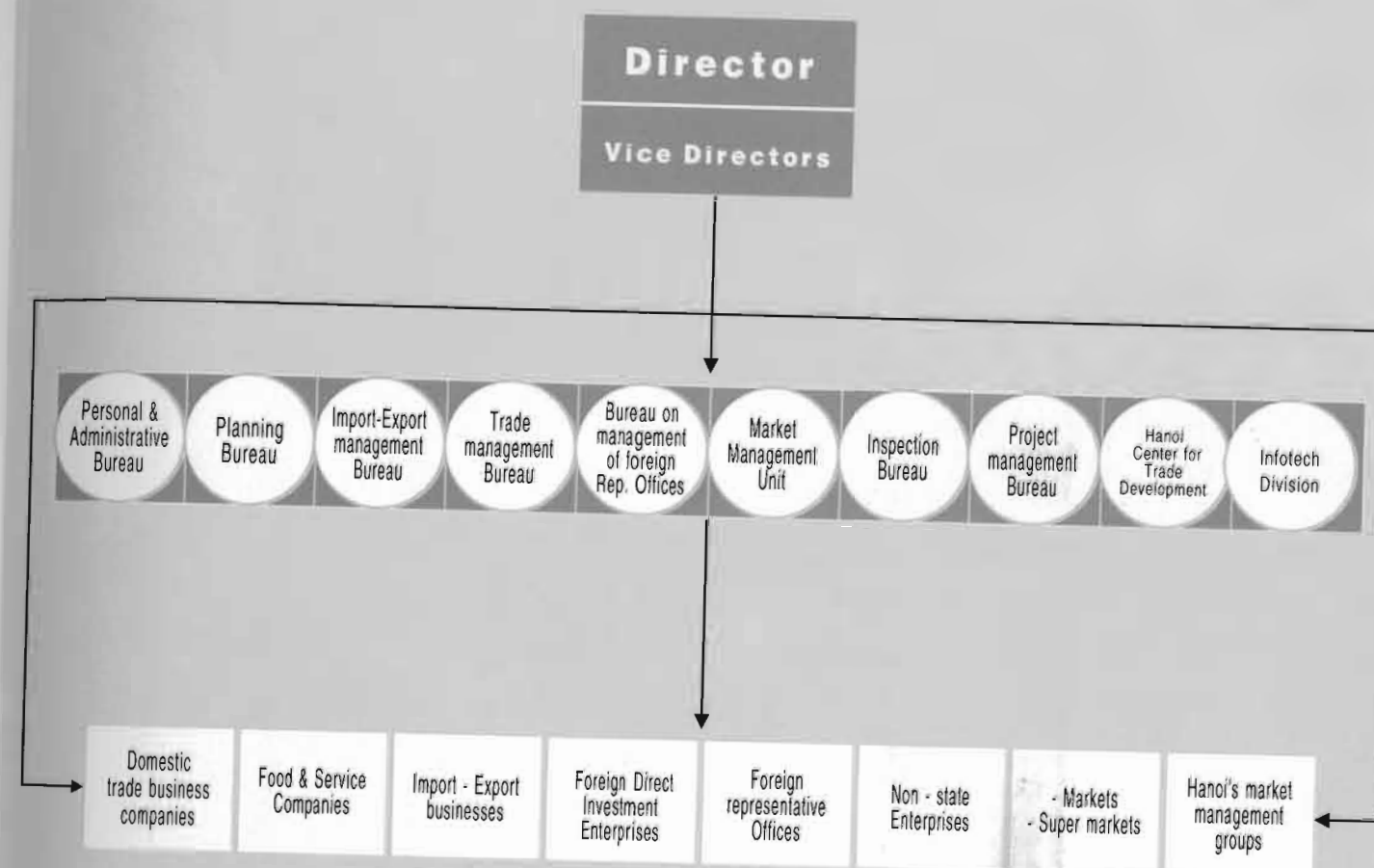

## Functions & Responsibilities of Hanoi Trade Department

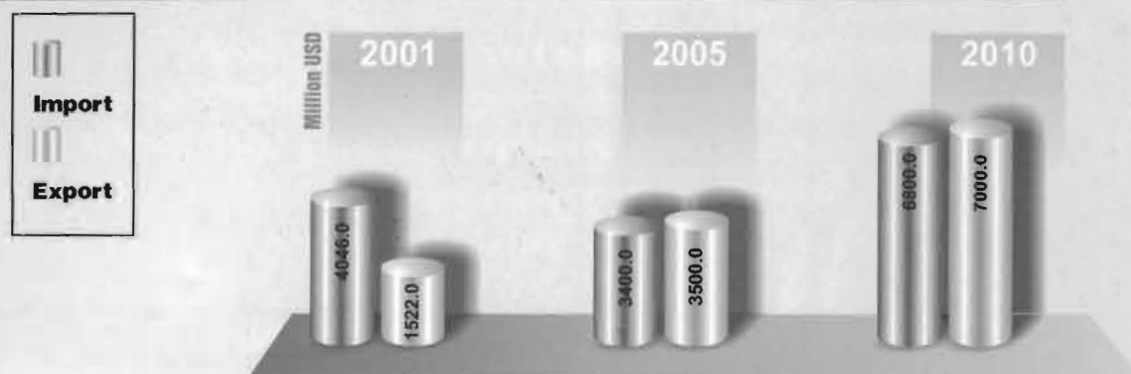

In order to promote trade activities, Hanoi Trade Department is willing to strengthen the trade relationship with International Trade Organizations in the World.

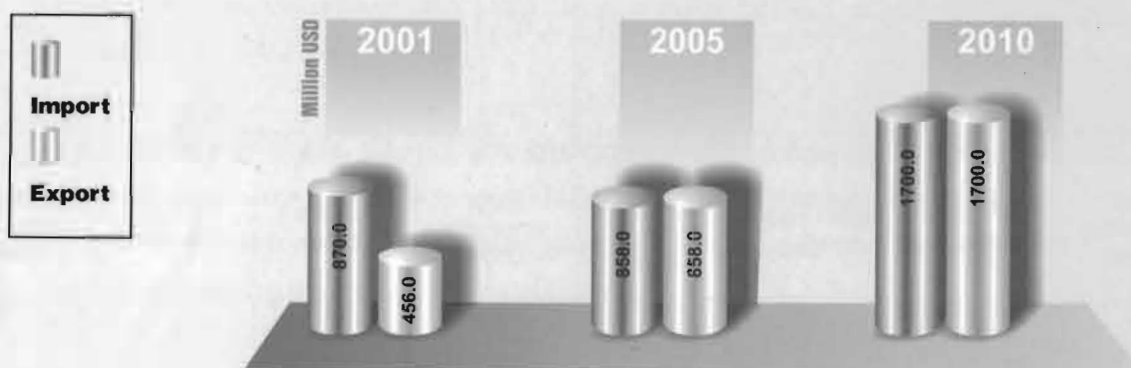


## Hanoi Growing up

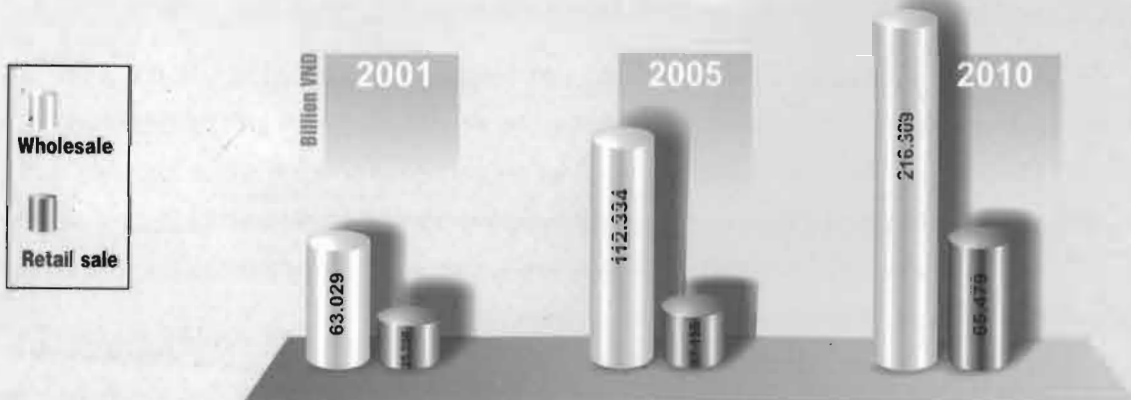
Import - export value within Hanoi urban area for the period 2001 - 2005 - 2010
