2. Development Context

Government Development Prospectus

Development in Viet Nam is now very rapid. The Government still maintains that it follows socialist principles but great reforms over the past ten years have opened up the way to a return of thinly disguised capitalism.

After the misery of twenty years of war and a subsequent decade of poverty and food shortages, the government started to dismantle the commune system and return land to individual families at the same time opening up the free market. The results have been impressive and Viet Nam has suddenly sprung from being a food deficit nation to being the third largest rice exporter in the world after USA and Thailand.

Opening up of the economy, demobilisation of much of the large army, making attractive terms for foreign investment and the recent ending of the US economic embargo are all creating the scene for massive economic growth.

Foreign investment in Viet Nam is already US\$2 billion with another US\$6 billion pledged. Property prices are soaring and trade grows at an uncontrollable pace. Singapore has become Viet Nam's largest trade partner with a tenfold growth in trade over the last four years.

Having witnessed the failure of the Soviet economic model, Viet Nam is veering more towards the Chinese style of economic reform and encouragement of joint venture.

Investment is encouraged in the development of manufacturing industries and oil exploration. Tourism is also seen as a major source of revenue. Industrial plantations, the traditional mainstay of the Vietnamese economy, are getting a boost of reinvestment and upgrading.

Major problems are being felt in the lack of infrastructure to support such rapid economic growth, lack of controls and taxation and the growing gap between private sector and the government sector economies. Uncontrolled growth could be a major threat to what is left of Viet Nam's precious biodiversity.

Human Demography and Impacts on Biodiversity

Viet Nam is already one of the most densely crowded countries in the world, with a population of 65 million people or over 200 per km². Some 89% of the population is made up of Viet and Muong people who occupy the two great agricultural deltas and the narrow coastal zone of the country. These areas are very densely populated with more than 500 persons per km². The remaining 11% of the population is made up of more than 40 different ethnic minorities. The most numerous minorities are the Mon-Khome group and the Thai groups in the south and north respectively. The H'mong, or Meo, are another important group which although not numerous affect very large areas of forest in the north of the country through their destructive form of shifting cultivation. The H'mong are recent settlers from southern China. Chinese (Han-Hoa) dominate in a few areas of northern Viet Nam.

The population grows at a rate of 2.4% per annum. Overpopulation is already a huge problem with landless poor being resettled in the central highlands at expense of the last extensive forests in the country. Forests are being cleared higher and higher into the hills, in areas quite unsuitable for sustained agriculture. The constant flow of refugees out of the country is mostly a reflection of the critical population imbalance rather than for political reasons.

Energy Issues

Viet Nam has large reserves of coal particularly in the north of the country. Coal and coal bricks are the main fuel used in northern towns.

Hydropower is becoming increasingly important. The Hoa Binh dam for example supplies all electricity to Hanoi and other northern towns. Viet Nam has no nuclear power but there are plans to build a first nuclear power station.

Petrol is imported for the running of the fast increasing number of cars and motorbikes in the country. However, Viet Nam has now started to exploit the offshore oil reserves on the southern continental shelf and may soon become self-sufficient and even an exporter of oil and gas.

In the south, most town households use charcoal for domestic cooking. This has a large impact on remaining forests. In village areas throughout the country the continued use of wood fuel is a continuing problem. Moreover, villagers with access to forest cut more wood than they need themselves and earn money by selling bundles of firewood at the roadside to passing lorries and trucks.

Even some industries are fuelled by wood. Cement and brick making consumes vast amounts of woodfuel.

Pollution and Waste Disposal

The National Plan for Environment and Sustainable Development proposes the establishment of a pollution control system and standards for controlling industrial pollution, wastes etc. The Ministry of Science, Technology and the Environment has subsequently developed a number of standards such as Maximum Permissible Concentrations (MPC's) that can be released in the form of toxic chemicals, dust, noise and water pollutants in the workplace and populated areas. Enforcement of these standards remains very weak but with the recent passing of the Law of the Environment things may soon improve.

There is almost no control at present of waste discharge into the sea or even into large rivers. One major concern must be the threat of oil spills off the southern coasts. This a very busy shipping lane where accidents could happen, an area where ships flush their bilges, and where Viet Nam is fast going ahead with oil exploration and the construction of drilling platforms. Contingency measures are not in place and a major oil spill could destroy much of the mangroves and coral reefs in the area.

Marine and Coastal Development

The marine environment is threatened by a variety of developments. The biggest threat is oil exploration on the southern shelf. Oilfield development rose from 41,000 tonnes production in 1986 to 5.2 million tonnes in 1992. This development involves not only more shipping and disturbance to the area but also a growing threat of oil spillage and pollution.

Viet Nam's inshore fisheries are heavily over-utilised. There are a total of 54,000 fishing boats. Fishery statistics for the seas north of 20N between 1987 and 1992 show that actual production has dropped by 39%, despite a 32% increase in total vessel power.

Coral mining is a serious development. Coral is mined and burned to produce lime and cement. Two cement factories in Khanh Hoa and Ninh Thuan (see Figure 4) each produce 20,000 tonnes of cement per year, requiring 80,000 tonnes of coral. There are many such factories along the coast.

Much of the seafront is being physically developed as tourism areas, factory sites or fishing villages. There is almost no natural undisturbed coastline left. Marine and coastal tourism is driving a new demand for souvenirs such as rare shells, turtles, decorative corals and so on, whilst collecting of ornamental fish for trade to Singapore is also a growing problem.

River pollution including upland silt wash-off, plus domestic and industrial discharge, is a serious threat to the marine environment. Coral reefs in Cat Ba National Park are being killed by the increased sediment load of the dyked Red River Delta. Pollution from ports and ships is also a threat. The number of ships registered in Viet Nam is over 800 with a total tonnage of over a million GRT.

Cultural Aspects of Resource Utilisation

There are some signs of traditional and cultural respect for nature and restraints on the utilisation of

natural resources. Some Thai villages in the north of the country still set aside small forest patches as areas to collect medicinal plants, perform burials and protect stream sources. Some Buddhist attitudes persist. Hunting is prohibited in the grounds of temples and on some forested hills around temples. Holy turtles are protected in the lakes around Hanoi. There is a superstitious reluctance to cut fig trees among most ethnic groups.

However, current attitudes remain for the most part entirely pragmatic. Everything that can be eaten, used, or sold is taken at every opportunity. Animal rights are not respected. Cruelty is commonplace, from the keeping of dogs in tiny cages prior to their slaughter as food, to the public teasing of exhibited animals in the national zoos.

Discrimination towards the ethnic minority peoples is strictly forbidden and each ethnic group has the right to use its own language and writing form, and to observe its own cultural traditions and customs. The government adopts policies aimed at development of all aspects so as to gradually improve the material and spiritual life of ethnic minority people. Preservation of many traditional uses of biodiversity and domestic varieties are preserved through the preservation of Viet Nam's diverse cultures.

Manpower and Training Capacity

The country lacks nothing in terms of manpower but has a shortage of trained staff in certain sectors especially conservation work and a lack of funds to employ such staff.

For example, there are only two trained biologists working in the Ministry of Forestry to look after the country's 87 nature reserves and similar shortages are found at provincial and district level.

Shortage of trained manpower was identified as one of the most critical constraints in managing the country's important biological resources and training was therefore made the main component of the Viet Nam GEF project. Some US\$2.7 million will be spent on training conservation staff under this project, with the great emphasis on guard training and reserve manager training at field training centres at Cuc Phuong, Bach Ma and Nam Bai Cat Tien national parks in the north, centre and south of the country respectively. The project will also strengthen the conservation components of standard forestry training for all new forestry trainees and provide overseas training scholarships for a small number of managers to receive higher training overseas.

In fact Viet Nam has quite good facilities to do almost all needed training in-country in its numerous universities and scientific institutes.

Health and Education

Viet Nam enjoys relatively high standards of education, with some 500,000 teachers in 1988. Primary school participation is close to 100% and the 1992 literacy rate is estimated at 88%. There are numerous centres of higher education throughout the country and universities in Hanoi and Ho Chi Minh.

Standards of health are rather poor. Infant mortality and malnourishment are high. Levels of immunisation

are low so that diseases such as diphtheria, scarlet fever, tuberculosis, and malaria are common. The numbers of hospitals, clinics and general standards of medical treatment are very poor.

A more complicated health problem is the high level of birth defects, cancers and spontaneous abortions. It is claimed many of these latter problems are a by-product of the stresses of the long war, including exposure to dioxin from the agent orange defoliant sprayed over much of the southern half of the country.

Environmental Impact Assessment (EIA) Policy

The Law of Environment was signed in December 1993, and provides the basis for the ordering of Environmental Impact Assessments.

In theory, all major developments will be required to undertake an EIA and demonstrate that the development will not be deleterious to the environment or that any such damage can be mitigated.

Initially all foreign joint ventures, secondarily all major government projects, and eventually all major developments, will be subjected to such regulations. The Ministry of Science Technology and Environment are refining industrial standards that must be met both in the EIA stage and in eventual implementation stage of development.

is Vietnam's seventh largest investor, with some US\$1 billion invested, mostly in industrial and information technology projects in Hanoi and HCMC. Overall some \$20 b. is invested in Vietnam. (The Star/Kuala Lumpur, Aug. 29, FBIS-EAS 96-69).

* Japan will extend a 1.99 million yen grant to Vietnam for a project to improve primary school facilities in Vietnam, the Japan Foreign Ministry announced Wednesday (Sept. 4). The money will be used to repair and build 45 elementary schools along the central coast and furnish them with educational equipment. (Kyodo Sept. 4).

* Royal Cambodian Army Chief of General Staff Ke Kimyan arrived in Vietnam Aug. 21 for a one week visit, meeting with Vietnam's Defense Minister and other officials. His visit came at a time when the Khmer Rouge appear to be disintegrating with the defection of Ieng Sary and other high officials. (Cambodia Times, Aug. 26-Sept. 1, FBIS-EAS 96-175).

* As Vietnam and Cambodia develop their tourist industry along the lines of Thailand, they become more vulnerable to the world's child sex trade, said Ron O'Grady, head of lobby group End Child Prostitution in Asian Tourism (ECPAT), at a Stockholm conference (Aug. 30). Southeast Asia remains the worst affected region in the world by this problem. The conference of the World Congress Against Commercial Sexual Exploitation of Children attracted over 1,000 delegates to Stockholm from 130 countries. Save the Children said it will monitor pedophiles' use of the Internet and is encouraging internet users to pass information to the police. (Reuters, Aug. 30).

* Many foreigners have been using phony \$100 traveler's cheques in Ho Chi Minh City and Thua Thien-Hue province, say Vietnam security officials. Nhan Dan (Aug. 29) says the counterfeiters would check into hotels with phony passports so they could launder the money into Vietnamese dong. (FBIS-EAS 96-173).

* SRV National Assembly Chairman Nong Duc Manh visited Thailand Sept. 3-7 to meet with his counterparts and high officials there and discuss bilateral relations. Chief issue discussed was the continuing territorial dispute over fisheries and the detention of 76 Thai fishermen in Vietnam. (Radio Bangkok Sept. 4, FBIS-EAS 96-172).

* Continued good relations between Russia and Vietnam was pledged during a celebration of Vietnam's 51st National Day at the Vietnamese embassy in Moscow, Sept. 2. Russia's Energy Minister Petr Rodionov said the Vietnamese should be profoundly grateful to Russian specialists who helped Vietnam on several projects, thereby insuring "Vietnam's energy independence." (Itar-Tass Sept. 3, FBIS-SOV 96-172).

* ASEAN's first forum on Internet agreed Wednesday (Sept. 4) to regulate Internet and block off sites that offend "Asian values." ASEAN sources said it would be difficult to develop a uniform policy on internet censorship, but participants at the forum agreed to exchange more information among their nations regarding pages which each country blacklists. They also agreed to improve an ASEAN webpage, launched last year by the ASEAN secretariat based in Jakarta. (Kyodo, Reuters Sept. 4).

* Vietnam does not yet have direct access to Internet, but some officials have said controlled access is possible by the end of the year, according to Kristin Huckshorn of the San Jose Mercury News (Sept. 2). Huckshorn reports on the country's first cybercafe, located in Ho Chi Minh City, where customers may send and receive e-mail or indulge in games such as solitaire and minesweep. Cafe Tam Tam has become a hit, says Huckshorn, used primarily by foreigners, but also Vietnamese residents. The cafe was launched by Huynh Minh, 26, a returnee from Hong Kong, and his American partner Tom Rapp, a restaurant owner, with a \$40,000 investment. It involves four PC's, one with a CD-ROM drive, and an HP printer, and is visited daily by about 100 customers. Customers may send e-mail abroad for \$1/page, \$.20/page to receive it. The cafe is located downtown at 87 Tran Quang Khai, HCMC.

* Sales of Compaq computers in Vietnam jumped by 60% last year, says Paul Blinkhorn, the company's commercial business director for the Asia Pacific region. The company holds a market leading 20% share of Vietnam's PC market. Its main customers are state owned businesses and government ministries. Overall the number of computers in Vietnam has grown rapidly, from 150,000 at the end of 1995 to a projected 275,000 by the end of this year. (Dow Jones News Sept. 5).

* A Hong Kong prison official acknowledged using Vietnamese criminal gang members to control other Vietnamese boat people in the detention centers, reports Lucia Palpal-latoc of the Hong Kong Standard (Sept. 9, FBIS-EAS 96-175). The unnamed Correctional Service Dept. (CSD) officer told Palpal-latoc that camp guards have put gang leaders in direct control of the lives of the boat people, intimidating those who do not follow the rules. Guards have given the gang leaders extra benefits and allowed them to extort the camp residents. The May 10 riot in which 26 buildings and 53 vehicles were burned was instigated by a gang leader and former Viet Cong officer said the CSD official. He said prison guards used the wrong strategy in controlling the prisoners: "We should have helped the guys who really needed our help -- the handicapped, the mentally retarded and the elderly. But we had put our resources particularly with the gang leaders." Hong Kong authorities have long denied allegations of using gang members to control the Vietnamese.

* Hong Kong camp managers are hoping for a surge in "voluntary" repatriation of Vietnamese as Tai A Chau detention center is closed. Some 5,000 residents of the center are being transferred to Whitehead Detention Center, the next step toward forced repatriation. A Hong Kong official said only 3,661 people have returned under the voluntary repatriation program from Tai A Chau over the last five years, a figure he considers "disappointing." (Hong Kong Standard Sept. 8, FBIS-EAS 96-175).

* The South China Morning Post reports Sept. 11: "Some 218 Vietnamese boat people were forcibly repatriated on two flights after Monday's operation was canceled because of Typhoon Sally. More than 30 Vietnamese had to be armlocked or carried on to the planes during the 6-and-1/2- hour operation." (FBIS-EAS 96-177).

* Boat People SOS Committee is protesting the forced repatriation of Vietnamese boat people from Southeast Asia, and urging the U.S. congress to investigate the UNHCR's involvement. (BPSOS, Sept. 4).

* The Vietnamese-American community has raised \$1.3 million to help the stranded boat people in Philippines, according to Thoi Bao newspaper (San Jose). A fund raising concert in Orange County, California netted \$230,000, while 15,000 people who participated in a San Jose, California walkathon raised another

\$350,000. The money will be used to establish a Vietnamese village in Palawan Island camp, and help the Vietnamese become permanent residents if they wish to do so. Philippines Catholic Bishop Ramon Arguelles recently completed a two week visit to the U.S. to help raise funds. (source: news sent by Philip Phu Bui, Aug. 31).

* FBIS East Asia Daily Report ceased publication in paper format on Sept. 2. All other FBIS daily reports will also cease this year in paper form. Processing of agricultural produces industry has not develop yet. limited scale, primitive equipments and backward technology, most of products are consumed in domestic as not high quality to meet the demand of international market.

As to lack of Investment Capital, high quality and productivity plants, advanced technical and fruits, vegetables and foodstuffs technology to process, consumption market is not settle therefore the province has not expand high quality fruits, vegetables and foodstuff manufacture to meet the need of the market and export.

In general agricultural produces, foodstuffs processing of Hungyen is limited, out of proportioned to resources potential and labour force at the present condition. The Province defines clearly this is a field which need take advantage of source of investment capitals in and out country, one of the main way speed up to develop eco-social of the province. The above mentioned parties agree to sign this contract of joint venture with the following counts and conditions:

Count 1: Joint Venture objectives

The joint venture objectives are to establish an outdoor entertainment and sport complex, which serves the public with the following equipment:

1. Grand Roue
2. Grand Huit
3. Merry Go round
4. Matter Horn

The above equipment has all been used with quality of more than 80%. The foreign partner guarantees that the quality confirmation for these game machines shall be made by international quality examination such as Bureau Veritas or SGS....

Count 2: Location

The location will be in the precinct of Ky Hoa's Park, #10A Le Hong Phong Street.

Count 3: Capital Contribution Responsibility

This indicates the responsibilities of each party in the capital contribution:

1. KY HOA Tourism and Commercial Co. contributes the right of using land; value accounts for 30% of the total joint venture's capital.
2. Les Grandes Attractions Modernes contributes to the following articles, which accounts for 70% of the total Joint Venture's capital.
 - Equipment value (as stated in count 1) : 1,500,000 USD.
 - Cost of foundation construction.
 - Cost of equipment transportation and installation.

Les Grandes Attractions Modernes' contribution value may vary during the cooperation period if the game models are no longer attractive to customers. The foreign partner will change new equipment or invest more games to expand the game models so that they are always up-to-date. Whenever there are any addition or modification of game models, the two parties should negotiate in advance and report to the Investment License Authority for examination and ratification.

In the case, Ky Hoa wished to develop new game on other free spaces of land, the foreign partner has the priority to join the project; if the foreign partner refuses to join Ky Hoa reserves the right to call for other partner.

During contract period, both parties agree to delegate Ky Hoa to get license to take out dated equipment from Ky Hoa to operate in other location with the permission of the Investment License Authority. The expenses shall be counted into operational expenses.

In the case, one party is unable to fulfil the duties as agreed upon, that party shall have to notify the other party officially the reasons and solutions 30 days prior. Actual and proper loss due to the delay or inability of fulfilling the duties of one party shall be compensated. Both parties shall negotiate the compensation cost. If both parties can not settle the problem, the judge department or referee specified at count 10 will make decision.

Count 4: Other responsibilities

4.1. Ky Hoa:

Other from capital contribution, Vietnam party has the following responsibilities:

- Personnel: Help recruit Vietnamese employees with highly trained skill.
- Foreign Exchange: Help the foreign party liaise with the appropriate Authority. The foreign party shall be allowed to use all ways in accordance to Vietnam Laws to balance the foreign exchange. The foreign party shall be allowed to transfer the shared profit in foreign currency to foreign countries as well as all stock holder's equity when the joint venture terminates its operation.
- Security outside the game model complex.
- Supply electricity and water for the complex.
- Record of revenue and draw balance sheet for shared dividends and retained earnings as in count 3.
- Recruit fares collectors and pay salary for these collectors during the contract period.
- Ky Hoa is responsible for appointing an accountant for the project. Salary of this accountant is counted into the total cost of the project.
- Supporting party B to import game equipment from overseas, all expenses are of side B's account.
- Represent both parties to propose the appropriate authorities for exemption or reduction from tax during the first two operational years.

4.2. Foreign partner's responsibilities:

- Marketing: Help Ky Hoa manage the services in the operational areas, introduce foreign tourists to visit the entertainment center.
- Personnel: Help the joint venture recruit and train managers, marketing personnel, accountants, and technicians.
- Foreign partner shall be responsible for managing the technology problems and training Vietnamese employees.
- Maintain constant and regular operation of equipment and games.
- Reconstruct and complete and operate the game complex according to the technical design with the agreement of side A. Completion for the whole complex shall be no later than 08/24/1998.
- Follow all operation regulation fixed by Vietnam party.
- Be responsible for all reparation if damaged and all the repair costs are at side B's account.
- Hire technicians to operate in game complex (List of employees should be approved by side A). Salary or other benefit for those employees will be at side B's expenses.
- Pay for import expenses (including transportation,...).

Count 5: Supervising mechanism

During contract period, both sides agree upon the following supervising mechanism:

- Ky Hoa shall be responsible for appointing accountant to record the project, this personnel's salary is counted into the total cost.

- Every Monday, both sides shall crosscheck the revenue to draw the balance for shared dividends. On the 25th of February, two sides shall draw the official balance sheet base on the month's revenue and the generated costs; base on the rate of shared dividends in count 3 to divide the profit.

Count 6: Contract duration

The contract duration is 05 years from the issuing date of investment license. Any change on the duration of the contract should be agreed by both side and reported to the investment license authority for ratification.

If one side wished to extend the contract duration longer than the agreed duration, that side shall have to notify its partner at least 60 months prior to the expiration date of the contract. If both sides agree to extend the contract relation, they have to submit the form to the investment license authority.

Count 8: Tax

1. Foreign partner fulfils tax paying and any financial responsibility according to the investment license. Profit taxes and transferred profit taxes are paid directly to Vietnamese government.
2. Ky Hoa partner fulfils tax paying and any financial responsibilities according to Law for Vietnamese enterprise and investment license. Ky Hoa partner also shall represent the joint venture to pay income tax for both sides.

Count 9: Cost and income distribution

Both sides agree these items are count to operational expense :

1. Electricity and water expense for the game complex.
2. Salaries for employees (to be decided by both sides)
 - Accountant for the project appointed by Ky Hoa side.

- Technical supervisor appointed by foreign side.
- Cashier and game operator.

3. Advertising expense.
4. Maintenance expense.
5. Ticket printing expense.
6. Both sides should agree other expenses.

Calculation for net profit:

Profit dividend = Revenue (from ticket selling) - Income tax - Net expenses

After fulfilling all financial duties to Vietnamese Government and setting up required reserve and other reserves, the remaining profit of both sides is divided according to count 3:

Ky Hoa side	: 30%
Les Grandes Attractions Modernes	: 70%

Profit tax of each side is paid according to count 8. Operation mechanism as well as scale and using regulation on reserves is divided by both sides in accordance to the laws' of the Republic Socialist of Vietnam.

Count 10: Dispute Solving

In case of any dispute between related sides during the contract implement, first both sides should try to arrange on the basis of negotiation and compromise. If within 60 days from the 1st negotiation date, the dispute still can not be solved, both sides may submit the case to the International Economic Referee Center of Vietnam. The decision of the International Economic Referee Center of Vietnam shall be final and both sides are bound to carry that decision.

Count 11: Expiration

The contract terminates its operation before expiration and/or ands in the following cases:

1. The contract duration as in the investment license is expired.
2. As proposed by one or both sides and approved by government authority. When the joint venture can not continue operation due to severe loss but as to operate no less than 6 months, or one side violates the contract counts leading to severe economic loss and approved by planning and investment Bureau. In that case, foreign partner shall be allowed to re-export their equipment according to investment law.
3. Bankruptcy.
4. Unavoidable cases such as: natural calamity, war...that terminates the investment activities and those inevitabilities are the real cause. Both sides have tried to use every method to subdue the consequences but failed. In those cases, the depleted side should predict the consequences and inform the other side immediately about those incidents and send a report of methods and details of the incidents, conformed by local authority within 20 days.

Besides, both sides immediately report to the Bureau of Manning and Investment about all the applied methods (though failed).

Count 12: Liquidation

When the contract expires, both sides agree upon the liquidation of assets related to benefits and duties of both sides in the joint venture as following:

- All assets as game equipment of foreign side shall be shifted back to foreign side.
- Fixed assets such as buildings and foundation shall retain for Ky Hoa side.

Count 13:

Both sides shall carry out all other related counts that are specifically stated in this contract in accordance to Vietnamese law and investment license.

Count 14:

This contract can be modified, extended after agreement in writing by both sides and has to be ratified by investment license authority

Count 15:

This contract is valid from the date of issuing license.

Count 16:

This contract is signed on May 3rd, 1998 in Ho Chi Minh City including 4 original copies in Vietnamese and French. Both Vietnamese and French copies have the same legal value.
