Thank you for interest in our POW/MIAs. Your voice can help force our government to implement as national policy what most Americans believe is an American principle: America will never leave Americans behind after a battle, abandoning them for political expediency!

Together we can let the politicians and career diplomats know that the American people are outraged at the betrayal of America's POW/MIAs. This means writing, faxing, and calling your representative, your two senators, and the President - not once, but often(weekly, bi-weekly, monthly).

It is said that knowledge is power. Find out as much as you can about the way Washington has systemically mishandled any and all information indicating LIVE POWs are still in Vietnamese hands. Then you can speak to the policymakers with authority. Visit the National Archives and see the documentation for yourself. If that isn't possible, read about the evidence in *The Men We Left Behind* by Mark Sauter and James Sanders. This book by two men who have examined the documentation in the Archives, and other excellent sources, are listed on the enclosed order blank.

Letters to the editors of your local papers can help. The media has a sad history of taking the government policy "line" at face value. When a bureaucrat responds to a media question about a surfaced intelligence report, document, or photo, the bureaucrat casts doubt on the credibility of the source; the media then states that the information is "not valid, according to the U.S. Government." For example, the document located in the Soviet Archives earlier this year, although discredited by the Pentagon, confirms the information provided by three Vietnamese defectors in the 60's and 70's about the policy of the Hanoi government to return some of the POWs in 1973 and hold 600 to 800 more for future bargaining purposes. We didn't hear that from the news media when the document surfaced; we only heard that the U.S. Government "doubted the veracity" of the document.

The most important thing you can do is PRAY. Ask God to give a special measure of His grace to our POWs and to perform a miracle that will bring them home to freedom.
