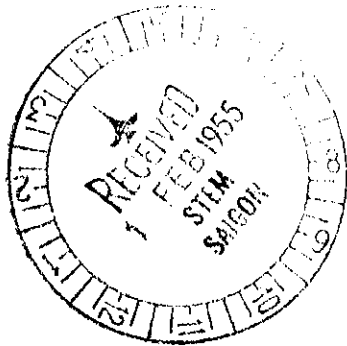

The IRC has discussed with FOA/W a project for the support of the Popular Polytechnical School in Saigon. FOA/W concurs in the Mission's support for this project so far as described by Dr. Samuel Adams, e.g. advances already made and the 300,000 plasters programmed in FY 1955. However, the IRC has not yet presented FOA with a sufficiently firm proposal outlining specific activities and financial requirements of the project and the longer-range aids FOA might be requested to provide under a contract with IRC to support the Polytechnical School. The IRC expects to present a more detailed proposal to FOA/W which will be reported to USOM.
