To Whom May Come These Presents:

GREETINGS AND BEWARE WHEREAS, The good ship USS LIPAN (ATF-85)

bound for American Samoa is about to enter our domain, and the aforesaid ship carries a large and slimy cargo of land-lubbers, beach-combers, cargo-rats, sea-lawyers, lounge-lizards, parlor dunnigans, plow-deserters, park-bench warmers, chicken-chasers, hay-tossers, sand-crabs, four-flushers, cross-word puzzle bugs and all other living creatures of the land, and last but not least, hē-vamps, liberty-hounds and Drug Store cow-boys falsely masquerading as seamen and man-o'-warermen of which you are a member, having never appeared before us; and
