3. SSG Leroy Manns connects cable from one APC to another in an attempt to remove the mired vehicle from the mud.

Explanatory notes for DASPO still captions. See sample caption, for correct information format.

NOTE 1: SECURITY CLASSIFICATION: In upper case letters list either security classification or the word "UNCLASSIFIED". If classified, list in SPECIAL INSTRUCTIONS (Note 12) name, rank and organization of classifying authority. Also list regarding instructions. Each officer and/or enlisted man will be fully aware of AR 380-5 regarding grouping.

NOTE 2: Number all pages of captions. Include on each page, total page count.

NOTE 3: Name and rank of photographer(s).

NOTE 4: SUBJECT: Detailed title of filming project.

NOTE 5: DATE: List inclusive dates of photography.

NOTE 6: FILM: List total rolls of each type film exposed. Total exposures also required.

NOTE 7: CAMERA: List name and serial number of camera(s) used.

NOTE 8: PROJECT: List DCS number and SPX or APC numbers, if applicable.

NOTE 9: REVIEWED BY: List name of Team OIC or NCOIC who reviewed the finished captions. Reviewers initials are required.

NOTE 10: Not for public release statement will be typed in uppercase letters or rubber stamped on the first page of all captions.

NOTE 11: RUBBER STAMP OR TYPE IN UPPER CASE LETTERS EITHER: "FILMING COMPLETE" or "MORE TO FOLLOW".

NOTE 12: SPECIAL INSTRUCTIONS: The following information should be provided under this heading when appropriate: "SPECIAL PROCESSING INSTRUCTIONS" (See also LOI 3-68); list other photographers and/or DCS numbers pertaining to the same subject; and list classification instructions, (See Note 1).

NOTE 13: COVERAGE OBJECTIVE: See LOI 6-68.

NOTE 14: SUMMARY: Complete detailed description of the project. See LOI 5-69
for good example.

NOTE 15: MASTER CAPTION: Summary to be provided for each individual roll of
still film, if different from preceding roll.

NOTE 16: Frame by frame description of each roll of film. Identify whenever
possible, all personnel in photos to include name, rank, unit and home
town.
