

THE PRESIDENT OF THE REPUBLIC OF VIETNAM,

Considering the Constitution of April 1, 1967,

Considering Decree No. 234/TT/SL of May 25, 1968 and subsequent texts fixing the composition of the Government,

In view of the needs of the Nation,

DECREES THE FOLLOWING:

- Art. 1 The composition of the present Government, under the leadership of Prime Minister Tran van Huong, is hereby reformed.
- Art. 2 General Tran Thien Khiem is designated as Prime Minister.
- Art. 3 Pending the formation of the Government, the Prime Minister and all members of the current Government are charged with expediting current affairs.

DECREES:

Art. 1 - Decree No. 023-TT/SL, November 1967, is hereby abrogated and the Office of the President is fixed as follows:

- A. Advisory Group:
 - Advisors
- B. Particular components:
 - Chief of Civil Cabinet
 - Chief of Military Cabinet
 - Secretary
 - Press Officer
 - Director of Protocol
- C. Components in charge of various fields of the State:

Special Assistants for:

- National planning
- Military and Security
- Political and Cultural Research
- Liaison with Constitutional Bodies
- Economy Finance
- External Affairs
- Law
- Liaison with Civic and Political Groups

D. Administrative Components:

- Administrator General

E. Dependent Agencies:

- Central Intelligence organization
- Directorate General of Budget and Foreign Aid
- Directorate General of Planning

Item I - Advisory Group

Art. 2 - Advisory Group consists of a number of advisors equivalent to Minister of State.

Item II - Authorities belonging to particular components:

Art. 3 - The Office of the President is directed by a Chief of Cabinet equivalent to the Director of Cabinet at the Prime Ministry. It consists of:

- 1. Operation Bureau.
- 2. Mail Bureau.
- 3. Bureau of Records.
- 4. A number of Attache Officers directed by a Principal Attache who is equivalent to Chief of Service. The Attache Officers are equivalent to Chiefs of Bureaus.
- 5. Guard group is directed by a Group chief equivalent to the Director of various services.
- 6. Service of Internal Services is directed by a Chief of Service assisted by an Assistant equivalent to a Chief of Service at a Ministry. It consists of:
 - Building Bureau
 - Reception Bureau
 - Supply Bureau

- Art. 4 The Military Cabinet of the Presidency is directed by a Chief of Military Cabinet ("General" rank) equivalent to the Director of Cabinet at the Prime Ministry, who is assisted by an Assistant equivalent to the Deputy Director of Cabinet at the Prime Ministry. It consists of 3 groups:
- Protection and Support Group
- Operation Group
- Military Affairs Group

The Chief of each group is an officer of "Major" rank, who is equivalent to a Director of various Services.

- 1) The Protection and Support Group consists of 2 services:
 - Service of Protection directed by a Chief of Service comprises 2 bureaus:
 - Bureau of Installation Security
 - Bureau of Special Investigation
 - Service of Support directed by a Chief of Service comprises 3 bureaus:
 - Personnel Bureau
 - Supply Bureau
- Mail Bureau

- 2) The Operation Group consists of 2 Services:
 - Service of Military Ceremony and Movement directed by a Chief of Service consists of 2 bureaus;
 - Bureau of Military Ceremony
 - Bureau of Movement

- Service of Transmission directed by a Chief of Service consists of 4 bureaus:
 - Bureau of Technique
 - Bureau of Operation
 - Bureau of Code
 - Bureau of Transmission Supply
- 3) The Military Affairs Group consists of 2 services:
 - Service of Situation directed by a Chief of Service comprises 3 bureaus:
 - Bureau of Situation
 - Bureau of Pacification and Development
 - Bureau of Statistics
 - Service of documentation and Liaison directed by a Chief of Service consists of 2 bureaus;
 - Bureau of Documentation
 - Bureau of Liaison
- Art. 5 The Secretariat is directed by a Secretary equivalent to the Director of Cabinet at the Prime Minister's Office.
- Art. 6 The Directorate of Press is directed by a Press Officer equivalent to the Director of Cabinet at the Prime Ministry, who is assisted by an Assistant equivalent to a Director of a small number of services. It consists of 2 Services:
- 1) Service of Information and Press directed by a Chief of Service consists of 3 bureaus:

- Bureau of Teleprinter
- Bureau of Foreign Language Press
- Bureau of Local Press
- 2) Service of Technique directed by a Chief of Service consists of 3 bureaus:
 - Bureau of Technique
 - Bureau of Editing
 - Bureau of Liaison
- Art. 7 The Directorate of Protocol is directed by a Director equivalent to the Director of Cabinet at the Prime Ministry. It consists of 2 Services:
- Service of Protocol directed by a Chief of Service consists of 2 bureaus;
 - Bureau of Diplomatic Protocol
 - Bureau of Domestic Protocol
- Service of Relations is directed by a Chief of Service assisted by 2 assistants in charge of relationship. The latter are equivalent to Chief of Bureau.
- Item III Authorities belonging to components in charge of various fields of the State:
- Art. 8 Special Assistants are equivalent to Minister, Secretary of State or Under Secretary of State.

According to the responsible field, each Special Assistant may have one or more specialist and clerical section directed by a Section Chief equivalent to a Chief of Bureau.

Item IV - Authorities belonging to the Administrative Components:

- Art. 9 These authorities are directed by an Administrator General equivalent to the Director of Cabinet at the Prime Ministry, who is assisted by a Deputy Administrator General equivalent to the Deputy Director of Cabinet at the Prime Ministry. They consist of:
- Bureau of Operation
- Directorate of Administration
- Directorate of Personnel and Accounting
- Dispensary
- 1) The Bureau of Operation is placed under the direct supervision of the Administrator General
- 2) The Directorate of Administration directed by a Director consists of 3 Services:
 - a. Service of Administration directed by a Chief of Service consists of 3 bureaus;
 - Bureau of Decoration (medals)
 - Bureau of General Administration
 - Main Secretariat
 - b. Service of Legislation directed by a Chief of Service consists of 3 bureaus:
 - Bureau of Legislation
 - Bureau of Central Administration Research
 - Bureau of Local Administration Research
- 3) The Directorate of Personnel and Accounting is directed by a Director who is assisted by a Deputy Director. It consists of 3 Services:

- a. Service of Personnel and Payroll directed by a Chief of Service consists of 2 bureaus:
 - Bureau of Personnel
 - Bureau of Payroll
- b. Service of Budget and Accounting directed by a Chief of Service consists of 3 bureaus:
 - Bureau of Budget
 - Bureau of Accounting
 - Bureau of Accounting Management of Imprest Fund directed by an Accounting Manager
- c. Service of Materials and Vehicles directed by a Chief of Service consists of 4 bureaus:
 - Bureau of Materials
 - Bureau of Supplies
 - Bureau of Public Building
 - Bureau of Vehicle. Dependent to this bureau is a Maintenance Shop which is directed by a Chief equivalent to a Chief of Bureau.
- 4) The Dispensary is directed by a Medical Doctor Chief equivalent to a Chief of Service, who is assisted by a Physician Assistant equivalent to a Chief of Service at a Ministry. It consists of 1 bureau and 2 rooms:
 - Bureau of Dispensary Management
 - General Medicine Room directed by a Physician
 - Dental Room directed by a surgeon dentist.

Art. 10 - The operations and duties of the above installations will be fixed by an instruction governing their operations.

Art. 11 - Besides the above-mentioned positions, the Office of the President has a further number of Experts, Charges de Mission and Generalists, who are assigned to various authorities as the exigencies may require.

Each authority has a Personnel Progression Table. The appointment and replacement of personnel are based on the approved progression table.

Art. 12 - Advisors, Special Assistants, Chief of Civil Cabinet, Chief of Military Cabinet, Secretary, Press Officer, Director of Protocol, and General Administrator at the Presidency are charged, each as to that which concerns him, with the execution of this decree.

This Decree that comes into effect from October 1, 1969, will be published in the Official Gazette of the Republic of Vietnam.

INSTRUCTION FIXING THE ADMINISTRATION OF AUTHORITIES BELONGING TO THE OFFICE OF THE PRESIDENT

Art. 1 - The purpose of this instruction is to separate functions and fix the administration of authorities belonging to the office of the President, which have been organized by Decree No. 497-a-TT/SL, September 26, 1969.

Art. 2 - Composition of advisors:

Entrusted by the President, advisors are in charge of particular matters related to the determination of national policy and planning.

Art. 3 - Special components:

1. Chief of Cabinet: 75

Chief of Cabinet is in charge of the following important matters:

- To coordinate and harmonize the activities of attache officers, body guards, internal services,
- Secret and particular services of the President,
- Audiences, tours, receptions,
- Outgoing and incoming mails,
- Distribution of mails to authorities belonging to the Presidency,

- To keep and store records,
- To sign and disseminate the minutes of proceedings of ministerial meetings,
- Social problems,
- Internal services rendered to the President,
- To transmit directives of the President to the agencies,
- To organize conferences under the chairmanship of the President at the Presidency,
- To submit to the President mails and reporting slips for signature,
- To sign the copies of secret documents and others, when ordered,
- To coordinate the activities of other authorities in the Presidency,
- To file 1 copy of any document sent out from the authorities belonging to the Presidency,
- To file secret documents of the President,
- To assume security for the President and his family,
- To perform particular duties entrusted by the government.

2. Chief of military cabinet:

Military cabinet is a staff directed by a Chief of Cabinet whose duties are:

- a. To follow up, update and report all matters related to the GVN Armed Forces in the following fields:
 - (1) Development, modernization, organization, training, operations, logistics, strength, manpower, promotion, and political warfare activities
 - (2) Military situation

- (3) Territorial defense planning
- (4) Activities of the Allied expeditionary troops
- b. To defend the Presidential Building
- c. To assume security investigation of the Presidential staff, including civilians
- d. To dispose, combine the internal movement, visit or overseas official mission of the President
- e. To be in charge of military ceremonial rites
- f. To supply necessary transmission media
- g. To contact with military authorities to request military media support for the Presidency
- h. To transmit the President's directives to the Ministry of Defense, the General Staff or other High Level Commands
- Problems related to military planning, organization and development of the GVN Armed Forces, the enemy's situation and the Pacification and Development are submitted to the Special Assistant for Military Affairs and Security prior to submission to the President
- j. To complete the above duties, the Military Cabinet should coordinate with the GVN and Allied military authorities to collect documents on information and situation

3. Secretary: is in charge of the following matters:

- Private mail of the President
- Motions and petitions
- Personnel relations
- To translate and submit important documents to the President
- To read and analyze books and magazines for submitting to the President
- To gather documents for preparing and drawing up the Ministerial Meeting.

4. Press Officer:

As spokeman of the President, the Press Officer has the duty:

- To analyze information and press reports for submitting to the President
- To disseminate information pertaining to the activities of the President
- To keep contact with Press and News Agencies, Radio Broadcasting and Television
- To organize the President's Press Conference and interviews for press and news agencies
- To direct photography, cinematography and tape recording.

5. Director of Protocol:

Has the following duties:

- To prepare programs, arrange etiquette and rank in the ceremonies and receptions held at the Presidency or where the President is present
- To organize the presentation of credentials of leaders of the Diplomatic Corps

- To combine and arrange the program of overseas official missions of the President and the reception of national guests and delegations invited by the President to Vietnam
- To submit to the President the credentials accrediting Vietnamese Overseas Diplomatic Corps Leaders, Consuls General and Consuls for signature.

Art. 4 - Components in charge of various fields of the State

- Special Assistants:

- a. Special Assistants assist the President in:
 - Guiding the line and policy of the State
- b. Each Special Assistant is in charge of particular field and receives instructions directly from the President

Special Assistants will coordinate their activities when the problem is related to various domains in order to have common assessment for submitting to the President

- c. Within the scope of activities, Special
 Assistants have duties to:
 - Study responsible problems
 - Follow up and update the situation
 - Make periodic or extraordinary reports for submitting to the President
 - Prepare messages, instructions, circulars, etc... for submitting to the President

- Contact with the Executive, Legislative bodies and groups in order to gather documents and assess the situation or clarify the line and policy initiated by the President
- Transmit the directions of the President to the agencies concerned.
- d. With regard to the Government, Special Assistants will attend the meetings held by the government staff or by the Central Council, when necessary, for offering opinions or representing the viewpoint of the President
- e. With regard to co-ordination, Special Assistants may offer opinions and contact directly with Secretaries of State, Ministers and friendly foreign agencies. In the coordinative activities, the chairmanship is reserved for the ministerial rank.

Art. 5 - Administrative Components:

1. Administrator General has duty to manage and support all agencies belonging to the Presidency in the scope of Personnel, Budget, Public Building, Materials and vehicles, etc.

a. With regard to Personnel:

- To manage all administrative personnel serving in the Presidency
- To supply all authorities except military cabinet, belonging to the Presidency, and dependent agencies (as DGBFA) with executive personnel

- To coordinate with Special Assistants in the recruitment of specialists as provided for in budget
- To submit to the President for approval all documents on the appointment of managerial position at the Presidency from directorial rank up
- By order of the President, to sign decrees appointing managerial positions at the Presidency from Deputy Director rank down, with the approval of the President

b. With regard to budget:

- To prepare and discharge the Presidential Budget
- To liquidate salaries for personnel administered by Administrator General
- To liquidate allowances for all personnel of the Presidency, if any
- To liquidate expenditures incurred by the Presidency
- Administrator General is nominated payment authorizing officer of the National Budget belonging to the Presidency

c. With regard to house, vehicle and materials:

- To manage and maintain all houses and vehicles belonging to the Presidency
- To distribute houses and vehicles to recipient positions
- To purchase, manage, store and distribute materials and office supplies to the authorities belonging to the Presidency
- To organize the supply of necessary items to all personnel of the Presidency and their families.

2. Administration and handling of civil services:

- By order of the President, to sign decrees pertaining to the definition of duties of authorities located in the Presidency
- To coordinate with the office of the Prime Minister, Central, Local Government agencies to handle routine administrative civil services which are not characteristically determined or instructed
- To represent the President in administratively disputed claims, if any
- To direct and handle civil services of the Directorates and Services under the supervision of the Administrator General
- To submit to the President documents on administration and general legislation
- To sign all certified copies of administrative or legislative enactments approved by the President, except confidential documents pertaining to Civil and Military cabinets
- To sign all routing slips of certified copies of administrative and legislative documents for distribution
- To sign mission orders for officials going abroad, when directed by the President
- To sign way-bills for officials on home TDY, when requested by the head of agency

To distribute government directives on the implementation of the national line and policy within the sphere of Presidency.

Art. 6 - Agencies under the direct jurisdiction of the Presidency:

The duties of these agencies, which are defined by current enactments remain unchanged.

Art. 7 - Considering the separation of functions the Heads of authorities in the Presidency will define the duties of their dependent agencies.

Art. 8 - Advisors, Special Assistants, Chief of Civil Cabinet, Chief of Military Cabinet, Secretary, Press Officer, Director of Protocol, Administrator General at the Presidency are charged, each as to that which concerns him, with the execution of this instruction.

It will be published in the official gazette of the Republic of Vietnam.

THE PRESIDENT OF THE REPUBLIC OF VIETNAM

In view of the Constitution of the Republic of Vietnam, dated April 1, 1967,

In view of Decree No. 394-TT/SL of Sept. 1, 1969 determining the composition of the Government,

In view of Decree No. 497a-TT/SL of Sept. 26, 1969 fixing the organization of the Presidency,

Considering the needs of Service,

DECREES THE FOLLOWING:

Art. 1 - The Directorate General of Planning is hereby placed under the direct jurisdiction of the Presidency and under the direct supervision of the Special Assistant for National Planning at the Presidency.

Art. 2 - The Prime Minister of the Government shall carry out the execution of the present Decree.

- 5. To confirm balance sheets of dependent public enterprises in order to enclose it with the state general accounts as defined by Article 89, Decree Law 019-SLU, September 3, 1966.

DECREE LAW NO. 019/SLU GOVERNING THE FINANCIAL AND ACCOUNTING SYSTEM OF VIETNAM

3rd Part: AUTONOMOUS PUBLIC AGENCIES AND MIXED OWNERSHIP CORPORATIONS

Chapter 25: Autonomous Public Agencies

Art. 86 - Autonomous public agencies are public agencies having administrative, industrial, commercial or financial character, endowed with juridical personality and an autonomous management. They are created by laws and governed by general provisions fixed by the Prime Minister upon proposal of the Minister of Finance and the interested Ministers.

The general provisions mentioned above must provide for rules relative to:

- The form and presentation of the annual budget which constitutes a prefiguration of the balance sheet and the account of the results of exploitation.
- The keeping of a commercial or industrial accounting in conformity with a general accounting plan.
- The drawing up of periodic reports and financial positions.
- The method of reckoning and fixing:
 - Amortizements
 - Allocations to the renovation funds
 - Reserves and other funds
- The raising of loans or to the investment of liquid assets.

 To the audit of accounts conducted on the spot by the Ministry of Finance and the General Office of Control.

For regularization purpose, existing autonomous public agencies are designated by special decrees.

Chapter 26: Mixed Ownership Corporations

Art. 87 - Mixed ownership corporations are any corporation or enterprise amenable to civil law and public credit agencies controlled by the State in which the State is in possession of the whole, the majority or an important block of capital or to which subsidies, loans or advances are granted by the State.

Mixed ownership corporations are subject to control by the State in conformity with general provisions fixed by decree.
