In April 1996 and in April 1993, THE INSIDER publisher an audit of DIA's database in which was outlined an explanation of the DIA (Defense Intelligence Agency) "source reports" which were logged on DIAs database. The data was dated April 30, 1992 - 4287 first hand and hearsay reports of live Americans in S.E. Asia. In August 1981 Gen. Eugene Tighe, prepared "Working Papers", a briefing of the General who would replaced him at DIA. These Working Papers outlined 1204 "source reports" (of which 351 were first hand live sighting reports). Included in "The 1996 Kit of Evidence" which is available for \$25.00, see advertisement, are all of these live sighting reports.

So, people are stepping forward who said the saw (eye witnesses) or heard (hearsay) about live American Prisoners who were never released.

From April 1992 to June 1995 DIA received some 1316, additional reports. DIA is the live sighting tracking agency with a "STONE BEACH" SB-team on the ground in S.E. Asia sneaking around, spying on Vietnam, Laos and Cambodia. SB sends agents to verify, live sighting reports. SB tasks sources to obtain proof and evidence. These "STONE BEACH" teams conduct covert missions with covert action staff (CAS) agents. Most Americans do not know that spying is going on, because it is only discussed in "Closed Sessions" behind locked doors at DIA and in Intelligence Committee rooms at "Closed Hearings".

One of the organizations that is on the ground in Vietnam, Laos and Cambodia is the JTF-FA which has an intelligence director who collects, analysis, reviews and forward "live sightings" to the DPMO in Washington, DC. The JTF-FA obtains live sighting information from individuals in Thailand, Vietnam, Laos and Cambodia who contact JTF-FA detachments and voluntarily provide information by letter or during an interview. A report containing the circumstances of the sighting is produced and sent via message from the field detachments to the JTF-FA headquarters in Hawaii and to the DPMO headquarters in Washington, DC - simultaneously. Reports from Hanoi are faxed to the JTF-FA headquarters and then

forwarded via message to the DPMO, which is headed by General James Wold. The JTF-FA analysis JTF-FA produced live sighting reports and forwards the evaluations to the DPMO for further action. Action on a live sighting reports is the responsibility of the DPMO. The DPMO is the U.S. Government agency responsible for analysis, evaluation and adjudication of all live sighting information.

Thus if I were the governing body that had the oversight responsibility for reviewing and evaluating the successes and failures of the system, set up to look into live sighting reports, I would want to clearly understand the JTF-FA role in this process. I would look at choke points in the system where "the enemy" could easily penetrate the system, intercept our "secure" communications and monitor our secret activity. I would most assuredly look at the faxed reports sent from Hanoi, over open communication lines, as a real security violation and take steps to damage limit source and sighting intelligence from intercept. It has been stated that the Vietnamese seem to know our next move, before we tell them. For that to happen, they have to have a spy in our system or a way to monitor our plans in the field. So, a security analysis is in order. If we look on the Vietnamese computers and find our most secure "source reports" then it is time for a security review of the process & procedures.

When politicians in Washington, DC wage a battle to assure us that all that can be done is being done, they may be doing this or making these statements of reassurance to serve their own interests, inventing an imaginary defense that never materializes. We as researchers of facts about live POWs need to keep a sharp eye on those who use rhetoric or rhetorical statements to assure us that all is well and moving along fine, when the facts do not support this conclusion. The system, set up and in place has failed to produce one single live American, while the system attempts to persuade us that it is not receiving any more or any additional verifiable live sighting reports. The Insider challenges the notion of success in the accounting process, as no successes are being reported on live sighting resolution. Yes, graves are being located and remains are being recovered, but where are the live sighting reports leading to?

Lets, all offer up a little prayer that God will help us all find the words to say that will change the minds of those who hold the facts or access to the facts, held in a closed compartments where no one is allowed to see. Separate eluding from fact. No one is interested in the wrong facts. We are interested in 100% accuracy. Wisdom is the correct use of knowledge-not the incorrect use of facts. If we could only see around the corner! If we could get eye ball to eye ball with the facts, instead of being lead to a safe spot. For the benefit of the sceptic, who believe that all the POWs were released, all POWs died by now, or they want to be there, I challenge you to look at the facts and the evidence.
