STATEMENT

With the United States Armed Forces
on board USS KEARSARGE (CVS-33) in
The South China Sea

At approximately 0800G, 3 June 1969 following the collision of the
USS FRANK E. EVANS and HMAS MELBOURNE, a body was brought to sick bay
aboard the USS KEARSARGE. This body was identified by dog tags and by
comparison of teeth with dental records as that of GLINES, Kenneth *UL, 94*
B64 83 82, SA, USN.

Examination of the body revealed soaking wet clothes which were
removed. The only obvious external injuries were a large abrasion of
the right anterior chest wall and an occipital skull injury. Palpation
of the skull revealed a large hematoma over the occiput with laceration
and bleeding. It felt as if a skull defect were present, but this was
not ascertained by radiography and could have been only a laceration
through the galea aponeurosis. The mouth was filled with a pink foamy
material felt to be pulmonary edema.

A more detailed examination of the remains was not done because the
body was to be flown to Tan San Nhut AFB, RVN, for autopsy.

The conclusion reached by me on the basis of wet clothes and pul-
monary edema was that of death by salt water drowning. The role played
by the head injury would be only speculative.

STATEMENT

With the United States Armed Forces
on board USS KEARSARGE (CVS-33) in
The South China Sea

Approximately 0800 on the morning of 3 June 1969, a stretcher bearing the body of one Kenneth W. GLINES was brought to sick bay. I was told this was the only fatal casualty recovered thus far from the collision of the USS FRANK E. EVANS and HMAS MELBOURNE.

I did not personally examine the body, but did observe the following:

The victim's clothes were soaked with water. His hair was wet and he had a pink-tinged foam in his mouth. When his shirt was removed, the large bruise and abrasion on his left anterior chest appeared to be washed clean.

Assuming that the patient had drowned, I returned to my work caring for injured survivors and had no further contact with the body.
