

3. [REDACTED] INFORMATION. THE FOLLOWING INFORMATION WAS RE-  
LATED BY SOURCE TO INTERVIEWER AS FACT. SOMETIME IN EARLY  
JAN 85, SOURCE AND A FRIEND NAMED VU HONG PHONG, OF THON  
6 HAMLET, TAN THIEN VILLAGE, HAM TAN DISTRICT, THUAN HAI  
PROVINCE, (WHO WAS A FORMER ARVN 2LT), TRAVELLED TO GIO  
LINH TOGETHER WHERE THEY BOUGHT THE REMAINS OF AN AMERICAN  
THE SALE WAS SET UP MAINLY BY PHONG AND SOURCE COULD  
PROVIDE NO SPECIFIC INFORMATION ON HOW THE SALE WAS AC-  
COMPLISHED. SOURCE EXPLAINED THAT GIO LINH IS NEAR  
DONG HA TOWN, BINH TRI THIEN PROVINCE. THERE, THEY  
JOINTLY BOUGHT THE REMAINS FOR TWO TAELS OF GOLD, PHONG  
AND SOURCE PAID ONE TAIL EACH. THE REMAINS INCLUDED A  
DOG TAG WHICH WAS ALLEGED BY THE SELLER TO BE ASSOCIATED  
WITH THE REMAINS. AFTER THE PURCHASE, THEY BROUGHT THE  
REMAINS BACK TO PHONG'S HOUSE WHERE THEY WERE HIDDEN AND  
ARE CURRENTLY HIDDEN. AFTER CONCEALING THE REMAINS,  
SOURCE AND SOURCE TRAVELLED TO HCMC TO SEARCH FOR  
A WAY TO SMUGGLE THE REMAINS OUT OF VIETNAM. AFTER THAT,  
SOURCE WAS ABLE TO ESCAPE FROM VIETNAM WHILE PHONG WAS  
NOT. BECAUSE THEY BECAME SPLIT UP AND COULD NOT ESCAPE  
TOGETHER, SOURCE WAS UNABLE TO BRING THE REMAINS ALONG  
WITH HER. PHONG IS STILL IN VIETNAM. SOURCE RECALLED  
SEEING THE REMAINS DURING THE PURCHASE BUT CLAIMED SHE  
WAS TOO FRIGHTENED TO DESERVE THE REMAINS FOR A LONG  
PERIOD OF TIME AND ONLY GLANCED AT THEM. SHE RECALLED  
THE REMAINS DID INCLUDE A SKULL WHICH HAD SOME TEETH AND  
THAT ALL THE REMAINS MADE A PARCEL OF APPROX SOCCER-  
BALL SIZE.

4. [REDACTED] THE REMAINS WERE SMUGGLED SOUTH BY PHONG PAYING  
A CIVILIAN FRIEND OF HIS TO DRESS LIKE A COMMUNIST  
SOLDIER AND TRANSPORT THE REMAINS IN A PAVN BACKPACK WHILE  
RIDING ON A TRAIN. SOURCE EXPLAINED THAT THE SRV TRAINS  
CONDUCTS ARE NOT AS SEVERELY ENFORCED ON THE TRAINS AS  
THEY ARE FOR MOTORIST TRAVEL. SOURCE COULD RECALL NO IN-  
FORMATION FROM THE DOG TAG. SOURCE COULD PROVIDE NO  
DETAILS CONCERNING THE ORIGIN OF THE REMAINS.

5. [REDACTED] PURSUANT TO THE REQUIREMENTS PROVIDED IN  
REFS A THRU C, SOURCE WAS ASKED ABOUT HER KNOWLEDGE OF  
HUY KEIEM RE-ED CAMP. SOURCE PROVIDED THE FOLLOWING  
INFORMATION AS FACT. SOURCE'S FATHER, NGUYEN THANH QUANG  
WAS FORMERLY AN ARVN CAPTAIN AND WAS THE S-1 STAFF OFFICE
