



1954 AND HAD MANY RELATIVES IN HO NOI. HE IS CURRENTLY RESIDING IN LOC CHAU VILLAGE, BAO LOC DISTRICT, LAM DONG PROVINCE. ACCORDING TO HIM, HE HAS APPLIED TO GO TO THE U.S. UNDER THE H.O. PROGRAM. WHILE WE WERE STILL IN VIETNAM, HE TOLD US THAT HE HAD RECEIVED HIS VISA AND WAS TO LEAVE SOON.

- I AM NOT SURE WHETHER HE HAS SOLD THESE ARTICLES TO THE VIET CONG REGIME YET OR NOT. WHILE WE WERE STILL IN VIETNAM, HE WAS VERY POOR, BUT THEN BUILT A NEW HOME AND IMPROVED HIS STANDARD OF LIVING A GREAT DEAL, BECAUSE HIS WIFE SPECIALIZED IN TRADING IN BRASS ARTICLES AND IVORY AND SEARCHING FOR AMERICAN REMAINS TO SELL FOR GOLD.

- I REQUEST THE U.S. DELEGATION TO FIND MR. K'JOP AND HIS WIFE IF:

- HE HAS SOLD THE ABOVE LISTED ARTICLES TO THE VIET CONG FOR GOLD, BECAUSE THIS GOLD WAS NOT THE RESULT OF HIS OWN WORK, BUT OF ALL OUR TAPOF. BUT HE DEFEATED US AND TOOK THE GOLD HIMSELF.

- HE IS RESETTLED IN THE U.S. UNDER THE H.O. PROGRAM, THE U.S. SHOULD FIND HIM AND RETRIEVE THE ARTICLES BELONGING TO THE AMERICAN PILOT KILLED IN THE AIRCRAFT. HE IS A FRAUD AND WILL ATTEMPT TO FOOL EVEN THE AMERICAN DELEGATION.

- WE TRULY REQUEST THE AMERICAN DELEGATION TO ALLOW US TO CLEAR UP THIS MATTER. -- END QUOTE.

COMMENTS: FIELD COMMENTS - ALTHOUGH NOT DATED, THIS NOTE WAS RECEIVED BY THE U.S. REFUGEE OFFICE IN MANILA ON 24 FEB 92. DUE TO OTHER MISSION REQUIREMENTS AND TRAVEL RESTRICTIONS, RO WAS NOT ABLE TO VISIT THE MORONG REFUGEE CAMP, PATAAN, RP UNTIL AUG 93. BY THIS TIME, SOURCE HAD DEPARTED, SO WAS NOT AVAILABLE FOR INTERVIEW.
