... TALKING POINTS FOR CJTF-FA VISIT TO VIETNAM

... POINTS ARE PROPOSED FOR USE BY BG NEEDHAM DURING HIS VISIT TO CENTRAL VIETNAM.

... DURING A VISIT TO QUANG NAM-DANANG AND THUA THIEN-HUE IN MAY 1992, SPECIAL ASSISTANT MR. BELL DISCUSSED SEVERAL REPORTS FROM LOCAL OFFICIALS. THESE REPORTS INDICATE THAT REMAINS HAVE BEEN RECOVERED FROM CAPTURED PERSONNEL WHO NOW ARE KEEPING THEM IN THEIR HOMES. MR. BELL DISCUSSED WITH LOCAL OFFICIALS TO FORMER CADRE WHO MAY BE ABLE TO PROVIDE INFORMATION ON PERSONNEL CAPTURED, DETAINED, EVACUATED, OR PROVIDED TO THE BAR. MR. BELL EMPHASIZED TO LOCAL OFFICIALS HIS INTEREST IN WORKING WITH NORMAL ITERATION ACTIVITIES.

... QUANG NAM-DANANG: DURING HIS RECENT VISIT HERE MR. BELL RECEIVED REPORTS INDICATING THAT LOCAL RESIDENTS HAVE RECOVERED REMAINS AND TAKEN THEM TO THEIR HOMES. THESE REPORTS INCLUDED REMAINS OF "HOWARD" WHICH WERE REPORTEDLY RECOVERED IN THE AREA OF QUANG BINH AND NOW KEPT AT THE HOME OF A LOCAL VILLAGER. (NOTE: PRESENTLY WITHIN THE BOUNDARY OF THUA THIEN-HUE). (NOTE: THIS IS A REPORT OF SENATORIAL INTEREST). MR. BELL REQUESTED PERMISSION TO INTERVIEW MR. HO NGHINH AND MR. PHAM XUAN THU IN THE PAST. MR. BELL RECEIVED SOME REPORTS FROM PEOPLE WHO HAVE VISITED MR. HO NGHINH. INFORMATION ON CASES 0239 AND 0019 WAS RECEIVED DURING MR. BELL'S VISIT. MR. BELL SHARED THIS INFORMATION WITH THE VNOSMP. WE HAVE MADE CONTACT WITH MR. HO NGHINH AND MR. PHAM XUAN THU IN THE PAST. MR. BELL HAS BEEN IGNORED. I WOULD LIKE TO ASK FOR YOUR ASSISTANCE IN THESE REQUESTS. WE WOULD ALSO LIKE TO INTERVIEW MR. HO NGHINH IN DAI LOC. MR. BINH IS A FORMER MEMBER OF THE PARTY COMMITTEE FOR ENEMY PROSELYTING. WE WOULD LIKE TO INTERVIEW MR. CHAN XUAN, BORN DURING 1943 IN DIEN BAN. MR. CHAN XUAN IS A FORMER MEMBER OF THE PARTY COMMITTEE. YOUR COOPERATION IN RESPONDING TO THESE REQUESTS AS MR. BELL INFORMED YOU DURING HIS VISIT WOULD BE APPRECIATED. MR. BELL REQUESTED NOT TO INTERFERE WITH ALREADY SCHEDULED ITERATIONS. MR. BELL REQUESTED MR. BELL TO WORK WITH YOU DURING A PERIOD OF TIME DURING HIS VISIT.

... DURING HIS RECENT VISIT HERE MR. BELL DISCUSSED SEVERAL REPORTS FROM LOCAL RESIDENTS HAVE RECOVERED REMAINS AND TAKEN THEM TO THEIR HOMES. THESE REPORTS INCLUDED REMAINS FOUND BY VILLAGERS IN THE AREA OF QUANG BINH AND NOW KEPT AT THE HOME OF A LOCAL VILLAGER IN DAI LOC DISTRICT. REMAINS FOUND IN TAN MY
