SUMMARY: (U) THIS IS A STONY BEACH REPORT. IT PROVIDES VERY LIMITED INFORMATION REGARDING POSSIBLE U.S. SERVICE MEMBERS' REMAINS IN VIETNAM.

TEXT: 1. (U) SOURCE CLAIMS ONE OF HIS FRIENDS PURCHASED TWO SETS OF U.S. SERVICE MEMBERS' REMAINS ALONG WITH DOG TAGS AND HID THEM IN HIS OWN HOME. THE REMAINS ARE CLAIMED TO HAVE BEEN DISCOVERED BY THE FRIEND'S RELATIVES IN QUANG TRI PROVINCE, BROUGHT TO HO CHI MINH CITY AND THEN SOLD TO SOURCE'S FRIEND. THE FOLLOWING IS THE NAME AND ADDRESS OF SOURCE'S FRIEND -

LE CANH HUNG

 HO CHI MINH CITY, VIETNAM

2. (U) ADDITIONALLY, SOURCE STATED THAT ON 26 APRIL 1992, JUST PRIOR TO HIS DEPARTURE FROM VIETNAM, HE WAS SHOWN TWO DOG TAGS. SOURCE FELT THAT ONE WAS PROBABLY FAKE BUT THE OTHER MAY HAVE BEEN GENUINE. HE DOES NOT REMEMBER THE NAMES ON THE DOG TAGS AND DID NOT WRITE THE INFORMATION DOWN BECAUSE HE DID NOT INTEND TO REPORT ANY INFORMATION CONCERNING POW'S OR MIA'S. THE FOLLOWING IS THE NAME AND ADDRESS OF THE PERSON WHO SHOWED THE SOURCE THE DOG TAGS -

COMMENTS: (U) (SOURCE COMMENT) - SOURCE STATED HE DID NOT PLAN TO GIVE ANY INFORMATION ON POW/MIA MATTERS BECAUSE HE HAD PREVIOUSLY HAD A BAD EXPERIENCE (NFI) WHEN REPORTING POW/MIA INFORMATION TO THE U.S. GOVERNMENT. HE DID NOT WISH TO EXPOSE HIMSELF AGAIN.
