SUMMARY: (U) THIS IS A STONY BEACH REPORT. IT
 PROVIDES LIMITED INFORMATION CONCERNING TWO SETS OF
 U.S SERVICE MEMBERS' REMAINS, POSSIBLY RELATING TO
 REFNO 1831, HELD IN PHU LOC DISTRICT, THUA THIEN

PROVINCE, VIETNAM.

SOURCE CLAIMS A NEIGHBOR GAVE HIM THE INFORMATION JUST
 PRIOR TO SOURCE'S DEPARTURE FROM VIETNAM. THE
 FOLLOWING IS THE NEIGHBOR'S ADDRESS -

HUYNH DUC ((THAI))
 THO SON HAMLET
 LOC TIEN VILLAGE
 PHU LOC DISTRICT
 THUA THIEN PROVINCE

2. (U) SOURCE CLAIMS THAT MR. THAI SHOWED HIM TWO
 SETS OF REMAINS, WITH DOG TAGS, IN DECEMBER 1991. THE
 REMAINS CAME FROM TWO CRASHED FIGHTER AIRCRAFT LOCATED
 ALONG THE BORDER BETWEEN QUANG NAM PROVINCE, VIETNAM
 AND LAOS. SOURCE DID NOT KNOW THE DATE OR
 CIRCUMSTANCES OF THE INCIDENT.

COMMENTS: 1. (U) (SOURCE COMMENT) - HUYNH DUC THAI
 IS THE SON OF HUYNH THANH (HO35), A FORMER RVN SECRET
 POLICEMAN. HUYNH THANH WANTED THAI TO IMMIGRATE TO
 THE US. BUT SINCE THAI WAS MARRIED, HE WAS NO LONGER
 ELIGIBLE UNDER THE ODP PROGRAM. THAI REQUESTED SOURCE
 PROVIDE ABOVE INFORMATION TO THE APPROPRIATE USG
 AUTHORITIES.

2. (U) (FIELD COMMENT) - ACCORDING TO THE DIA ROSTER
 OF UNACCOUNTED U.S. PERSONNEL, SOUTH EAST ASIA, BOTH
 ((BURNHAM)), MASON I. AND ((AMOS)), THOMAS, ARE BOTH
 UNACCOUNTED FOR U.S. SERVICEMEN (REFNO 1831).
 HOWEVER, SOURCE STATED THAT REMAINS CAME FROM TWO
 SEPARATE ACFT. THIS INFORMATION IS NOT CONSISTENT
 WITH THE REFNO 1831 INCIDENT.
