PROVIDES VERY LIMITED INFORMATION REGARDING POSSIBLE
U.S. SERVICE MEMBERS' REMAINS BEING KEPT IN VIETNAM.

TEXT: 1. (U) SOURCE KNOWS A MAN, CURRENTLY LIVING
IN THE U.S., WHO CLAIMS TO KNOW ANOTHER PERSON IN
VIETNAM WHO POSSESSES A LARGE NUMBER (NFI) OF DOG TAGS
AND SOME FLYING LOG BOOKS (NFI). THIS PERSON, WHOM THE
SOURCE DOES NOT KNOW PERSONALLY, HAS BURIED ALL THE
MATERIAL IN THE FOREST NEAR BIEN HOA CITY, DONG NAI
PROVINCE. SOURCE STATED THIS MAN WANTS TO TRADE THE
MATERIAL FOR IMMIGRATION TO THE U.S. FOR HIM AND HIS
FAMILY. HE DOES NOT WANT MONEY AND WILL TURN IN TWO
ITEMS OF THIS MATERIAL FOR IDENTIFICATION IN ADVANCE
OF BEING AUTHORIZED TO IMMIGRATE.
