 OFFICE, BANGKOK, TH., ON 9 JUNE 1992, IN VIETNAMESE.
 TRANSLATION FROM THE LETTER INCLUDES INFORMATION
 CONCERNING 32 SETS OF U.S. SERVICE MEMBER'S REMAINS-
 CURRENTLY, SOURCE IS THE PRESIDENT OF A VOLUNTARY AND
 HUMANITY ORGANIZATION, WHICH CLAIMS THEY HAVE TURNED
 OVER TO THE VIETNAMESE GOVERNMENT 32 SETS OF U.S.
 SERVICE MEMBER'S REMAINS, WITH AN ADDITIONAL 15 SETS
 LEFT TO TURN OVER. AFTER THE 32 SETS OF REMAINS WERE
 TURNED OVER, SOURCE CLAIMS THAT MEMBERS OF THE GROUP
 WERE THROWN INTO JAIL BY THE VIETNAMESE GOVERNMENT.
