PROVIDES LIMITED INFORMATION CONCERNING HEARSAY
REPORTS ABOUT U.S. SERVICE MEMBERS' MISSING IN
INDOCHINA DURING THE VIETNAM WAR.

TEXT: (C/NF) SOURCE CLAIMS TO HAVE WORKED WITH THE
USG BETWEEN 1973 AND 1975 IN GATHERING INFORMATION
REGARDING U.S. SERVICE MEMBERS' REMAINS. HE RELAYED

THE FOLLOWING INFORMATION AND REQUESTED CONTACT WITH
THE APPROPRIATE AUTHORITIES -

A. (C/NF) IN 1977 WHILE IN A REEDUCATION CAMP IN YEN
BAY, SOURCE WAS TOLD A BLACK AMERICAN WAS SEEN IN THE
AREA.

B. (C/NF) IN 1988 THREE OR FOUR PEOPLE TOLD SOURCE
THEY SAW A CAUCASIAN AMERICAN NAMED ((DEBREY)) AT
REGION 3 BIEN GIOI, KONTUM, PLEIKU.

C. (C/NF) IN 1990, THERE WERE ABOUT 100 AMERICANS
STILL BEING HELD AT DUyen HAI DISTRICT AREA, BETWEEN
GO CONG AND VUNG TAU, GUARDED BY VIETNAMESE. THIS
INFORMATION HAS FROM A MONK WHO IS A GOOD FRIEND OF
SOURCE.

D. (C/NF) IN 1991, A CAMBODIAN LIEUTENANT, WHEN HE
WAS ON A MISSION IN VIETNAM, TOLD SOMEONE ELSE HE
KNOWS OF AN AMERICAN STILL LIVING IN CAMBODIA. THE
PERSON WITH THE INFORMATION IS NGUYEN VAN ((HUU)), SON
OF ER. (NGUYEN)) HUU GIA, WHO IS WORKING AT HONG BANG
HOSPITAL IN HO CHI MINH CITY.

E. (C/NF) IN 1991, SOURCE WAS TOLD THERE WERE SEVEN
AMERICANS IN DANANG, NEAR THE BORDER OF LAOS AND
VIETNAM.

F. (C/NF) LE VAN ((SAU)). A CLOSE FRIEND OF SOURCE,
IS KEEPING SOME REMAINS AT 175 TRANG LONG, GIA DINH,
HO CHI MINH CITY. CARE SHOULD BE TAKEN WHEN
CONTACTING LE.

G. (U) NGUYEN VAN ((BE)), A PROFESSIONAL DOG
TRAINING SPECIALIST AT THE TAO DAN ATHLETIC FIELD
BEHIND THE PRESIDENTIAL PALACE HAS INFORMATION
CONCERNING 60 SETS OF U.S. SERVICE MEMBERS' REMAINS.

COMMENTS: (U) (FIELD COMMENT) - DEBREY IS NOT LISTED
AS MISSING IN THE UNCLASSIFIED ROSTER OF U.S.
PERSONNEL, SOUTHEAST ASIA. SOURCE WAS PROCESSED
THROUGH SUAN PIU, BANGKOK, PRIOR TO SDR (S-VOP-0E366)
BEING PUBLISHED. IN CLEARING THE BACKLOG OF ODP
