TEXT: (U) IN AN UNSOLICITED LETTER SENT TO THE
 ORDERLY DEPARTURE PROGRAM OFFICE IN BANGKOK, THAILAND,
 SOURCE CLAIMS TO HAVE IN HIS POSSESSION THREE SETS OF
 REMAINS BELONGING TO U.S. SERVICE MEMBERS FROM THE
 VIETNAM WAR. ACCORDING TO THE LETTER, SOURCE WAS TOLD
 THERE WAS A REWARD FOR THE REMAINS OF AMERICAN
 SOLDIERS WHO WERE KILLED IN THE VIETNAM WAR. HE HAS
 WRITTEN TWO OTHER LETTERS DIRECTLY TO THE AMERICAN
 REPRESENTATIVES IN HO CHI MINH CITY BUT NEVER RECEIVED
 A REPLY. HIS MOTIVATION FOR WRITING IS FOR HIM AND
 HIS FAMILY TO BE CONSIDERED FOR IMMIGRATION TO THE
 U.S. HE INCLUDED ALL PERTINENT DOCUMENTS TO
 ACCOMPLISH THIS END. ALSO INCLUDED ARE TWO COLOR
 PHOTOS, AND A BONE CHIP OF ONE OF THE REMAINS WITH THE
 FOLLOWING INFORMATION ASSOCIATED WITH IT -
