ON TUESDAY JUNE 8, 1995, FORMER CONGRESSMAN BILLY HENDON, AGAIN HANDCUFFED HIMSELF TO THE MAIN GATE OF THE JOINT TASK FORCE - FULL ACCOUNTING (JTF-FA) COMPOUND. THIS DRASTIC ACTION WAS A DIRECT RESULT OF JTF-FA'S REFUSAL TO ALLOW MR. HENDON TO LEAD JTF-FA INVESTIGATORS AND LIVE SIGHTING INVESTIGATORS, AND AN EXPERT FROM STONEY BEACH, TO HUNG HOA PRISON UNDERGROUND.

HUNG HOA PRISON, IS THE SITE WHERE MR. HENDON STATES AMERICAN PRISONERS OF WAR ARE HELD TODAY. AN INVESTIGATOR FROM STONEY BEACH WAS FLOWN IN FROM BANGKOK TO REVIEW MR. HENDON'S INFORMATION. YET, NEITHER THE STONEY BEACH INVESTIGATOR NOR ANYONE AT THE JTF-FA COMPOUND IS WILLING TO SPEAK WITH MR. HENDON.

AFTER TEN HOURS HANDCUFFED TO THE GATE, MR. HENDON REMOVED THE CUFFS AT 10:30 P.M. (LOCAL HANOI TIME.) HE DID THIS WHEN IT BECAME APPARENT JTF-FA AND STONEY BEACH INVESTIGATORS, WOULD NOT SPEAK WITH MR. HENDON OR ALLOW HIM TO LEAD THEM TO OUR POWS.

MR. HENDON'S VISA EXPIRES JUNE 8TH 1995 AT 12 MIDNIGHT (LOCAL HANOI TIME.) MR. HENDON REMAINS IN VIETNAM WITHOUT A VISA AND PLANS TO BE BACK AT THE JTF-FA COMPOUND WEDNESDAY MORNING, TO DEMAND THAT JTF-FA AND STONEY BEACH INVESTIGATORS GO DIRECTLY TO THE HUNG HOA PRISON FACILITY.
