I am conserving the rest skeleton of an american pilot with the

The circumstance in which that by chance, My husband
deceased the rest skeleton of that American pilot is described below:
My husband and some of his fellows worked on a hill amongst
dixious mountains in Kontou region in december 1984, suddenly they
deceased a aluminium frame nailed on the hill with grass and ground.
They have digged around it, and by curiosity, they found a destroyed
aluminium cabin of a C130. As they opened the door, there was four
rests of the skeletons sitting at working team within. They were
very happy but very afraid of the severity of the local authorities.
Through, they decided to share themselves the four rests of skeleton found.
My husband owned one rest of skeleton, and the others the three others.
That rest of the American skeleton above consisting totally whole body -
