1. SUMMARY: REF A REPORTED DOG TAG INFORMATION ON ANTHONY C. SHINE AND REF B WAS A REQUEST FOR REINTERVIEW OF MR. SOURCE OF REF A, TO DETERMINE WHERE AND UNDER WHAT CIRCUMSTANCES HIS CONTACT OBTAINED INFORMATION CONCERNING REFNO 1950, CPT ANTHONY C. SHINE.
2. INFORMATION: ON 28 MAY 90, SOURCE WAS ADVISED THAT ANTHONY C. SHINE IS AN UNACCOUNTED FOR INDIVIDUAL, AND THAT IS NOT. SOURCE WAS ALSO INFORMED THAT THE REMAINS HE PROVIDED WERE NOT HUMAN.
3. AS REPORTED IN REF A, PARA 5, SOURCE STILL INSISTS THAT HE IS UNAWARE WHERE THE REMAINS AND DOG TAG INFORMATION WERE ORIGINALLY FOUND. SOURCE ALSO CLAIMS HE HAS NOT SEEN HIS SOURCE SINCE RECEIVING THE INFORMATION IN MAY 89.
4. COMMENT: SOURCE WAS PROVIDED A SELF ADDRESSED/STAMPED ENVELOPE, AND ASKED TO FORWARD ANY FURTHER INFORMATION SHOULD THEY MEET AGAIN.
