
1. IN RESPONSE TO OASD (DASD/POW-MIA) TASKER REF A, JTF-FA J2 COMPILED A LIST OF APPROXIMATELY 140 VIETNAMESE INDIVIDUALS WHOM WE WOULD LIKE TO INTERVIEW. USCINCPAC HAS TASKED US TO REDUCE THE LIST TO THE TOP 50 PRIORITY NAMES. WE THEREFORE NEED YOUR INPUT ASAP TO IDENTIFY THE INDIVIDUALS WE MUST INTERVIEW, IN ORDER OF PRIORITY.

2. THE LIST OF 140 INCLUDED INPUT FROM DET 2 (REF B) AND DET 1 (REF C). MOST OF THE DET 2 INPUT WAS PREVIOUSLY PRESENTED TO THE SRV DURING THE APRIL 93 TECH TALKS. USCINCPAC HAS DETERMINED THAT NEED NOT BE INCLUDED IN THE KERRY LIST. THE DET 1 INPUT FROM MR. BELL INCLUDED APPROXIMATELY 100 NAMES. THESE NAMES WERE NOT PRIORITIZED.

3. BASED ON CLARIFICATION FROM OASD/KERRY, REQUEST THAT DET 2 PERSONNEL CONSULT WITH MR. BELL AND IDENTIFY FROM THE LIST THOSE WHO ARE ABSOLUTELY CRITICAL INDIVIDUALS (I.E. THOSE THAT WOULD HAVE A SIGNIFICANT IMPACT ON OUR EFFORT TO RESOLVE THE POW/MIA ISSUE); MAXIMUM OF 50.

4. WE REQUIRE A RESPONSE AS SOON AS POSSIBLE; YOUR COB 6 MAY.
