AN ADVISOR IN DARLAC PROVINCE. NO U.S. MILITARY PERSONNEL WERE HELD WITH THIS GROUP AND SOURCE MAY BE RELAYING HEARSAY INFORMATION ON MR. STRUHARIK WHO WAS A USAID EMPLOYEE AT BAN ME THUOT, DARLAC PROVINCE.
