TO U.S. CONTROL ON 30 OCTOBER 1975.

3. (U) EVEN THOUGH NOT ALL THE FACTS PROVIDED BY SOURCE ARE
ACCURATE, FOR EXAMPLE, EIGHT PERSONS VICE A TOTAL OF ELEVEN PERSONS,
AND THE PRESENCE OF A "COLONEL" IN THE GROUP, SOURCE'S INFORMATION
CLEARLY CORRELATES TO THE INDIVIDUALS CITED IN PARA 2 ABOVE. SOURCE
MAY BE PROVIDING HEARSAY INFORMATION AS FIRST HAND.
