

3. [REDACTED] INFORMATION: SOURCE STATED THAT WHILE RESID-
ING AT DUONG HOA VILLAGE, HA COI DISTRICT SHE OBSERVED
THE CRASH OF A U.S. JET (MODEL UNKNOWN) AND CAPTURE OF
TWO U.S. PILOTS. SOURCE WAS NOT ABLE TO RECALL THE YEAR
OF THE INCIDENT BUT STATED THAT SHE WAS 14 YOA AT THE TIME.
SOURCE RECALLED THAT THE INCIDENT OCCURRED DURING MID YEAR
(NOT SURE OF MONTH BUT POSSIBLY JUNE) AND SOMETIME DURING
THE MORNING HOURS (NOT SURE OF TIME BUT PRIOR TO NOON).

4. [REDACTED] SOURCE STATED THAT SHE OBSERVED TWO JET AIR-
CRAFT FLYING FROM THE OCEAN IN THE DIRECTION OF LAN SON
(EAST TO WEST). SOURCE RECALLED THAT SHORTLY THEREAFTER
SHE OBSERVED ONE JET AIRCRAFT ON FIRE FLYING FROM IN-
LAND CUT TO SEA (WEST TO EAST). SOURCE WAS NOT SURE IF
THE BURNING AIRCRAFT WAS ONE OF THE SAME AIRCRAFT THAT
SHE OBSERVED EARLIER BUT SPECULATED THAT IT WAS. SOURCE
OBSERVED ONE PILOT BAIL OUT OF THE BURNING AIRCRAFT AND
DESCEND INTO DUONG HOA VILLAGE (YJ 7569) BETWEEN THE
VILLAGES OF TONG FA (YJ 756698) AND CAI LAM (YJ 755656).
SOURCE RECALLED SEEING ONLY ONE PARACHUTE WHICH WAS FULLY
DEPLOYED AND RED IN COLOR. SOURCE STATED THAT THE BURNING
AIRCRAFT CRASHED DOWN ON THE SIDE OF A HILL APPROXIMATELY
300 METERS INLAND FROM THE OCEAN.

5. [REDACTED] APPROXIMATELY THREE HOURS AFTER THE CRASH OF
THE AIRCRAFT SOURCE OBSERVED TWO U.S. PILOTS IN THE

CUSTODY OF VILLAGE MILITIA AND PUBLIC SECURITY (CONG AN) PERSONNEL OF CAI LAM VILLAGE. SOURCE RECALLED THAT BOTH OF THE PILOTS WERE STANDING WITH THEIR HANDS TIED BEHIND THEIR BACKS. SOURCE DESCRIBED THE PILOTS AS MALE CAUCASIANS, BOTH MEDIUM BUILD, BOTH YOUNG, BOTH APPROXIMATELY 1.72M TALL AND BOTH WEARING UNIFORMS SIMILAR TO PAVN ISSUE BUT LIGHTER IN COLOR. SOURCE RECALLED THAT BOTH MEN HAD RANK INSIGNIA ON THEIR SHOULDERS BUT THAT SHE DID NOT KNOW THE MEANING OF THE INSIGNIA. SOURCE COULD NOT REMEMBER THE HAIR COLOR OF THE MEN ALTHOUGH NEITHER OF THEM WERE WEARING HELMETS ACCORDING TO SOURCE. SOURCE DID NOT NOTICE ANY WOUNDS OR INJURIES TO EITHER OF THE PILOTS. SOURCE ALSO DID NOT OBSERVE ANY WEAPONS OR PERSONAL EFFECTS BUT SPECULATED THAT THEY WERE CONFISCATED BY THE CAPTURING FORCES PRIOR TO HER OBSERVATION OF THE PILOTS.

6. [REDACTED] SOURCE STATED THAT SHORTLY AFTER SHE OBSERVED THE PILOTS PUBLIC SECURITY PERSONNEL AND OFFICIALS FROM HA CCI DISTRICT (YJ 6574) ARRIVED AT DUCNG HOA AND TOOK CUSTODY OF BOTH MEN. AFTER THE PILOTS WERE TAKEN AWAY IN A MILITARY VEHICLE SOURCE DID NOT OBSERVE OR HEAR ABOUT THEM AGAIN. SOURCE DID NOT KNOW THE DESTINATION OF THE CAPTURED PILOTS. SOURCE WAS NOT ABLE TO PROVIDE FURTHER INFORMATION CONCERNING THE INCIDENT.

7. [REDACTED] SOURCE DID NOT OBSERVE ANY CHINESE PERSONNEL INVOLVED IN THE INCIDENT.
