SUBJ: (C) US Captive Killed by VC in Kiên Phong Province, Region 2.

(C) (10 pages, handwritten; B-3). Notebook, entries dated Jan to Jul 69, maintained by an unspecified person, contains records of ((RVNAF)) prisoners of war, including one US Negro CPT, who were captured ((by the VC)) in An Giang, Mỹ Tho, Bến Tre, Kiên Phong, Gò Công and Kiên Tường Provinces. The US Captain ((name not mentioned)) was captured after his plane was downed by ((VC)) ground fire in Kiên Phong Province on 14 Jan 69, and he was shot to death during his evacuation to an unidentified area. Captured under the same circumstances as the US Captain was an RVNAF Lieutenant who is still being detained in Kiên Phong Province.
