1. A RECENT *source* PROVIDED A CLAIMED LIVE SIGHTING OF UNIDENTIFIED MALE CAUCASIANS AT THE K-4 REEDUCATION CAMP OUTSIDE XUAN LOC TOWN, DONG NAI PROVINCE, SRV, IN LATE 1979.

AVAILABLE RECORDS INDICATE SUBJECT REFUGEE FORMERLY SERVED AT THAT TIME AS AN NCO WITH THE DONG NAI PROVINCE PUBLIC SECURITY SERVICE AND WAS KNOWLEDGEABLE CONCERNING THE K-4 REEDUCATION CAMP. DIA/DC-2 VIEWS SUBJECT SOURCE AS HAVING INFORMATION OF POSSIBLY SIGNIFICANT VALUE IN SEVERAL ASPECTS OF THE PW/MIA ISSUE.

2. AVAILABLE RECORDS IN REF MSG INDICATE SUBJECT REFUGEE DEPARTED INDONESIA FOR AUSTRALIA ON 23 MAY 84. HIS SPONSOR BROTHER-IN-LAW IS IDENTIFIED AS *name* *data*

RECORDS ALSO LIST A BROTHER-IN-LAW, *name* RESIDING IN AUSTRALIA WITH NO ADDRESS LISTED.

3. REQUEST YOU CONTACT SUBJECT REFUGEE AND DETERMINE HIS WILLINGNESS TO PROVIDE INFORMATION OF INTEREST TO THE PW/MIA ISSUE. IF HE IS AGREEABLE, WE CAN PROVIDE DETAILED QUESTIONS IN WRITTEN VIETNAMESE WHICH HE CAN EITHER RESPOND TO THROUGH AN INTERPRETER OR CAN PROVIDE IN HANDWRITTEN FORM FOR TRANSLATION BY DIA/DC-2.

4. POC IN DIA/DC-2 IS SEDGWICK TOURISON.
