1. REF A FORWARDED ADDRESS OF VN REFUGEE WHO WAS OF PARTICULAR INTEREST TO DC-2. REF B INDICATED VN INDIVIDUAL HAD MOVED BUT HIS BROTHER WOULD ADVISE WHEN HE HAD RECONTACTED HIS FAMILY. REQUEST UPDATE ON INDIVIDUAL'S AVAILABILITY.

2. DC-2 COMMENT: INDIVIDUAL IN QUESTION IS *source* AVAILABLE RECORDS OBTAINED FROM ANOTHER AGENCY INDICATE THAT *source* ACKNOWLEDGED HAVING SERVED WITH THE NATIONAL LIBERATION FRONT SECURITY SERVICES STARTING AT LEAST AS EARLY AS 1976. FOLLOWING THE COLLAPSE OF THE GVN HE SERVED WITH THE DONG HAI PROVINCE PUBLIC SECURITY OFFICE, CLAIMING TO HAVE BEEN A COMPANY GRADE OFFICER WHEN HE LEFT THE PUBLIC SECURITY SERVICES IN

SC IS KNOWLEDGEABLE CONCERNING REEDUCATION CAMP K-4 WHICH IS OF PARTICULAR INTEREST.

3. WHEN LOCATED, REQUEST YOU DETERMINE HIS WILLINGNESS TO RESPOND TO WRITTEN QUESTIONS WHICH CAN BE FORWARDED TO USDAO CANBERRA IN VIETNAMESE AND TO WHICH SC CAN RESPOND TO IN WRITTEN VIETNAMESE.

4. DIA/DC-2 POC IS SEDGWICK TOURISON.
