ALLEGED RECOVERY OF REMAINS, PERSONAL EFFECTS, AND
 IDENTIFICATION MEDIA ASSOCIATED WITH EIGHT OF NINE
 INDIVIDUALS FROM A HELICOPTER CRASH SITE LOCATED ON A
 RIVER BANK IN THAI THIEN (V), LONG THANH (D), DONG NAI
 (VIC. YS 1782). AT THE TIME OF THE INITIAL INTERVIEW,
 SOURCE CLAIMED THAT HIS COPY OF THE IDENTIFICATION
 INFORMATION WAS MISPLACED AFTER AN ATTACK ON HIS BOAT
 BY THAI PIRATES, AND THAT HE WAS ONLY ABLE TO RECALL A
 SINGLE NAME OF THE EIGHT.

4. SOURCE NOW CLAIMS TO HAVE RECEIVED FROM HIS
 HALF-BROTHER, VU DUC TINH (VUX DWCS TINHS) OF TAN BIEN
 WARD, BIEN HOA CITY, IDENTIFICATION INFORMATION
 ASSOCIATED WITH EIGHT OF NINE REMAINS. ONE REMAINS HAS
 NO NAME ASSOCIATION. THE IDENTIFICATION INFORMATION IS

5. IN ADDITION TO THE ONE REMAINS PROVIDED TO THE
"HANOI DELEGATION" IN DECEMBER, 1985, AT THE DEMAND OF
THE BIEN HOA PSS, SOURCE NOW CLAIMS THAT THE C14 OFFICE
OF THE PSS CONFISCATED ANOTHER OF THE REMAINS AT THAT
SAME TIME. HE DID NOT SPECIFY WHICH OF THE REMAINS ARE
NOW IN SRV CUSTODY.

6. COMMENT: "ADDISON" WAS REPORTEDLY IN REF.
ALL NAMES REPORTED IN PAR- 4, WITH THE EXCEPTION OF
"EAUREY," HAVE BEEN THE SUBJECT OF PREVIOUS "DOG-TAG"
REPORTING. THE "COURHLING" AND "BODELL" NAMES ARE
FOLLOWED BY IDENTICAL DATA. THE NAME "R WILSON" IS
ASSOCIATED WITH REFNO 1754. INTERVIEWER'S INITIAL
IMPRESSION OF SOURCE'S LACK OF CREDIBILITY WAS
REINFORCED BY THIS SECOND MEETING. THE PAPER FROM
WHICH THE INFORMATION REPORTED IN PAR. 4 ABOVE IS TAKEN
WILL BE FORWARDED SEPARATELY TO HQ, JCRC. DECL: OADR
