(U) (1 page, typewritten; B-1) Circular 28/TB-K, dated 11 Dec 69, signed by Trung Ngón for the Administrative Office of A15 ((possibly the Current Affairs Committee, former Sub-Region 5 Party Committee, presently Thu Bien Sub-Region, COSVN)), forwarded to all A's ((possibly subordinate agencies of the Sub-Region)) and B's ((possibly various district Party Committees)), informs the addressees of the appointment of the following six cadre to the Administrative Office, with the view of ensuring a successful performance of missions: Comrade Ba Ngón, Chief of the Administrative Office and the Study Cell; Comrade Tú Tân, Asst Chief of the Administrative Office, in charge of studying Party activities and the situation of friendly ((VC)) agencies in the intermediate line area; Comrade Bãy Ngoc, a cadre in charge of studying military and civilian proselyting and political struggle activities; Comrade Ba Nhó, a cadre in charge of collecting information pertaining to the enemy ((FVMAF/RVNAF)) situation in urban areas; and Comrades Ba Hóp and Hai Bau, Deputy Chiefs of the Management ((Section)). A handwritten note on the document states that this Circular was forwarded to B3 ((possibly Châu Thanh District Party Committee, former Sub-Region 5, COSVN)).
