1. In accordance with reference (a) the following quarterly combat readiness report of ground units is submitted for the period 1 October through 31 December 1960. Enclosures (1) through (8) are the quarterly readiness reports of subordinate units.

2. This Command is capable of providing two Marine Divisions, two Marine Aircraft Wings, a Marine Brigade consisting of air and ground elements, plus supporting elements of Force Troops for the conduct of combat operations.

3. Significant events which occurred during the past quarter and had a direct influence on readiness were as follows:

a. Increased tension in Southeast Asia during the latter part of December resulted in establishment of an increased readiness posture for our Western Pacific forces, the Air Naval Gunfire Liaison Company and the First Composite Radio Company. Activation of 3d Marine Division forces and embarkation of supplies and equipment in support of CJTF 116 provided effective training and served to test the Division's preparedness for mount-out and subsequent operations. In addition, the BLT assigned in support of the Seventh Fleet remained afloat and was ready for immediate use as required in support

of contingency plans.

b. Continuation of the transplacement program resulted in the 2d Battalion, 9th, 3d Marines being rotated to the 3d Marine Division. The 1st Battalion, 1st Marines and the 2d Battalion, 1st Marines rotated from the 3d Marine Division to the 1st Marine Division.

c. The Communications Company (-) (Rein), 7th Communications Battalion, FMF and a Pathfinder Team (Sub-Unit #1, 1st Force Recon Company, FMF) joined the 3d Marine Division on 1 December 1960.

4. PERSONNEL

a. The major ground commands of Fleet Marine Force, Pacific were below authorized strength for officers and enlisted personnel. The major personnel deficiencies were shortages in rank and MOS to fill authorized billets. Specific shortages are shown in subordinate unit reports.

b. Significant personnel factors by commands were:

(1) 1st Marine Division (Rein): This division had a serious shortage of officers in MOS 2715. Shortages of approximately 50% of that authorized by current T/O existed in OF 65, 66 and 71 in ranks from E-1 through E-6.

(2) Force Troops, FMFPac: The personnel shortages reported by the Commanding General, Force Troops, FMFPac as critical were: 84 enlisted, MOS 0844, in ranks of E-4 and below.

(3) 1st Force Service Regiment: The manning level assigned this regiment prohibited it from accomplishing its prescribed mission of logistically supporting a Marine Expeditionary Force. The manning level authorizes only 43% of the enlisted personnel and 53% of the officer personnel that are authorized by the L - Series T/O and restricts the regiment from performing its mission efficiently. Recommendations have been submitted to correct this situation. 56% 70%

(4) 1st Marine Brigade, FMF: This brigade reported a shortage of 12 officers and 185 enlisted personnel. The

officer shortages were in OF's 01, 04 and 25. Enlisted personnel shortages were in ground MOS' in pay grades E-1/E-2.

5. TRAINING

a. Training conducted during the quarter encompassed individual training through Battalion and Regimental Landing Team exercises. Primary emphasis in the 3d Marine Division was placed on training required for missions assigned in order to insure combat readiness and included a Regimental Landing Team exercise combining beach and helicopter borne assaults designed to suppress small bands of guerrillas. Training in the 1st Marine Division and the 1st Marine Brigade was highlighted by exercises conducted in conjunction with the organization Troop Test Program, with emphasis placed on platoon, company and brigade sized units. Results of the field tests have been received and are being reviewed prior to submission to the Commandant, Marine Corps Schools (Dir MCLFDC).

b. Division CPX's, Battalion ORT's, Naval Gunfire exercises, and numerous field exercises were conducted and contributed to the overall posture of training readiness. Five major exercises, including Artillery Regiment, Artillery Battalion, Infantry Battalion and Anti-Tank Battalion training were conducted in the Fuji-McNair area, thereby re-emphasizing the importance of that area for training of WestPac units. On the other hand the lack of a battalion or largersized training area available to the 1st Marine Brigade remained a training problem for that organization. Individual marksmanship training was also stressed during the quarter.

c. Artillery and Antiaircraft units conducted basic, advanced, and amphibious training in conjunction with aviation and infantry units.

d. Units continued emphasis on organic schooling and on-the-job training in an effort to compensate for the reduction in formal schooling caused by limited TAD funds. The effectiveness of the increased unit schooling was somewhat offset by the lack of facilities and technically qualified personnel available. Additional schooling was provided by mobile teams from LFTU and 9th Air Force for the 1st Marine Division.

e. Enclosures (1) through (8) contain specific lists of training exercises and indicate a degree of training readiness which is predominantly category A, especially in deployed units. The transplacement battalions relegated to cadre status

have reduced the training effectiveness at regimental and division levels in the 1st Marine Division but the Division has the capability to mount-out within 10 days, if required.

6. MATERIAL:

a. All ground units of Fleet Marine Force, Pacific with the exception of the 1st AA Group had on hand sufficient material to mount out and engage in assigned missions.

b. The special report on the status of mounting out stocks of the 3d Marine Division (Rein), requested by reference (b), is attached to the report of that unit.

c. Specific material improvements, or limitations on individual units to perform assigned missions are enumerated below:

(1) 1st Anti-Aircraft Group

(a) The readiness of the missile battalions continued in Category "C". The supply of HAWK and items was still not satisfactory, but all echelons were aware of the problem. Only two HAWK batteries could be maintained and this involved the exchange of battery equipment. || ✓

(b) Directly related to HAWK readiness was the fact that the HAWK Maintenance Platoons of the Det., 1st FSR had not received all of the equipment and parts necessary to accomplish their missions.

(2) 1st Marine Division (Rein)

(a) Deficiencies regarding the AN/TRC-27 have been forwarded by correspondence. Further shortcomings affecting this equipment will be forwarded by the 1st Marine Division report of OPERATION PACK MULE (PHIBLEX 42-60). ✓✓

(3) 1st Marine Brigade

(a) This Headquarters is aware that in the event the 1st Marine Brigade is committed to a combat situation, material resources available to this Force would have to reinforce the support elements of that unit. It is considered, however, that the present material available

to the 1st Marine Brigade, with minor exceptions, is adequate for its present mission. Specific recommendations for improving the material status of the 1st Marine Brigade Service Battalion are under consideration.

(4) 1st Composite Radio Company

(a) The receipt of the communications shelters S-144 on 22 January 1961 considerably improved the readiness of this unit. Practically all material deficiencies will be satisfied upon arrival of the Craig Helo-Lift huts.

(5) 3d Marine Division

(a) The most serious deficiency continued to be the lack of required items to complete the outfitting of the 2d Supply and Maintenance Platoon of the 3d Service Battalion. Deficiencies are on requisition.



STATEMENT OF THE COMMANDER
(Form 2)

1. During this quarter, one infantry battalion, 2d Battalion, 9th Marines, 1st Marines (now 2/3) was deployed to the 3d Marine Division, 18 November. Organization of infantry transplacement battalions continues in accordance with current directives. Two infantry battalions; 1st Battalion, 1st Marines (formerly 1/5/1) and 2d Battalion, 1st Marines (formerly 2/5/1) joined this command from the 3d Marine Division on 5 October and 16 December respectively. The 1st Battalion, 1st Marines (1/5/1) commenced its CONUS half-cycle on 1 October. The personnel figures in this report include personnel assigned to the 1st Force Service Regiment (-).

a. Personnel:

(1) Officers

(a) During the second quarter of this fiscal year officer strength was relatively constant.

(b) The following table presents the current officer strength:

(1) This period was highlighted by exercises in conjunction with the Troop Test Program. One infantry battalion, 1st Battalion, 5th Marines (formerly 2/3/5), conducted the majority of field tests of weapons and proposed organization.

(2) As outlined in form 4, organizations of this Division participated in exercises from company to brigade size.

(3) One infantry battalion, 2d Battalion, 9th Marines, 1st Marines (now 2/3), completed the stateside transplacement training cycle and departed for the 3d Marine Division during the quarter.

(4) Individual marksmanship training continued to receive special emphasis. The requalification figures for the quarter are as follows:

(5) A total of 838 students attended Division Schools during the quarter. Nineteen (19) officers completed the ABCD course and were assigned an additional MOS of 5702.

(6) Landing Force Training Unit Pacific provided Mobile Instructional Teams which conducted courses in Embarkation, Shore Party, and Staff Planning. A total of 173 students completed these courses.

(7) Two Division CPX's (17-19 Nov & 13-15 Dec) were held in conjunction with the Troop Test Program to test the single CP concept.

(8) An instructional team from the 9th Air Force conducted a one week familiarization course at Camp Pendleton in the techniques and problems associated with Air Transport loading and mount-out procedures.

12 January 1961c. Materiel

(1) General. The materiel readiness of this Division will permit it to perform assigned combat missions. With minor exceptions all combat essential items are in the possession of subordinate units. Some local shortages do exist but, except as noted below, these do not significantly affect the combat capability of this Division.

(2) Communication-Electronics. The reduction in the replacement and evacuation program this Fiscal Year has caused a considerable increase in the work load of communication-electronics maintenance facilities. The full impact of the R&E reductions cannot be determined at this time, but these reductions will lessen the communication materiel readiness posture of this Division.

The electronics repair parts support of the division remains below acceptable standards. A sampling of the major electronics items deadlined for periods in excess of forty-five (45) days discloses that out of forty-six (46) similar items on deadline a total of thirty-nine (39) different parts were required to effect repairs; the deficiency in spare parts support, therefore, is general and not restricted to any one unit or type of parts. The above items do not include components such as headsets, handsets, and test equipment, of which approximately 325 are also deadlined awaiting parts.

Regarding the radio relay set, AN/TRC-27, comments expressed on its limitations on the last Quarterly Readiness Report have been reaffirmed this quarter. This equipment in its present form does not fulfill its intended mission. After conducting local schools and employing this item extensively for the past six months, utilizing the talents of factory technical representatives both for training and technical assistance, this division has never been able to operate successfully all planned circuits. The optical line of sight characteristics so necessary for its employment seriously restricts its tactical employment at the Infantry/Artillery regimental and battalion levels. This equipment is so fragile as to require abnormal care in handling, transportation and installation. Equipment failures with the AN/TRC-27 have caused less than 50% availability during exercises this past 6 months. These shortcomings affect not only the infantry, but also the artillery and supporting elements which must share the Division Radio Relay System.



(3) Ordnance. Ordnance material readiness within the division is satisfactory with the exception of 3d Battalion, (9th Marines) 7th Marines. This battalion is currently being reconstituted from cadre status. Individual weapons were transplaced last quarter to Okinawa with the 3d Battalion, (9th Marines) 7th Marines and the battalion returning from Okinawa was joined at zero strength with no equipment. Replacement BAR's are on requisition, but are not available on the west coast. 3d Battalion, (9th Marines), 7th Marines is now 3/7.

As a result of re-equipping one tank company last quarter with M48A1 tanks vice M103 tanks, and due to the delays inherent in the R&E program, 1st Tank Battalion is short two M48A1 and two M67 tanks. Additionally, three M48A1 tanks which were replaced from the combat allowance were evacuated as a result of flooding which occurred during the Ready BLT Mount Out Exercise last November. This has been the subject of separate correspondence.

(4) Engineer. Engineer materiel readiness is adequate, but shortages in certain repair parts of selected items of major equipment do exist. Currently 1st Pioneer Battalion has no mechanical dirt lifting capability due to the evacuation of all of their tractors, industrial, Huff (front end loaders). These three tractors have been phased out of the Marine Corps Supply System and new model tractors are not due until the end of FY-61.

(5) Motor Transport. The status of motor transport remains satisfactory. Some shortages do exist in certain selected items of spare parts, but these are of such nature as not to materially reduce the combat readiness of this division.

Personnel.NOTE 1:

The major personnel problems in this command are:

- a. Shortage of officers in MOS 2715
- b. A shortage of approximately 50% of currently authorized strength in various ranks as follows:

E6, E4, E3	Of 65

NOTE 2:

Strength of the Division is below manning level. This and the discrepancies in actual rank and MOS are the basis for the category B evaluation of this commands personnel readiness.

NOTE 3:

The 1st Regiment is shown as category B due to the recent arrival of 2d Battalion, 1st Marines (formerly 2/5/1) from Okinawa at reduced strength. Scheduled input should correct this situation by 15 January 1961.

Training.NOTE 1:

Training deficiencies within this Division continue to be related directly to personnel shortages. The transplacement battalion program and battalions relegated to cadre status have reduced the training effectiveness at the regimental and division levels. In the main, training at the battalion and lower levels, exclusive of the units in cadre is considered to be excellent. The Division has the capability to mount-out within ten days on a combat mission.

STATEMENT OF COMMANDER (FORM-2)

1. Personnel.

a. Personnel strengths of the 3d Marine Division are considered to be minimal satisfactory for current missions of the Division. In the event of any personnel levy on the Division to fill billets on a Contingency Plan Staff, the situation becomes sub-minimal. There is a shortage in the current manning level of the Division of 89 officers and 666 enlisted, many of which are of critical MOS's and rank. The most significant of these shortages are in MOS's shown in succeeding paragraphs, the most critical of which are Tracked Vehicle, Engineer, Bulk Fuel and Communications personnel in the Marine Corps and Medical in the Navy.

b. Certain organizational changes occurred during this period. The 2nd Bn, 5th, 3d Marines transplaced on 28 November 1960 and was replaced by 2nd Battalion, 9th, 3d Marines on 1 December 1960. The Communications Company, 7th Communication Battalion, FMF, arrived on 1 December 1960 and was administratively attached to Headquarters Battalion, 3d Marine Division. The Pathfinder Team (Sub-Unit #1, 1st Force Recon Co., FMF) arrived on 1 December 1960 and was attached to Headquarters Company, 9th Marines for administrative control.

c. The Longshoreman Company (T/O L-3403), Third Force Service Regiment has not yet been staffed.

d. In view of the fact that this Division is required to operate from nine (9) camps and that Camp Butler has insufficient personnel to provide for and perform required Base type functions, the heavy demands for Fleet Assistance personnel detracts materially from the proper employment of Division personnel in their T/O billets. Of these, one hundred twenty-five (125) personnel are provided direct to Camp Butler, and approximately 400 others are assigned to Base functions normally provided by Marine Corps Base personnel in the CONUS. This additional drain on personnel from organizations already under manning level strength adversely affects training and combat readiness on a continual basis.

e. The operation and maintenance of two rifle ranges on Okinawa and a range detachment at Fuji-McNair, Japan further add to this problem since, (as indicated by Commanding General, Fleet Marine Force, Pacific Quarterly Combat Readiness Report for 3d Quarter, 1960 to CMC (Serial 0463-60 of 7 November 1960) (paragraph 4.a) (Personnel)), this Division was the only major ground command in FMF, Pacific under-strength in Officers. Operating under-strength initially, with the requirements of

nine camps and three ranges super-imposed, the Division continually operates under an acute officer shortage. Particularly pressing at this time is the need for manning level strength in critical specialties in the 3d Force Service Regiment.

2. Training

a. The state of training of Division personnel during the 4th quarter of calendar year 1960, has increased over the last quarter, but the problems of personnel shortage and time-consuming training effort required to integrate new untrained personnel into each unit continue to prevent maximum advanced training in many units. However, scheduled on-island and off island training exercises and special emphasis on training required for missions assigned in Contingency Plans are designed to ensure the Division's readiness for commitment.

b. The actual activation of forces and embarkation of supplies and equipment in support of CJTF 116 Operation Plans during the month of December has been more effective than any training exercises conducted during the quarter in testing and increasing the Division's preparedness for mount-out and subsequent operations.

c. The primary objectives of the two Division CPX's conducted were to test communications capabilities and to increase mobility of unit Command Posts.

d. A Regimental Landing Exercise (Exercise 43-60: PAOK-BOARD) was conducted 12-20 November involving in some capacity every Division unit. A landing force commanded by Col. T. F. BEEMAN, Commanding Officer, 3d Marines, conducted a combined beach and helicopter borne assault. The problem was centered on the suppression of small bands of guerrilla forces by battalions operating under Regimental control to secure three separate TAOR's.

e. There were five other major training exercises conducted during the quarter which included Artillery Regiment, Artillery Battalion, Infantry Battalion, and Anti-Tank Battalion training at the Fuji-McNair Training Area in Japan. Due to the limitations on adequate training areas for tanks, anti-tank, and artillery on Okinawa, the Fuji-McNair Training Area continues to be the most suitable training facility available to the Division for Battalion exercises and the firing of tank, anti-tank, and artillery weapons.

f. Other off-island training included Naval Gunfire Exercises at Tabones with 25 Marine and Navy personnel composing 2 spotting teams, and a reinforced company size RECONEX in the Philippines.

g. An afloat BLT was maintained as part of the amphibious Ready Group during the entire quarter. This Battalion held Amphibious exercises in Taiwan and Helicopter borne exercises at Subic.

h. Two battalion size Operational Readiness Test Exercises (ORTEX's) were held to test the capability of units to mount-out on short notice.

i. Division Schools continued to increase the formal training within the Division this quarter by graduating 92 Officers and 855 Enlisted men.

j. From the standpoint of training the Division has increased its preparedness and is ready for combat operations. For greater effectiveness in extended operations more personnel basically trained in critical occupational specialties are required.

3. Material.

a. The 3d Marine Division is ready for immediate embarkation and for sustained operations. Sufficient organic equipment

and materiel are on hand for initial commitment.

b. Recommended changes in the "M" Series T/E's continue to be submitted. Items such as generators, spray paint machines and others have been authorized on a temporary basis in order to improve combat readiness.

c. The employment of tactical vehicles for garrison support in addition to normal training exercises necessitates a high maintenance and repair rate.

d. The 3d Service Battalion still lacks certain T/E items which curtail that organization's maintenance capability (See consolidated report). Seriously curtailed is this organization's artillery maintenance capability due to the non-availability of a Shop set, artillery.

1. Personnel.

a. 1st Bridge Platoon, 1st Bridge Company has a critical shortage of 11 enlisted men. Under current shortage of personnel (666) the Division has not the means to build this unit to strength. In an actual operation personnel now performing Camp type functions would be assigned.

b. Medical Battalion has an overall rating of category "C" due to the shortage of 18 Medical Corps Officers. However, it is anticipated that this deficiency would be corrected if this unit were committed into combat. Personnel are not available to bring this organization to strength as an acute shortage of Medical Personnel exists throughout. Contingency Plans provide for flying out sufficient personnel to fill these vacancies when the situation requires.

2. Training.

a. The 1st Bridge Platoon, 1st Bridge Company, is in Category "C" because of insufficient personnel to maintain organic engineer and bridge equipment and still perform required bridge training. This has been alleviated partially by shifting maintenance responsibility for certain equipment to the Support Company, 3d Pioneer Battalion. A comprehensive training schedule has been established to improve technical efficiency of personnel.

b. The 3d Tank Battalion is in Category "C" due to the fact that the large number of replacements gained during the quarter have had no previous tank training. The Battalion has therefore commenced training on a basic level. The Tank Battalion also has had no large scale training exercise this quarter but with an exercise scheduled at the Fuji-McNair Area 1st Quarter Calendar Year 61 will have an opportunity to conduct live firing and other advanced training sufficient to improve their current combat readiness.

3. Materiel. The 3d Marine Division is categorized by an overall rating of "B".

Artillery maintenance capability is curtailed due to non-availability of a shop set, artillery.

Requisitions have been placed and this situation will be alleviated upon receipt of the requisitioned equipment.

b. "D" Company, 3d Medical Bn.

This organization lacks sufficient organic equipment (tentage, light set, X-Ray and laboratory facilities, generator PU-239, and the like). These items were left at Range Detachment, Fuji-McNair upon return of this unit to Okinawa.

It has been directed that all major items of equipment not authorized by T/E Range Detachment, Fuji-McNair be returned to 3d Medical Bn. In addition, the X-Ray set has been returned. This will change the "C" Category currently held by this organization to "B".

c. 3d Bn (7th) 9th Marines

This unit has been assigned Category "C" due to materiel shortages primarily consisting of batteries for communication equipment.

Appropriate supply action has been taken and these shortages will be corrected during January 1961.

QUARTERLY REPORT OF COMBAT READINESSSTATEMENT OF THE COMMANDER(FORM 2)1. Personnel

a. At the end of the quarter the Brigade had a shortage of 12 officers and 185 enlisted. The officer shortages were centered in OF 01, 04 and 25. Enlisted shortages were centered mostly around ground MOS's in pay grades E-1/E-2.

b. Naval personnel situation at the end of the quarter showed a shortage of 3 dentists and 6 dental technicians. There was an excess of 22 hospital corpsmen.

c. The overall picture of the personnel situation indicated that the Brigade was operating at 97% of the authorized officer manning level and 97% of the authorized enlisted manning level.

d. Neither the Brigade Headquarters Company nor the Service Battalion Headquarters has sufficient personnel to establish and maintain a combat command post. This is due primarily to the lack of communication, clerical, and motor transport personnel in the T/Os for these two units.

2. Training

a. Training Readiness remains in the category "A" state. This quarter's training was devoted primarily to the Troop Test Program with emphasis placed on all phases of platoon and company field training.

b. All units fired all organic weapons during battalion field firing exercises in the Pohakuloa training area.

c. The Brigade is prepared to embark immediately for combat operations.

3. Material

a. Material readiness continues to be maintained at a high level with only minor exceptions.

CONFIDENTIAL

b. An overall "B" category for material readiness is assigned the Brigade as a whole however, for the following reasons:

(1) Lack of approved Tables of Equipment for Service Company and Headquarters Company of Service Battalion continues to adversely affect the combat efficiency of these units.

(2) As previously reported, and on a continuing basis, certain critical items of motor transport, ordnance and communication-electronics equipment are lacking or require replacement.

1. Major Deficiencies

a. Personnel. See Form 2, paragraph 1.

b. Training

(1) The lack of battalion and larger size training areas remains a training problem.

(2) The non-availability of Landing Craft preclude the proper training of the Brigade Shore Party.

c. Material

(1) 4th Marines

(a) Motor Transport. Pending receipt of the authorized Light Infantry Carrier M274, substitute jeeps (M38A1) and trailers continue being utilized. Current budget guidance indicated partial receipt of the former is now scheduled for 1st Quarter Fiscal Year 1963.

(b) Communication-Electronics. On a continuing basis the air-ground communications presents a problem area. As previously reported, six of the authorized ten MAY radios evacuated for repair and modernization during 3d and 4th quarter Fiscal Year 1960 have not been returned to date. A recent communication from CG, MCSC, Barstow advised the Brigade that subject radios, when received from the repair and modernization contractor, were in an unserviceable condition and consequently all action regarding same is being held in abeyance pending resolution by GMC.

(c) Ordnance. The previously reported shortage of bayonets and seabards is becoming critical. The shortage of these items has increased to one thousand ninety-four (1094) and one thousand two hundred fifty-seven (1257) respectively.

(d) General Items. Because of excessive time on requisition the following items, although not major items, are reported:

25 Pumps, Air pressure (for Field Ranges) on requisition since 9 November 1959.

16 Post, aiming M1A2 on requisition since 11 May 1960.

(2) Service Battalion

(a) As previously reported, the combat capabilities and efficiency of both Service Company and Headquarters Company continue to be adversely affected by the lack of approved Tables of Equipment for these units.

(b) Companies comprising the Service Battalion are not in proximity to their parent unit and consequently are without the back-up support normally available. In particular, this hinders the Battalion's capability to support the Brigade in ABC Defense.

2. Action taken to rectify deficiencies

a. Personnel. Not applicable.

b. Training

(1) Coordination with U. S. Army Hawaii is making some of the Army owned training areas on Oahu available to the Brigade more frequently.

(2) Field problem using available LVT2 and trucks to simulate small landing craft are planned for Service Battalion elements to improve their amphibious landing capabilities. Some experience is being gained in beaching, loading and unloading LSTs during administrative moves to outer-island training areas. During scheduled training in SOCAL during 4th Quarter FY 1961 this area of training will be stressed heavily while shipping is available. Unfortunately this will be subsequent to the scheduled Brigade Landing Exercise.



1. Personnel

a. Officers: The authorized manning level for officers is 100% of Tables of Organization, or 272 officers. The on-board strength is 283, an overage of 11. Of the total strength, an overage of 53 lieutenants exists, the majority of whom have been assigned for on-the-job training in selected occupational fields. By rank, there is a shortage of 6 majors and 7 captains which, though not considered critical shortages, have left vacancies by T/O authorized rank in subordinate command billets.

b. Enlisted: The enlisted personnel input during the reporting quarter has been sufficient to build the Command up to strength with a manning level of 4194 enlisted and an on-board strength of 4163. With the advent of the Hawk Missile units, the requirement for trained personnel in specialist fields has been greatly increased, but the personnel base for training the required specialist is available. Within the Field Artillery Group there is a critical shortage of 84 enlisted E-4 and below O844's.

c. From the personnel standpoint, the Command is at a peak of readiness and all subordinate units are capable of embarking immediately for combat operations, with the following exceptions:

2nd Light Antiaircraft Missile Battalion
4th 155mm Gun Battery (Self Propelled)

2. Training. Recent activation of various units within Force Troops coupled with the existence of long established units contributes to the extreme variance of training readiness and training programs.

a. Individual Training. Individual training within recently activated units and units with a large influx of basics has been stressed. Due to budget limitations, formal school quotas have been drastically reduced. During the past quarter only NCO, Officers ABC and a selected number of administrative courses were utilized at schools conducted by

1st Marine Division and Marine Corps Base, Camp Pendleton. Lack of funds to send personnel to communications, ammunition, weapons repair, food service and enlisted ABC courses has and will continue to adversely affect the training readiness. Establishment of locally conducted schools has and will tend to compensate for this condition but lack of facilities and technically qualified personnel that can be spared for instructors can only partially fill the gap.

b. Basic Unit Training. Within the Antiaircraft Group units, the following basic unit training has been accomplished during the quarter; 1st MAAM Battalion completed missile firing by batteries at Pacific Missile Range; 1st IAAM Battalion completed package training at Fort Bliss, Texas, and the 2nd IAAM Battalion commenced package training at Fort Bliss which will be completed during February 1961. Self-propelled units within the 1st Field Artillery Group were restricted from firing during a large portion of the quarter due to faulty sight shaft assemblies. This condition has been rectified and normal field firing exercises will be conducted during the 1st quarter 1961. The 1st HARB(-) and the 1st 155mm Howitzer Battery conducted numerous field exercises. No field work was done by the 3rd and 4th 155mm Gun and 4th 155mm Howitzer Batteries recently removed from cadre status. Unit training for "D" Company, 7th Engineer Battalion is accomplished by the assignment of various engineer tasks. Projects assigned to this unit are screened to insure compatibility with the unit's training requirements. Unit training for Detachment 1st Force Service Regiment does not apply to the Detachment as a complete unit. Task organizations are formed as required. The 5th Dental Company established a dental field unit with instruction on assembly and field operations.

c. Advanced Unit Training. A COMEX was conducted by the 1st Anti-aircraft Group involving Headquarters Battery, the 1st IAAM Battalion and elements of the 3rd Marine Air Wing during October and November 1960. Subsequent to the COMEX, 1st IAAM Battalion participated in ADEX 2-61 conducted by the 3rd Marine Air Wing. The 1st Field Artillery Group conducted one CPX and participated in one FFEX in support of the 11th Marines during the quarter. One CPX and one FFEX have also been scheduled for the 1st quarter 1961. The 4th 8" Howitzer Battery (SP) participated in a mount out exercise during December. Additional Force Troops units will be designated to participate in this type exercise during the 1st quarter 1961.

d. Amphibious Training. A Detachment, 1st Field Artillery Group consisting of the Headquarters (-), 1st 155mm Howitzer, 1st 8" Howitzer (SP) and 1st Heavy Artillery Rocket (-) Batteries participated in PHIBLEX 42-60 "PACK MULE". Participation of "D" Company, 7th Engineer Battalion in combat Support Exercise 40-60 "LONG HAUL" continued until

21 October 1960. There are no amphibious exercises scheduled for the 1st quarter 1961 in which Force Troops units will participate.

3. Material

a. With the exception of the 5th AOP and HAWK Maintenance sections of Det 1st FSR, material readiness has not changed appreciably during the past quarter. The AOP problem is discussed in the Report of Readiness to Conduct Atomic Warfare, and for reasons of classification is not further discussed. The new HAWK Maintenance Platoons have not yet received all of the equipment and parts with which to accomplish their mission. In regard to the supply of HAWK end items and parts, all echelons are aware of the problem, and it is felt that this is not unusual for a new weapons system. As the situation currently exists, only two effective HAWK batteries can be maintained and this involves the exchange of battery equipment.

b. The training of the new LAAM Battalions is also affected by the shortages of parts. These have been the subject of separate correspondence at the request of Headquarters Marine Corps. Of particular importance, as it relates to training, is the lack of training missiles.

c. A problem common to the Marine Corps as a whole is the shortage of M-62 wreckers, MRC 83 radios and packing and crating materials. Recent mount-out drills have emphasized the need for the latter items.

1. Personnel. Category "A" has been specified for this Command. Personnel shortages by rank and MOS do exist, however it is considered that with the current on-board strength, an adequate personnel base is available to meet training and readiness requirements.

2. Training. Training Category "B" has been assigned to Force Troops in its entirety due primarily to recent activation of a number of units and secondly because of the lack of ample amphibious training for other units. Participation by all Force Troops units in a minimum of one amphibious exercise during 1961 should enable a Category "A" assignment to Force Troops by 30 September 1961. A majority of the key personnel have completed training or had the experience to enable them to plan and conduct combat operations.

a. Action taken. Scheduling for all units of Force Troops to participate in amphibious exercises during 1961 has been accomplished.

b. Estimate in column 6 is based primarily on the participation of all Force Troops units in an amphibious type exercise prior to 30 September 1961. Secondly the personnel situation is presently such that effective unit training programs can be initiated and accomplished.

3. Material. Material readiness is assigned category "B" due to shortages of equipment; equipment deadlined for lack of parts and shortages of communications equipment.

a. Action taken. Requisitions for shortages have been submitted.

b. Estimate of "unknown" for all Category B and C subordinate units is based on a lack of positive information on delivery of end items and for parts. Detachment 1st FSR expects to receive delivery of certain AOP equipment early in January 1961, but the delivery dates of other equipment to bring this unit to a B status is unknown.

1. Statement of the CommanderA. Personnel

(1) The currently imposed manning level prohibits this Regiment from accomplishing its prescribed mission of logistically supporting a Marine Expeditionary Force as set forth in the L-series organization. Aside from the fact that the manning level authorized only 43% of the enlisted personnel and 53% of the officer personnel that would be authorized at full strength, further restrictions have been placed on the manning level in that the total authorized in any rank and/or MOS must include the Regiment at Camp Pendleton and the Detachment at 29 Palms and may not exceed the reduced strength authorized under the L-series T/O in a given rank and/or MOS.

(3) A proposed manning level within a ceiling limit of 95 officers and 1591 enlisted personnel for 1st Force Service Regiment, Camp Pendleton and 29 officers and 458 enlisted personnel for the Detachment, 1st Force Service Regiment at 29 Palms has been submitted for the second half of FY 61. Preparation of these recommendations was seriously restricted in that the authorized reduced strength in any rank or MOS could not be exceeded and was required to include both the Detachment and the Regiment proper. This is an unrealistic approach in view of the fact that the Regiment at Camp Pendleton and the Detachment at 29 Palms have similar missions. The reduced strength figures in T/O L-3449 do not provide for operation of two logistic organizations at two widely separated locations. As a result, the combined recommended manning level is, at best, an unsatisfactory compromise.

(4) Critical shortage of Supply MOS's (117), Automotive Mechanics (46), Maintenance Personnel other than automotive (37), and Technician Specialists (71).

(5) This Regiment continues to lose personnel to Drill Instructor and Recruiters School as well as normal transfer. In many cases, untrained personnel are received as replacements. During this quarter, 164 enlisted personnel were either transferred or discharged while 397 were joined. Most of the joiners held either basic MOS's or MOS's in the infantry field. This constant turnover of personnel does not lend itself to the most efficient operation of a highly complex logistics organization.

(6) Detailed statements regarding the deficiencies in the currently authorized manning level were contained in the last quarterly combat readiness report and are still valid.

1. Major Deficiencies

b. Training

The rapid turn over of trained personnel, manning level restrictions, unmanned and unactivated elements influences the attainment of a high level of organizational effectiveness of the Regiment. Additionally the assignment of FMF personnel to the non FMF battalion to perform garrison missions, while enhancing individual technical skills leaves much to be desired by the FMF Battalions which will assume the responsibility upon mobilization or deployment. The primary concern is the Supply Company which is integrated into the Base Materiel Battalion.

2. Statement of action taken by the Commander to rectify major deficiencies listed in paragraph 1 above.

a. Personnel

(1) A report of critical MOS's is submitted to Commanding General, 1st Marine Division, monthly. Continuing liaison is maintained with the Division G-1 and Personnel office regarding shortages, both officer and enlisted.

(2) A vigorous reenlistment program is in effect. 47.3% of first term Marines and 69.4% of second term Marines recommended for reenlistment have been reenlisted during this quarter.

(3) An accelerated on-the-job training and retraining program is in effect.

(4) A recommended manning level for the 2nd half of FY 61 has been submitted to CG, FMF Pac and includes both the Regiment at Camp Pendleton and the Detachment at 29 Palms and, although still not adequate, will, if approved, place the Regiment in a more satisfactory position to adequately support Marine Corps Base, Camp Pendleton and the 1st Marine Division.

(5) A recommended change to L-series table of organization will be submitted during the next quarter. Recommended changes will be focused on increasing the reduced strength column to provide sufficient personnel to logistically support both Marine Corps Base Camp Pendleton and 29 Palms.

b. Training.

(1) Continual emphasis on the technical training of problem MOS's.

(2) Intensive on the job training for basic MOS's consistent with garrison requirements.

c. Materiel

(2) A continued requirement to maintain both the Detachment at 29 Palms and the Regiment at Camp Pendleton at sufficient strength in appropriate ranks and MOS's and yet remain within the authorized reduced strength of T/O L-3449 will seriously affect the capability of either to provide adequate logistic support for the two bases. The reduced strength column of T/O L-3449 is barely adequate in some ranks and MOS's to support Marine Corps Base, Camp Pendleton and the 1st Marine Division. Conversely, the reduced strength column of T/O L-3449 is entirely inadequate to logistically support two large bases such as Camp Pendleton and 29 Palms plus a Marine Division.

1. Personnel

a. Table of Organization Number (Provisional) 4853 revision number one, as modified by CMC letter AO1E-bjf of 25 Nov 1960 authorizes 271 enlisted and 38 officers (including 6 USN) for this company. The current authorized manning level is 211 enlisted, 22 officers USMC and 6 officers USN. Assigned at the end of this reporting period were 185 enlisted and 27 officers (including 6 USN). Considering enlisted personnel, the Company is 68 percent combat ready under the T/O and 87 percent combat ready under the manning level. Considering officer personnel, the Company is 73% combat ready under the T/O and 96% combat ready based on the manning level.

b. The present on board strength together with the known personnel changes indicates that 1st ANGLICO will continue to operate below the manning level with enlisted personnel during the next quarter. This shortage considered with the limiting effect of having a single Forward Air Control Team and a single Naval Gunfire spot team with each Battle Group is a critical deficiency.

2. Training

a. A high state of training readiness is maintained among all personnel on board through frequent unit field training exercises, command post exercises with U. S. Army units and technical training exercises. All personnel attached are sufficiently trained for immediate combat operations.

3. Material

a. A high state of material combat readiness exists. There are no serious deficiencies affecting material readiness under the manning level. Outstanding requisitions are listed in enclosure (2).

1. a. Personnel. The First Composite Radio Company is authorized a manning level of one hundred per cent T/O (10 officers, 152 enlisted USMC, and 2 enlisted, USN). The present strength of the company is 10 officers and 150 enlisted USMC. One (1) enlisted USN is assigned for temporary additional duty in excess of 30 days.

(1) The assignment of the HMI on a HEAD basis to the company is not considered satisfactory. He should be assigned on a regular tour basis as are other personnel in order to preclude a change of Corpsmen every 4 to 6 months. The problem of security clearance is an additional militating factor against assignment on a temporary basis.

(2) For planning purposes, it is pointed out that 33 members of this command in the rank of E-4 and below (approximately 25 percent of T/O) are scheduled to rotate in the fourth quarter FY 61. As yet, there is no indication of replacements being ordered to the command by CMC and it is most advantageous to have Security Clearance and special training completed on such personnel prior to their reporting for duty.

b. Training. During the major portion of the quarter reported on all operational elements of the company (augmented by headquarters support personnel) were deployed from the Hawaiian area on training and/or operational missions. Personnel remaining in Hawaii continued OJT to improve combat readiness and conducted rifle and pistol qualification.

(1) Detachment "A" conducted forward area intelligence training/operations on Okinawa during the period 1 Oct - 11 Nov utilizing Naval Security Group Facilities at Futema. During this period, a special element of Detachment "A" was assigned to COMSEVENTHFLT for special operations in conjunction with their employment schedule.

(2) During the period 12-22 Nov, Detachment "A", augmented by electronics warfare, communication and marine augmentation personnel from NAVCOMMFAC, San Miguel, provided communication intelligence, communication countermeasures, and COMSEC support to PHIBLEX 43-60 (exercise PACKBOARD).

(3) Detachment "B" participated in PHIBLEX 42-60 (exercise PACK-MULE) and provided support (para (2) above) to Commander, Third Marine Expeditionary Brigade at Camp Pendleton during the period 24 Oct - 8 Nov.

(4) After completing specialized operational training (SOT) at the National Security Agency, Ft. Meade, Maryland, Detachment "C" conducted progressive forward area training in Korea utilizing facilities provided by the 508th USASA Group during the period 15 Oct - 1 Dec. This detachment was augmented by marine personnel from NAVSECGRUACTY, Kam Seye, Japan

(5) A provisional unit made up of personnel from Fly-Away Team's "A" and "B" supported the 4th Marines exercise at Kahuku, Hawaii as part of the current Troop Test Program.

(6) One (1) specialist was assigned to CINCPACFLT to meet special requirements during October.

(7) The unit language familiarization identification training program was continued this quarter. In this conjunction, tapes and instructional material were provided FMFPAC for use by the interrogator/translator team personnel.

c. Material. The continued lack of authorized major equipment items and the unsuitability of the equipment on hand constitutes the major difficulty in the command maintaining the most efficient combat readiness stature. The unsuitability of the equipment on hand was substantiated by a technical representative of the National Security Agency during a recent visit to this command.

(1) These deficiencies should be corrected upon receipt of the special communication shelters scheduled to be air shipped from MCSC, Albany Georgia, on 19 January 1961 (CNO 302121Z Dec and CG AIRFMFPAC 101853Z Jan refer); and the Craig Halo-Lift huts which will be ready for acceptance at the contractor's plant 30 January 1961 (CNO 221533Z Dec refers).

d. Summary. The capability of First Composite Radio Company (augmented by personnel to fill critical billets) to provide tactical support to DIV/WING sized units is considered adequate. Capability to support force level operations for an extended period meets minimum requirements.

a. Personnel. Lack of linguists (MOS 3631), as reported previously, is the major personnel deficiency. Of the six authorized, three (2 Russian, 1 Chinese) are on board with a fourth expected the latter part of this month. In order for this unit to perform its training mission in support of contingency plans, a minimum of two linguists, skilled in each language of the target areas involved, is essential.

b. Training. The major training deficiency listed is due to lack of adequate intercept and direction finding equipment.
