I AM ANXIOUS THAT ALL OF OUR PEOPLE ARE MADE FULLY AWARE OF THEIR OBLIGATIONS, UNDER THE GENEVA CONVENTION, AS TO THE TREATMENT OF PRISONERS. THIS POINT ACQUIRES PARTICULAR IMPORTANCE NOW THAT THE FLOW OF REPLACEMENTS WILL BRING YOU A LARGE GROUP OF NEW AND UNINITIATED PEOPLE EACH MONTH.
