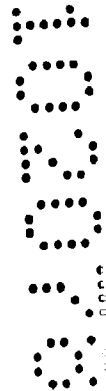

PART IINARRATIVE SUMMARY1. INTRODUCTION

a. General. General Leonard F. CHAPMAN, Jr., Commandant of the Marine Corps, visited the III Marine Amphibious Force from 15-17 January 1971. Upon his arrival in the Republic of Vietnam, General CHAPMAN was greeted by: Lieutenant General Hoang Xuan LAM, Commanding General, I Corps; Lieutenant General James W. SUTHERLAND, Jr., Commanding General, XXIV Corps; Lieutenant General Donn J. ROBERTSON, Commanding General, III Marine Amphibious Force; Brigadier General LEE Dong Yong, Commanding General, 2nd ROK Marine Corps Brigade. All III Marine Amphibious Force General Officers were also present. Other distinguished visitors to the III Marine Amphibious Force during the month of January included the Honorable J. W. WARNER, Under Secretary of the Navy and Lieutenant General W. K. JONES, Commanding General, Fleet Marine Force, Pacific. During January 1971, Headquarters, III Marine Amphibious Force was located at Camp Haskins, Northwest Da Nang, Quang Nam Province, Republic of Vietnam. The average Marine/Navy strength in Military Region One was 25,490, a decrease of 245 personnel from the previous month.

b. Activities. III Marine Amphibious Force activities were guided by COMUSMACV directive 10-11, dated 5 April 1970, and I ARVN/FWMAF MR-1 Combined Fall Winter Campaign Plan, dated 8 September 1970, in pursuit of its objectives for January 1971.

2. OVERALL EVALUATION

a. Incidents of enemy initiated activity throughout the III Marine Amphibious Force TAOI increased slightly during the month. However, these activities continued to be dominated by widely scattered harassing fires. Both the New Year's Truce period and the Tet Lunar New Year Truce period passed without the enemy launching any significant attacks on allied positions. There were no significant changes in the enemy order of battle in Quang Nam Province. Enemy strength decreased from 11,665 to 10,466 due to heavy losses in local force units.

b. In addition to normal small unit operations, there were three major named operations continued or initiated during the month of January 1971. Operation "IMPERIAL LAKE" continued from the previous month and remained under the operational control of 5th Marines (-) (REIN). During January, this operation accounted for 55 enemy killed and 30 weapons captured. Marine casualties in this operation were again reduced during the month. There were no Marines killed and 16 were wounded. Operation "HOANG DIEU 101", which began on 17 December 1970, terminated on 19 January 1971. This saturation operation, which involved joint US/ARVN participation, resulted in 83 enemy killed and 12 weapons captured by Marine units during the month. Two Marines were killed and 37 wounded while participating in this operation. Operation "UPSHUR STREAM" was begun on 11 January under the operational control of 1st Battalion, 1st Marines (-) (REIN). This was a category III Operation designed

PART IIISEQUENTIAL LISTING OF SIGNIFICANT EVENTS DURING JANUARY 19711. SUMMARY OF OPERATIONS

a. GENERAL. During the month of January, two major named operations were continued from the previous month and one major named operation was commenced by Marine units in Quang Nam province of Military Region One. Operations "IMPERIAL LAKE" and "HOANG DIEU LOI" were continued from December 1970 and operation "UPSHUR STREAM" was begun. Results are listed below:

b. EVENTS. During the month of January 1971 the following significant events were reported:

During the New Year's Truce period, which lasted from 1800 on 31 December 1970 until 1800 on 1 January 1971, there were a total of 16 major truce violations and 6 minor truce violations in MR-1. In Quang Nam Province there were two major violations, resulting in two friendly wounded and one enemy killed. There were two minor violations reported in Quang Nam Province:

At 040230H, CUPP Team 5, Company "G", 2nd Battalion, 5th Marines, located within their platoon CP 2 miles southwest of BALDY Combat Base, received an undetermined number of RPG and mortar rounds, which resulted in 5 Marines and 8 PF's wounded. In addition to the incoming, an unknown number of sappers reached the perimeter and cut into the perimeter wire. The CUPP Team, supported by a flare ship and gunships, returned small arms fire. An inspection of the perimeter area revealed numerous blood trails. Enemy losses were not known.

At 050728H, Marine artillery, responding to a request from a Marine Liaison Team, fired in support of the 197th PF platoon which was in contact with a platoon sized enemy force 5/2 Km north of BALDY Combat Base. A subsequent search of the area disclosed 4 VC killed by artillery and 2 killed by small arms fire. Two AK-47's were captured.

At 081000H, four VN males, one with an AK-47, surrendered to the Chieu Hoi program at the CP of CUPP Team 10, Company "G", 2nd Battalion, 5th Marines. The Hoi Chanhs were sent to Moc Bai District Headquarters for questioning.

At 081000H, Recon Team "WAGE EAENER", while on patrol 3 Kms north of FSB HYDER in the Que Son Mountains, observed 4 enemy moving along a trail. An ambush was set and the enemy were engaged with small arms fire, resulting in 3 VC killed. As the team moved in to search the contact area, it came under fire from 4 enemy armed with M-16's. The team then broke contact, moved to an LZ, and was extracted under fire. There were no friendly casualties.

At 100915H, during a sweep operation, a Marine from CUPP Team 10, Company "G", 2nd Battalion, 5th Marines, detonated a 60mm mortar round set as a surprise firing device. Two Marines were wounded and required evacuation. A command helicopter carrying the Executive Officer of 2nd Battalion, 5th Marines and the Company Commander of Company "E", 2nd Battalion, 5th Marines, landed to effect the evacuation. The Executive Officer and Company Commander deplaned and, while enroute to the casualties, detonated another surprise firing device, killing the Company Commander and wounding the Battalion Executive Officer and one RF. All of the wounded were evacuated to the 5th Marines Regimental Aid Station where the Battalion Executive Officer later died of wounds.

At 110020H, an ambush from Company "D", 1st Battalion, 1st Marines, initiated small arms fire on 3 VC in a boat moving along the Yen River 2 Kms northwest of Hill 55. Illumination revealed 3 VC bodies and an overturned boat on the opposite bank of the river. The bodies were not recovered because of the river.

At 110730H, a patrol from CAP 2-7-10, located 6 Kms northwest of Dien Ban, initiated small arms fire on 5 VC. The enemy returned fire and then fled. A sweep of the area revealed 2 VC killed. Six M-26 grenades and assorted propaganda documents were captured. During the contact one RF was wounded and later evacuated.

At 120120H, while on patrol, CUPP team 6, Company "G", 2nd Battalion, 5th Marines, observed approximately 20 enemy set in an ambush position. The CUPP Team set up a hasty defense and were then probed by 4 enemy. The enemy were engaged with small arms fire and M-26 grenades, killing two enemy. A Black Hammer was requested and arrived on station at 0135. Supported by the Black Hammer, the CUPP Team again engaged the enemy with small arms fire. At about 0355 the enemy broke contact and fled. A search of the area disclosed 7 VC killed by small arms fire and 9 VC killed by air.

At 130530H, a Forward Observer at OP ROUNDUP, with the use of an IOD, observed approximately 20 enemy carrying weapons 4 Kms west of his position. An artillery fire mission was called, resulting in 5 VC killed and five secondary explosions observed.

At 141400H, a platoon from Company "K", 3rd Battalion, 1st Marines, while on a sweep operation, found an enemy base camp consisting of 6 bunkers. A search of the camp uncovered 24 individual weapons, a large assortment of cooking utensils, 2 sewing machines, various medical supplies, 100 pounds of rice, and miscellaneous documents. In addition, one grave containing 1 VC body was discovered.

At 161300H, one VC surrendered under the Chieu Hoi program to CUPP Team 10, Company "G", 2nd Battalion, 5th Marines. The Hoi Chanh stated he was a rice carrier and directed the unit to a cache containing 2000 pounds of unpolished rice. The rice was distributed to the local populace.

At 182045H, CAP 2-7-2, while set in ambush, initiated small arms fire on 10 VC. The VC returned fire and fled. A sweep of the area disclosed 4 VC killed. Three individual weapons, 6 M-26 grenades, and 6 chicom grenades were captured. During the contact, 2 Marines, 1 Corpsman and 1 Kit Carson Scout were wounded; all required evacuation.

At 192130H, CUPP Team 6, Company "G", 2nd Battalion, 5th Marines, while in defensive positions 3 Kms northwest of BALDY Combat Base, received small arms fire from an unknown size enemy force located 200 meters west of their position. The team returned fire with small arms and called a Black Hammer on station which employed on board ordnance. Under illumination provided by a flareship, a search of the area was conducted which disclosed 12 enemy killed.

At 201100H, the point man of a platoon from Company "B", 1st Battalion, 1st Marines, while on patrol 5 Kms northwest of Hill 52, detonated a surprise firing device made from a can filled with C-4 and rigged with a pressure type firing mechanism. Four Marines were wounded. While setting up security for a MEDEVAC Helicopter, a Marine in the rear of the unit detonated a similar firing device which resulted in four more Marines wounded. Then the rotor wash from the MEDEVAC helicopter detonated 4 additional unknown type surprise firing devices which resulted in three additional Marines wounded. Total casualties were 11 wounded.

At 211330H, a squad from Company "B", 1st Battalion, 5th Marines, while on patrol 2½ Kms southwest of OP RAINBOW, found an enemy base camp consisting of 5 bunkers and 3 huts. A search of the camp produced 6 AK-47's, 3 AK-50's, 75 pounds of rice, assorted small arms ammunition, and explosives. The camp was destroyed and the weapons sent to BALDY Combat Base.

At 211530H, a CH-46D from HMM-364, while flying a troop insert mission 5 Kms northwest of Hill 52, crashed due to enemy action. The aircraft, which carried a crew of 4 and 18 passengers, was observed making a left bank on its final approach to the LZ when it crashed and burned. Elements of Company "B", 1st Battalion, 1st Marines, arrived at the scene, assisted in the extraction of personnel from the aircraft, called a MEDEVAC, and secured the crash site. At 1600 the MEDEVAC was completed. Total casualties were 5 killed and seventeen injured.

At 222210H, elements of CUPP team 6, Company "G", 2nd Battalion, 5th Marines, while in a defensive position 3 Kms west of BALDY Combat Base, received twelve 60mm mortar rounds, chicom grenades, and small arms fire from approximately 15 enemy. Supported by a Black Hammer, the Team returned fire with small arms. A sweep, conducted under artillery illumination, disclosed 1 VC killed. Then, as the Team was returning from the sweep of the contact area, it received 15 more mortar rounds, M-79 fire, and small arms fire from approximately 10 VC located to the Team's west. Again, supported by a Black Hammer which employed on board ordnance, the Team engaged the enemy causing them to break contact and flee. A sweep was conducted under illumination provided by a flareship. The sweep discovered 3 VC killed by air, and 4 killed by small arms fire. A total of 8 VC were killed in the engagement. There were no friendly casualties.

At 231200H, a mine dog on patrol 7 Kms northwest of BALDY Combat Base with CUPP Team 10, Company "G", 2nd Battalion, 5th Marines, discovered six surprise firing devices all rigged with pressure type firing mechanisms. The devices were 10 meters apart and were made from 60mm mortar rounds, chicom grenades, M-79 rounds, and 105 rounds. All devices were destroyed in place.

At 240840H, the same mine dog mentioned above, while working with CUPP Team 10, Company "G", 2nd Battalion, 5th Marines, on a search operation 6 Kms north northwest of BALDY Combat Base, detonated a 105 round set as a surprise firing device. The explosion killed both the dog and the handler. At 0845, while the Team was transporting the casualty to a MEDEVAC helicopter, a second explosion of unknown origin occurred, killing another Marine and a mine dog. In addition, 6 Marines, one RF and one PF were wounded.

At 251525H, a platoon from Company "L", 3rd Battalion, 5th Marines, while on patrol 2½ Kms north northeast of Hill 218, heard voices to the south of its position. While searching the area, the platoon observed and initiated small arms fire on approximately 10 enemy carrying packs and weapons and wearing green uniforms. The enemy returned fire and then broke contact. A subsequent search of the area revealed 9 NVA killed and 3 individual weapons captured.

There were 28 major truce violations and 18 minor truce violations reported throughout Military Region One during the TET Truce period, 1800 26 Jan 1971 - 1800 27 Jan 1971. In Quang Nam Province there were 7 major violations, resulting in 1 friendly killed, 2 wounded, 4 abducted and one missing. There were 8 minor violations. There were 8 enemy killed during the truce period.

At 271820H, a Forward Observer on OP Roundup, with the use of an IOD, observed approximately 20 enemy carrying packs and weapons and moving into a treeline 3½ Kms northwest of Roundup. An artillery fire mission was called, resulting in 7 VC killed.

4. PERSONNEL**a. Special Services Activities****(1) Freedom Hill Recreation Center**

(a) Theater: The 35mm Indoor Theater was operational 22½ days during the month of January with an average daily attendance of 265.

(b) Bowling Center: The Bowling Center was operational 22½ days during the month with an average of 385 games bowled daily.

(c) Library: The Freedom Hill Library was operational 22½ days during the month with a total attendance of 211.

(2) Stars and Stripes: During the month of January, 196,408 issues of Stars and Stripes newspapers were distributed to III MAF personnel. The noted increase in the distribution was due to an overprint by the Stars & Stripes on 10 Jan 71 issue, resulting in a double issue for III MAF on that day.

(3) R&R Activities (Out-of-Country): The total number of seats allotted to III MAF for the month of January 1971 was 1628. The number allotted for Okinawa R&R was 168. The MACV percentage of aircraft utilization for January is not available at this time. For update information, the December 1970 aircraft utilization figure was 98.7%.

(4) In-Country R&R: The total China Beach In-Country R&R allocation for the month was 8 officer quotas, of which 5 were used, and 220 enlisted quotas, of which 116 were used.

(5) Special Services Hong Kong flight: Two round-trip Special Services Hong Kong flights were made utilizing 88 spaces.

SECRET5. Intelligence

a. General Enemy Situation. During the first half of January, the level of enemy activity remained light. Enemy initiated incidents were centered primarily in the vicinity of Combat Base Baldy. The enemy spent the early part of the month in preparation for the Lunar New Year, or Tet highpoint, which was to signify the beginning of the enemy's K-800 Campaign. Captured enemy documents, agent reports, and interrogation of prisoners of war captured during this period indicated that the enemy's strategy immediately prior to the K-800 Campaign would be two-fold. First, the enemy would engage Allied forces if they entered his base camps and threatened the security of his food and munitions caches, rather than attempting to evade as he has done in the past. Second, the enemy would continue to attack small units and lightly defended Allied outposts, particularly in the lowlands, in an effort to convince the people that the VC were winning the war. Operation Imperial Lake maintained pressure on the enemy base camps and restricted his movement of supplies and personnel between these base camps in the Que Son Mountains and his operating areas in the lowlands. Other intelligence sources indicated rebuilding of local force units by replacing killed or captured district unit personnel with hamlet and village guerrillas. This practice was contrary to previously stated intentions of upgrading the combat effectiveness and overall strength of guerrilla forces. However, recent losses probably forced this change of policy.

After more than three months of preparations and successive postponements, enemy units mustered sufficient strength and supplies to launch a coordinated highpoint throughout Quang Nam Province on the night of 31 January and the early morning of 1 February.

b. Significant Contacts During The Period (See Part III, Para 1b)

(1) On 9 January, nine kilometers southwest of hill 55 (AT 8735 60), the 21st Ranger Group contacted an unknown size enemy force resulting in 21 enemy KIA, the capture of one VC (female nurse) and five individual weapons (two .45 caliber pistols, one M-16 rifle and two AK-47). A search of the bodies identified the KIAs as elements of the C-70 and Q-83 units. The search also revealed that the Q-83 commander was killed in the contact. There was one friendly WIA.

(2) On 14 January, the 21st Ranger Battalion, while searching 12½ kilometers southwest of Landing Zone Yuma (AT 893545), contacted an unknown size enemy force resulting in nine VC KIA, nine detainees and one AK-47 captured. There were no friendly casualties.

(3) On 31 January, an unknown size enemy force detonated a mechanical ambush three and one half kilometers southeast of Thuong Duc District Headquarters (ZC 152502). A 79th RBD element returned small arms fire and called artillery. Results were one friendly WIA, nine enemy KIA, four AK-47 and two B-40 rocket launchers captured.

(4) On 31 January, the Golden Gate Bridge (AT 965606) was partially destroyed by explosive charges that severed several pilings just above the waterline. Damage was estimated at 50%.

d. Enemy Order of Battle. There were no significant changes in the enemy order of battle during the month of January. However, the D3 NVA Infantry Battalion remained unlocated, leading to supposition that it may have disbanded. Late in the month, the R20th and V25th Main Force Infantry Battalions left their base camp in the Que Son Mountains and returned to the lowlands in Dien Ban and Duy Xuyen Districts, respectively, in preparation for the K-800 Campaign. Total enemy strength decreased to 10,466, due chiefly to losses in local force units, which were substantiated this month. Administrative service strength decreased to 3,545. Guerrilla strength decreased to 3,518.

e. Counterintelligence

(1) Monthly Overview. Contrary to an anticipated increase in VC/VCI counterintelligence related activity during the Tet holidays, there was no significant change in total number of incidents. However, there was a marked increase in kidnappings. On 26 January, 30 teenage civilians were kidnapped from the An Thanh Hamlet (AT 888478). This incident brought the total to 41 civilians abducted during the month. These incidents were further evidence of the enemy's manpower shortage and an indication of one means to alleviate it. The persons abducted will probably be employed as laborers for the K-800 Campaign. It is also possible that the teenagers will be ~~incorporated~~ into the guerrilla or local force ranks.

(2) Terrorism and Propaganda. Terrorist activity within the III MAF Area of Operations consisted of eleven isolated incidents during the month of January. The number of KIA and WIA resulting from terrorist activity remained at a low level in comparison with previous months. At the request of Vietnamese residents of Duc Ky (H) (AT 986622), A CUPP Team inspected the hamlet to find three homes destroyed by explosive charges and three additional homes with TNT charges emplaced for detonation. (a) There was one incident involving the assassination of one GVN official and one incident in which three GVN officials were wounded.

(b) Propaganda incidents included two occasions in which leaflets were distributed and one occasion which involved an oral broadcast requesting the local villagers to rally to the NLF. The general theme of the printed leaflets called for a Christmas, New Year, and TET Truce and ~~condemned~~ the U. S. and FVMAF for violating truce periods.

(3) Subversion. No incidents of subversion were known to have occurred during the month.

(4) Sabotage. On 31 January 1971, the enemy employed a different tactic in sabotaging the Golden Gate Bridge (AT 965604), causing 50% destruction. The explosive charge appeared to have been placed above the waterline, since several pilings were sheared off above the water, and no water spout was observed by the guards in the area at the time of detonation.

(5) Espionage. There were no reported incidents of espionage during the month. However, it can be reasonably assumed that the VC/VCI will maintain a continuing intelligence collection effort within the III MAF Area of Operations for the purpose of identifying prospective targets.

6. LOGISTICS

a. General. Major planning conferences highlighted activities involving G-4 staff and cognizant staff sections during January. Phasedown and redeployment of III Marine Amphibious Force from Vietnam was a major topic at the CINCPAC Movement/Planning Conference, held in Hawaii, the Seventh Fleet Fourth Quarter FY-71 Planning and Scheduling Conference, held at Baguio, Republic of the Philippines, and the Fleet Marine Force, WestPac Logistics Conference, held on Okinawa. The first two conferences confirmed amphibious shipping commitments for the movement of Marine units and equipment during Keystone Robin Charlie, and III MAF representatives were also able to stress the urgent requirement for opportune amphibious shipping to move retrograde cargo of the Force Logistic Command from Vietnam. In the Okinawa conference, firm guidance was established regarding supply procedures incident to phasedown of III MAF units; the general exchange of ideas and recommendations provided III MAF attendees the basis for completing redeployment planning. Also during the month of January, a major effort was made to identify and secure authority to release III MAF Butler buildings for shipment out-of-country. These structures are critically needed by Fleet Marine Force Western Pacific commands at Subic Bay, Republic of the Philippines, Iwakuni, Japan, and on Okinawa. By month's end, agreement had been reached with the Commanding General, XXIV Corps firmly establishing those structures regarded as excess to the needs of the various armed forces in Military Region 1. Consequently, approval for their shipment out of Vietnam was requested from Commander, U.S. Military Assistance Command, Vietnam. It was anticipated a favorable reply from COMUSMACV would be forthcoming by early February 1971.

b. G-4

(1) Redistribution Program

(a) The computerized system for redistribution action became functional during January 1971. All past history of redistribution transactions was coded and key punched resulting in the first accurate evaluation of the program to date. It was found that past figures based upon estimates of items redistributed were lower than the items actually redistributed. Computer accumulation of statistical data established that redistribution instructions

have been issued for 177,880 excess items since inception of the program through 31 January 1971. This figure is higher than previous estimates.

(b) Project 805, transfer of equipment to the Republic of Vietnam Armed Forces, continued to produce a rate of acceptances through January, remaining at 92% of items offered. Only 78 items were redistributed to the Vietnamese, however, bringing total acceptances to 8,654 since inception of the program in June 1970. It is anticipated that as Keystone Robin Charlie redeployments increase, total transfer of items to the Republic of Vietnam Armed Forces will show a sharp upswing.

(2) Real Estate/Facilities

(a) No Marine Corps facilities were transferred during the month of January, however, the Monkey Mountain Facility (MACS-4) was accepted for transfer by the U.S. Navy as soon as the Marine unit departed the site. Transfer date was scheduled for 1 February 1971.

(b) The redeployment of units during Keystone Robin Charlie will necessitate the transfer of sixteen pieces of property to either U.S. Army, Air Force, Navy, or Republic of Vietnam Forces. (3) Airlifts

(a) Marine intra-Republic of Vietnam passenger airlifts rose from 48,956 during December to 52,848 during January 1971 - an increase of 3,528. Total Marine cargo lifted dropped from 4,022 short tons during December to 3,983 short tons during January - a decrease of 39 short tons.

(b) Over 270 short tons of fuel were dispensed by Marine Corps KC-130 aircraft during in-flight refueling missions,

(c) Personnel flown out of the Republic of Vietnam in connection with permanent change of station orders totalled 3,144 - an increase of 1077 over the previous month.

(4) Ordinance

(a) Phasedown of III MAF forces has caused close coordination between this headquarters and the U.S. Army, Vietnam regarding ammunition responsibilities and requirements. It is currently planned that the U.S. Army will take over the complete support of III MAF ground ammunition requirements on 15 March 1971. As part of the eventual takeover, USARV assumed responsibility for requisitioning III MAF ground ammunition, providing suspension notification, and replacing suspended unserviceable stocks of ground ammunition on 1 January 1971. Additionally, the Army was provided with data, consisting of sixty-five ground ammunition items, which would insure support of U.S. Marine Corps and Republic of Korea Marine Corps forces until the U.S. Army assumes responsibility for our ground ammunition support on 15 March. The data provided for 30 days of common service ground ammunition to be on hand for transfer to USARV on the turnover date,

(b) Third quarter inspections of Marine Corps ammunition supply points were carried out at Combat Base Baldy, Marine Aircraft Group - 11 Bomb Dump, and ASP #2 during January.

c. Embarkation Summary. Development, promulgation, and confirmation of Keystone Robin Charlie shipping requirements were accomplished during two major conferences in January. Early in the month redeployment planning was undertaken at the CINCPAC Movement Planning Conference at CINCPAC Headquarters, Hawaii. At month's end, finalization of Redeployment Increment VI embarkation planning was accomplished. Throughout both conferences full utilization of all shipping for Force Logistic Command retrograde cargo was stressed.

d. Engineer Summary

(1) During the month of January, road maintenance responsibilities in Military Region 1 were reassigned by the Commanding General, XXIV Corps which caused an increase of III MAF responsibilities from 32.2 to 34.7 miles of roadway; this includes portions of HL-540, HL-542, ML-1C, ML-1D, ML-6, ML-8, and ML-12W. Major effort in maintenance of roads was placed on the upgrade of LTL-4 West and approximately 1,300 meters were completed during the month.

(2) The electrical upgrade of the 1st Marine Division ridgeline perimeter lights, Combat Base Baldy, Fire Support Base Ross, and Hill 65 Cantonment was completed during January. Additional electrical repairs were completed at Force Logistic Command and Combined Action Group areas.

(3) Force engineers continued to support Mobile Construction Battalion - 3, furnishing M-51 dump trucks which hauled 3,760 cubic yards of rock, 3,541 cubic yards of fill, and 60 cubic yards of asphalt for upgrading of LTL-4 East.

(4) Marine engineers repaired one bridge damaged by enemy action during January by replacing a span.

(5) During January, a major effort was completed by the dismantling of Sector A of Hill 327 Cantonment. The material salvaged from this effort was used in the maintenance of other areas in the III MAF area of operations.

(6) Electrical and plumbing repairs were made on the Hoa Khanh Children's Hospital, located at Force Logistic Command.
