NARRATIVE SUMMARY

The First Engineer Battalion minus "B" Company (-) (Rein), was in general support of the First Marine Division in the DaNang TAOR. Letter Companies reinforced by elements of Headquarters and Service and Support Companies were moderately committed to combat support missions during this period while simultaneously accomplishing various types of construction and maintaining their respective routine road sweeps. The Battalion (-) also supported numerous small unit operations: rough rider convoys, county fair operations, and swept a total of 1,597,100 meters of roads in the DaNang TAOR. "B" Company (-) (Rein) was in direct support of the fifth Marine Regiment for Operation UNION and UNION II.

Execution: The four engineers in support of "B" Company blew eight family bunkers and six large reinforced bunkers in the village of Phong Ha. they used four 40 pound shape charges and eighty pounds of C4. The two engineers with "A" Co blew two family bunkers at 072616 with five pounds of C4 each and one reinforced bunker at 071616 with ten pounds of C4. At BT 071416 they blew one house with ten pounds of C4. At BT 076615 and 075616 they blew one 105 round with 2½ pounds of C4.
11. Results: Ten family bunkers destroyed, 7 large reinforced bunkers destroyed, 1 House destroyed, and two 105 rounds (duds) were destroyed.

14. Commanders Analysis: A routine search and destroy operation. Engineers were used very well. The only problem was that the 1/1 S-3 did not clear it with us beforehand.

8. Mission: Provide close combat engineer support to 1st Battalion, 11th Marines to enable "A" Battery, 11th Marines to move to Thang Binh and return. Also provide engineer support for resupply convoy.
9. Concept of Operation: One SNCO and nine men with 200lbs of demolitions, two mine detectors, hand tools and demolition sets left this C.P. at 131307 H May67 and joined up with the convoy at 1/1 at 131545 H May67. From there they proceeded to Thang Binh. The team consisted of nine men from 2nd Platoon "A" Company, 1st Engineer Battalion.
10. Exection: The sweep team departed 1/1 C.P. at 131615 H May67 for Thang Binh. The sweep team found one 20lb box mine at Coor 134472 and blew mine in place. Just prior to finding mine, convoy took one incoming 60mm round. at Coor 123485. Convoy could not make Thang Binh that night, set up camp at Coor 150455, broke camp at 140630 H May67 and proceeded to Thang Binh. Arrived Thang Binh at 141200 H May67 and proceeded to string concertina wire around battery position. Finished stringing wire at 141530 H May67. Engineers were assigned perimeter guard at night. At 151530 H May67 left Thang Binh to pick up escort resupply convey. Picked them up at Coor BT 072550 and returned to Thang Binh without incident. On 160600 H May67 left Thang Binh to pick up and escort resupply convey. Received small arms fire possible M-79 or 60mm at end of convoy at Coor BT 075530. Unloaded at Thang Binh, empty trucks and two M-51's returned to DaNang. Operation secured on 17May67. Departed Thang Binh at 171500 H May67, came upon mined area at grid sq. 1248, convoy Commander would not take time to blow mines and used rice paddy as bypass and continued on. All units were transported by 3rd Antrack Battalion to coordinates AT 828858 from coordinates AT 822899 where the Battalion CP was set up the first night.

On May 20, 1967 all units were briefed by LtCol ROWLEY. Two teams of engineers were dispatched, one to A Co 1/7 and one team to B Co 1/7, these teams consisted of 4 men each. One team of 3 men was also sent to M Co 3/7. SSgt J. COUCH and five men swept the road from Coordinates AT 828858 to coordinates AT 892925 for the Antracks who were to remove an M-54 truck which had been damaged by a VC mine in an area on 19 May 1967 which had not been cleared by an engineer team.

On May 21st four engineers were returned to the company area because of heat exhaustion. Five (5) engineer replacements were heli lifted to the engineers from 1st Platoon CP at coordinates AT 621972.

The Battalion was relocated on 22 May to coordinates 822899 where it remained, running patrols from that position.

A truce was adhered to on 23 May 1967 in observance of Buddha's birthday. During the day of 23 May 1967, the engineers cleared an area for two (2) LZ's at coordinates 131846 and 135843. A total of 1600 pounds of C-4 was used to clear the two (2) LZ's.

11. Results. No men were lost as a result of KIA or WIA, but 4 men were evacuated because of heat exhaustion. The size of each LZ is approximately 120 feet long and 60 feet wide. A total of 1600 pounds of C-4 explosive was used to clear the two (2) Landing Zones.

12. Administrative Remarks. Resupply of engineers items and all other items was adequate.

13. Special equipment and techniques- None

14. Commanders analysis. The area encountered on 21 May as listed in this report was the first time that it had been thoroughly scouted. The engineers team successfully established two (2) LZ's and made the area more easily available for future operations.

15. Recommendations. It is recommended that Landing Zones in this area be checked, as the situation permits, before landing helicopters to determine if the zone is booby trapped or mined.
