PART II

NARRATIVE SUMMARY

During the month of April 1969, the 1st Engineer Battalion remained committed to combat engineer support missions while simultaneously completing 45 Division and 26 Battalion Work Orders and other engineer projects while maintaining assigned mine detection and clearing sweeps.

Combat engineer companies, reinforced by elements of Headquarters and Service Company and Engineer Support Company provided close combat engineer support in Operations OKLAHOMA HILLS and Project WOODPECKER V.

During the reporting period, 1,768,000 meters of road in the 1st Marine Division TAOR were swept for mines. Mine sweeps of roads resulted in 22 mines/boobytraps being located and destroyed. In addition to daily mine detection and clearing sweeps, 30 rough rider convoys were supported by combat engineers of this Battalion. Also, 60 special sweeps were conducted during the reporting period.

Company "A" is providing close combat engineer support to the 21st and 37th ARVN Ranger Battalions on Project WOODPECKER V which commenced on 30 March 1969. At present, Company "A" maintained six daily mine detection and clearing sweeps in the 1st Marine Regiment TAOR. Company "A" was heavily committed to bunker constructed and cantonment repairs within the 1st Marine Division TAOR, specified by Division Work Orders.

Company "B" provided close combat engineer support for the 5th Marine Regiment. In addition to routine demolition work, Company "B" also continued bunker construction and cantonment improvements for the 5th Marines and 2d Battalion, 11th Marines at the An Hoa combat base. Two daily mine detection and clearing sweeps were maintained by Company "B".

Company "C" is currently providing close combat engineer support for elements of the 7th Marines on Operation OKLAHOMA HILLS which commenced on 31 March 1969. Included in this support are special sweep teams which sweep Route 4 from Hill 65 to Hill 52. Other support consists of combat engineer support in construction of fire support bases, Landing Zone clearing and land clearing as outlined in Operations OKLAHOMA HILLS.

Six daily mine detection and clearing sweeps were continued by Company "C" during the reporting period. This company also provided general support in the form of construction and cantonment repairs, for units of the 1st Marine Division.

a. Road and Bridge Reconnaissance. During the month of April 1969, procedures whereby mine sweep teams submit daily reports of road, bridge, and culvert conditions for routes being maintained were continued.

4. Operations

a. Operation OKLAHOMA HILLS. Operation OKLAHOMA HILLS commenced on 31 March 1969 with Company "C", reinforced by elements of Support Company and one squad from Company "B" are in support of the 7th Marine Regiment. In addition, one platoon (-) from Company "A" is in support of 3d Battalion, 1st Marines on the operation. Included in this support are two mine sweep teams which clear Route 4 between Hill 65 and Hill 52. A total of 284,000 meters of road were swept by these teams during the reporting period. In addition, 58,000 square meters of land has been cleared along Route 4. Four fire support bases have been completed plus one fire support base is at 50 percent completion and three landing zones have been constructed by engineers of this battalion since the beginning of the operation. Enemy installations destroyed were, 132 bunkers, 133 fighting holes, 52 spider traps, 3853 lineal yards of trenchline and 194 lineal yards of tunnel were destroyed. b. Project WOODPECKER V. Project WOODPECKER V commenced on 30 March 1969 and continues at the present time. Company "A" is providing one platoon (-) and Support Company is providing one squad in direct support of the 21st and 37th ARVN Ranger Battalion. A total of 4,482,000 square meters of land have been cleared to date. In addition, 307 bunkers, 209 fighting holes and 130 spider traps have been cleared and destroyed. c. A purchase of \$100.00 worth of text books and school supplies was issued to the school at Son Thuy I.

8. Psychological Operations. One Psyops movie was shown in the village of Son Thuy I, with a response of approximately 70 villagers.

9. Religious Affairs. Four Sunday Catholic Masses and four Sunday Protestant Divine services were held at the 1st Engineer Battalion Memorial Chapel during the month of April 1969 at 1030 and 0915 respectively. In addition, one Memorial Service was conducted for a deceased member of this battalion.
