Throughout August the 1st Engineer Battalion continued in support of the 1st Marine Division and other III MAF Units with mine clearance teams, construction of combat defensive fortifications and fire support base improvements. An average of 25 combat engineers were employed in demolition teams rendering close combat engineer support to the 1st, 5th, and 7th Marine Regiments on platoon and company size operations. Seventeen engineer road sweep teams conducted sweeps over 2,439 Km. of road resulting in the detection and destruction of 7 items of enemy emplaced ordnance. The counter mine program was further enhanced by the application of the Voluntary Information Program. 37 ordnance items were recovered while expending 5,050 piastres.

Fire Support Bases McNutt and Scimitar were constructed as part of a series of joint operations with CIDG and ARVN Forces. Both bases are out of the division TAOR and support was coordinated with Quang Da Special Zone.

On the Fire Support Base McNutt complex 6 combat engineers utilizing (1) Case 450 tractor constructed six (6) 105 Howitzer positions and two (2) ammo berms. A total of 120 man hours and 16 equipment hours were utilized over a period of two days.

In the construction of the Fire Support Base Scimitar project, five (5) combat engineers utilizing (1) Case 450 tractor constructed four 155 Howitzers positions utilizing 150 man hours and 24 equipment hours over a period of three (3) days.

The 1st Marine Division Land Mine Warfare School conducted by the 1st Engineer Battalion was closed to outside units 1 August 1970 by Division Schools. However, the school remained open to instruct 1st Engineer Battalion personnel. A total of 126 students graduated from the school during the reporting period. 90 personnel from 3rd Battalion, 5th Marines were instructed by a mobile contact team during a two day course in Demolition and Counter SFD Tactics.

General Engineer Support was provided in the form of 76 Completed Division Work Orders and the production of 13,408,000 gallons of potable water.

On the 27th of August 1970 Col. BLUE, the 1st Marine Division G-4 and Col. CHANG FANG NANG of the Republic of China Marine Corps visited the 1st Engineer Battalion. They received a Staff Orientation briefing of the operations of the 1st Engineer Battalion.

Eighteen (18) 1st Engineer Battalion personnel continued in the upgrading of the bunkers and drainage system at FSB Ryder in preparation for the up coming monsoon season. A new trash chute was constructed and 3,850 gallons of pentaprine was spread over the entire FSB Ryder complex. Eight (8) bunkers were rehabilitated during the reporting period. A total of 2090 man hours were expended in the completion of these projects.

Four (4) combat engineers were inserted on the Hill 270 Fire Support Base (AT865680) on 30 August 1970 to rehabilitate the existing bunkers and the internal drainage system. During the reporting period the engineers initiated the complete rehabilitation of the COC bunker.

Company "C", 1st Shore Party Battalion continues to operate 15 Landing Zones throughout the 1st Marine Division TAOR. 4,484 tons of supplies and 17,188 passengers were moved utilizing 2,356 helicopter sorties.

In support of the Battalions engineer operations a daily average of 32 Organic Motor Vehicles traveled a total of 80,265 miles within the 1st Marine Divisions TAOR.

During the reporting period the Commanding Officer and selected Staff Officers visited each of the Battalion's Regimental areas and job sites on a weekly basis to gain first hand knowledge and progress and problem areas.

2. Intelligence Summary Month of August 1970

a. During the month of August enemy activity remained at a relatively low level with (1740) enemy sightings reported by 1st Marine Division units. The majority of the activity was in the 7th Marines AO. There were (87) enemy initiated contacts, the two most significant of which were a 122 mm rocket attack against the An Hoa Combat Base and a mortar attack against the Hill 34 Complex. The remainder of the enemy incidents were harassing in nature. Heightened points of activity were on 19 August commemorating the anniversary of the Viet Minh Revolution and on 30 August the day of the Vietnamese National Senate Elections. Enemy efforts were directed toward terrorism and propagandizing on these two dates. In summary, the enemy did not have the capability to initiate any large scale coordinated attacks but smaller harassing operations such as mortar and rocket attacks and sapper activity was prevalent. Primary targets for the ground activity remained to be CAP, CUPP, PF, and RF units.

3. Mine Warfare

a. During the month of August, 1st Engineer Battalion road sweep teams paid 5,050 \$VN from Voluntary Informant Program funds for the following 37 ordnance items.
