## PART III

## SIGNIFICANT EVENTS

1. Enemy Action

On 22 April 1969, a civilian truck was damaged by a RPG type weapon at AT937905 which is on the road a mile below "A" Battery.

On 24 April 1969, "A" Battery reported that elements of the 7th Engineers removed six claymore type mines from the roadway north of Hai Van and just north of the "A" Battery site.

On 25 April 1969, AFU "E" reported that one enemy round impacted on Finger 3 of the hill they are on-Hill 55. There is no positive report on just what type round it was. There was no damage to AFU "E".

On 29 April 1969, "A" Battery reported that two Marines from 6/2/26 were wounded from sniper fire at AT93829228 near "A" Battery.

During the month of April, bunkers along the road on the way to "A" Battery-Highway One, which is guarded by units of the 26th Marines, received light sniperfire.

During the month of April there were several rocket attacks launched by the enemy against the DaNang area; however, these attacks had no effect upon H&S Battery.

2. Casualties

Pvt. G. BOWAN, 2254781, was evacuated to USNH Guam for severe headaches.

Pvt. L. MISCHIARA, 2355767, was evacuated to NH ST. Albans for Inf. Hepatitis.

### 3. Civic Action

a. Twenty-five bags of cement were given for the construction of a well which was completed on 15 April 1969.

b. In addition to the Twenty-five bags of cement given last month, five pieces of second-hand tim and fifteen 2" by 4"s were presented for the reconstruction of a Spirit House adjacent to a sub-hamlet's cemetery.

c. On 26 April 1969, a ceremony and dinner were held and the contributions of civic action were listed on a poster at the entrance.

#### 4. Air Defense

a. The Battalion had 38 targets during 19 AAEX's. Of this total 33 or 86.8% were successfully engaged.

b. Three Unknowns occurred during the month of April.

c. There were no HAWK runs during the month of April.

## 5. Ground Defense

a. "A" Battery's ground defense effort consisted of putting in three layers of Barb Tape and constructing a tactical fence around "A" Launcher point. Post one and nine were reconstructed using 55 gallon drums and matting. Three reconnaissance-security patrols were conducted this month from "A" Battery.

b. At present, "B" Battery's ground defense capabilities are being revised. On 29 April 1969, a ground defense drill was conducted.

c. "C" Battery put in additional concertina around parts of the Battery perimeter. The burning and cutting of grass continued throughout the month. A 30 foot tower was emplaced on a knoll outside the Battery perimeter which was considered a good position but due to recommendations from Wing and Group, Ground Defense Officers, it is felt the tower should be moved inside the perimeter wire.

d. H&S Battery made no changes affecting the unit's defensive positions during the month of April.

e. AFU "E" made no changes affecting the unit's defensive positions during the month of April.

## 6. Training

a. "A" Battery conducted three hours of GMS. In addition, two hours of gas mask drill was held.

b. "B" Battery conducted two hours of GMS and sixteen hours of Technical training.

c. "C" Battery conducted four hours of GMS and fourteen hours of Technical training. In addition, two hours of Special Task Team training was also conducted.

d. H&S Battery conducted four hours of GMS and forty-four hours of Technical training. One hour of gas mask drill was also conducted.

e. AFU "E" conducted four hours of GMS and twenty-three hours of Technical training. In addition, three hours of Special Task Team training was conducted.

#### 7. Logistics

a. On 10 April 1969, WSM received five (5) loader-transporters from CONUS.

b. On 12 April 1969, WSM received six (6) HAWK missile launchers from CONUS. On the same date eight (8) 400HZ, and Two, (2) 60HZ generators returned from rebuild. Five (5) AN/MPQ-33 were removed from the system to prepare them for shipment to CONUS.

c. On 12 April 1969, an FMFPAC Inspecting Team inspected WSM and Engineering Section.

d. On 26 April 1969, two (2) AN/TSW-2, and four (4) loader-transporters were evacuated to CONUS.

e. On 29 April 1969, two (2) AN/TSW-2, and one (1) loader-transporter were evacuated to CONUS.

f. On 30 April 1969, a Systems Maintenance Officers meeting was held at the WSM building.

#### 8. Supply

A data processing program for an excess review was completed and tested this month. The excess run will be made next month and it is anticipated that 3000 line items will be dropped from stock as excess.

The FMFPAC Inspection Team visited supply during April.

d. During the month of April, Battalion Supply received 683 requests from using units not including clothing and Ser-Mart items. Of this number, 489 issues were made from stock creating a gross effectiveness of 72%. There were 39 requisitions, for items not previously held in stock, which accounted for a net effectiveness of 76%.

9. Motor Transport

a. The total amount of vehicle mileage for the month of April was 57,737.

b. The total number of passengers carried for the month of April was 18,622.

c. The total tonnage transferred for the month of April was 3,353.

10. Military Construction and Camp Improvement

a. On 9 April 1969, "A" Company, 7th Engineers began leveling a site for the new mess hall at "A" Battery. "A" Battery also started construction on a new AN/MPQ-35 shelter on 10 April 1969.

b. "B" Battery reported nothing significant was done in this area during the month of April.

c. At "C" Battery a 3000 gallon water tank was placed on 55 gallon oil drums to provide gravity water flow for the messhall. A large reefer was disassembled and placed on 4 x 4's to allow easier cleaning, better sanitation and prolong reefer life. All buildings at "C" Battery with the exception of the 49 shack and Missile Test Shop were wiped out by the explosions from ASP-1. Work is being started to rebuild the entire camp. Assistance is being obtained from the Sea Bees in rebuilding the messhall, and communications buildings.

d. H&S Battery reported that nothing significant was done in this area during the month with the exception that AFU "E" personnel have completed the move into ASRT "C" living areas which were recently rebuilt and cleaned up. All buildings at AFU "E" were painted and awnings have been installed. AFU "E" has also widened and re-sand-bagged the old revetment around their LPIR.

## 11. Operations

a. Emphasis is still being placed on the use of the Automatic Fire Distribution System (AFDS) for AMEX's. AFDS is used when equipment status permits.

b. Operation Center #4 has been moved back to the old area due to change in Battalion's displacement date for use with AMEX's. Operation Center #2 is in the process of being march-ordered to Barstow. Operation Center #2's air conditioner will be march ordered with the van.

c. Primary power unit for UPS-1, the PU-344, was released to Comm 1 April 1969. The TXQ-16 was taken down and packed for storage in anticipation of the move to MACG-18 area.

## 12. Communications

a. Radio Section. During the month of April radio section had ten (10) MRC-83's down (8NORS/2TRANSIENT) and two (2) TRC-75's down awaiting parts-Couplers. On 13 April 1969, radio section had a FMFPAC inspection. They received a satisfactory with minor discrepancies. All embarkation was brought up to date. During the month operators were sent to different batteries with MRC-83's to set up a practice net to ensure proficiency in their MOS.

b. Maintenance. During the month of April, 173 work orders were received. Of these 113 were completed, 17 were awaiting parts and 4 are at higher echelon repair facilities. Thirty-nine (39) are still awaiting work. Necessary preventive maintenance was performed within the tech shop on incoming gear. A team toured the batteries performing 2nd and 3rd echelon on about half of the total gear. Thirty (30) pieces of gear were sent to the calibration facility for maintenance.

c. Radio Relay. During the month of April, radio relay has been plagued with numerous equipment failures. Fifteen (15) RT-252's are currently on work orders for repair. This situation has caused all batteries to operate without proper backup equipment, and at times do not operate at all. All equipment on hand is old, and has been used for several years continuously, a major factor in excessive failure and downtime. All required, as well as all needed preventive maintenance has been performed for April.

d. Message Center. During the month of April, 389 incoming messages were received and processed by this command. Of these, 104 were classified requiring special routing. This command originated 82 outgoing messages which were in a large part due to the FMFPAC inspection that occurred the 13th of April. The message center reproduction machine filled 23 work orders for a total of 6,990 copies before it's breakdown. During the month of April the communications SOP was revised, approved, reproduced, and distributed. All required reports were submitted on time with the addition of a KY28/38 report which required that all of the KY-38 gear be inventoried.

e. Wire. During the month of April, eleven (11) lines were checked and/or repaired for various reasons. An additional phone was installed at the motor transport maintenance shop. The terminal box leading to the OC van was removed and the cable spliced together so that the terminal box may be used when wiring the new area.
