COMMANDER'S NARRATIVE SUMMARY OF EVENTS

The first half of March was spent in preparation for deployment to RVN. The largest problem was in the procurement of needed supplies and equipment. Most needs were met, but at the last possible moment, causing embarkation to be more difficult than desired.

The battalion sailed from Okinawa on 16 March aboard the USS TALLADEGA (APA-208) with the Medical Battalion Commander as CO of troops. Arrived off Chu Lai, RVN on 20 March. Debarkation was rapid and without significant events.

On 21 March casualties began arriving from Operation TEXAS. The number was significant, (100) but the newly arrived personnel joined with those already here to effect a smooth and skillful processing.

On 22 March, Lieutenant General WALT visited the Medical Battalion and promised more support to enable the hospital to increase it's bed space to 180. This was done temporarily thru the erection of General Purpose tents. Holding policy was simultaneously increased to 15 days.

DETAILED DESCRIPTION OF SIGNIFICANT EVENTS

3Mar66 - Reference (a) directed movement to ChuLai, RVN

15Mar66 - Commence loading USS TALLADEGA (APA-208) (Vehicles loaded aboard USS SEMINOLE)
It is noted that this was the first unit to embark from TENGAN Pier.

16Mar66 - Loading completed in record time (for APA's, according to USS TALLADEGA). Loading time: ^{less than} 12 hours.
Sailed from Buckner Bay.

20Mar66 - Smooth voyage. Ship's crew was most cooperative and helpful.
Arrived off Chu Lai and commenced unloading.

21Mar66 - Unloading completed.
Joined with Company "B", 3rd Medical Battalion, in support of Operation TEXAS.

22Mar66 - Visited by Lieutenant General WALT, Commanding General, III MAF.
Battalion Commander to DaNang to discuss cantonment requirements for Medical Battalion with III MAF Surgeon.

23Mar66 - Battalion Commander returned from DaNang.

27Mar66 - In accordance with reference (b), Company "D" embarked aboard USS SNOHOMISH COUNTY (LST-836) for movement to DaNang. Upon arrival redesignated as Company "B", 3rd Medical Battalion.
Company "B", 3rd Medical Battalion (at ChuLai) simultaneously redesignated Company "D", 1st Medical Battalion

28Mar66 - In support of Operation INDIANA.

29Mar66 - OpCon chopped to 1st Marine Division at 1500 (reference (c)).

30Mar66 - Type of mission assigned necessitated transferring all personnel (with a few exceptions) into H&S Company. (reference (d)).
