COMMANDER'S NARRATIVE SUMMARY OF EVENTS

On 27 May Co. "B" arrived, placing the full Battalion in operation in this area for the first time.

Shock and Resuscitation Team #1 was again deployed, this time for operation "Montgomery". While they again did not have a heavy casualty load, the benefits accruing were the same as in last month's report. It seems apparent that the mission, location and support requirements can be established, though they would probably require modification once experience with heavy casualty loads has occurred. A total of 119 patients were seen, including 56 who were returned directly to full or light duty by the S&R Team.


