PART II

NARRATIVE SUMMARY

1. During the period covered by this report, the command has been employed in support of U.S. and Allied Forces in the Danang and Chu Lai TACOR's.

a. In the 1st Medical Battalion work is progressing in the self improvement program. The work on the (2) two quonset huts housing two Operating Rooms and additional Intensive Care Unit, was delayed because of lack of materials for the drainage system. The current estimated completion date of this work is 20 July 1967. The X-ray building was completed and in operation on 17 June 1967. The 20X72 ward was completed and operational on 1 June 1967. A clearing platoon C-7 was employed at the 2/5 C.P. in support of operation Arizona, during the period 14 to 23 June 1967. During the period of 7 to 15 June 1967 an exchange of one orthopedist and one anesthesiologist was made with the Naval Hospital Ship USS Repose (AH-16). This exchange has fostered a better understanding of the total medical care facilities in support of the Division by both this command and the hospital ship. Orthopedists LCDR MULLINS and LCDR GIBSON and LCDR FENNING donated several hours of their off duty time to assist with the care of the patients at USAM Hospital. This assistance is expected to continue with increasing conditions. An overhead wire distribution system has been started. During the month 39 huts were wired. The remainder of the cantonment is expected to be rewired by 15 July 1967. A cement washrack has been built in the Battalion motor pool. The psychiatry department compiled monologue was distributed to all Battalion Surgeons within this division and to the medical officers of all other units from which we have received psychiatric consultations.

b. During the month of June three (3) Wards were completed and on 28 June 1967 1st Hospital Company (Rein) became a 160 bed facility. Additionally the CSR, Auto Clave building and eleven (11) living quarters were completed. The butler building for Motor Transport is nearing completion. Construction began on a new Chapel. The self help program continues. There is fresh water plumbing to all wards. The construction of a shower unit for company personnel has begun. The generator shed now has cement paving. The laboratory has the capability to perform blood chemistry, electrolyte and enzyme studies. On 5 June 1967 MUST-1 became attached to 1st Hospital Company with the mission to evaluate its capabilities to act as a C & C Company in the field.
