

NARRATIVE SUMMARY

1. During the month of June the 1st Medical Battalion continued to operate a 185 bed hospital at Phu Bai RVN. All elements were with the parent unit except the 1st Platoon of Delta Co. and 14 men of the Preventive Medicine section who are OP Con to First Hospital Co. at Danang.

Electrical and water problems encountered during the month of June have not recurred and the hospital is operating smoothly. The census has slacked somewhat from Mays average of 129 to 96.

Eight members of the Battalion were recommended for the Vietnam-ese Cross of Gallantry (3 with silver and 5 with bronze).
