~~8-2 INTELLIGENCE~~NARRATIVE SUMMARY

1. During the month of May 116 detainees were apprehended. There were fifteen nine (59) people with improper I.D., thirty one (31) illegal residents, four (4) deserters or Draft Dodgers and thirteen (13) people in an unauthorized area, all of whom were turned over to local authorities. Nine (9) VCS were picked up, three (3) of which were turned over to National Police in Hoa Vang District Headquarters. The other six (6) were detained in III MAF brig and questioned by 5th CIT since they have all been VC or VC sympathizers at one time. No determination has been made on these people.
2. Many reports were received concerning attempts on the Air Base during the Vietnamese Labor Day (1 May) Ho Chi Minh's birthday (19 May) and Buddha's birthday (23 May). Nothing happened during those critical periods. The possibility of an attack, especially an attack by fire is still high. The VC have been defeated in every attempt and they are in dire need of a success.
3. The I Corps Bridge which crosses the Song Han has been mentioned in many low level reports. An unconfirmed report was received by III MAF that a VC Sapper platoon had assembled in Danang with the mission of destroying the bridge. The security for the bridge was increased.

8-3 OPERATIONS/TRAINING

1. During the month this battalion conducted 90 Day and 124 Night fire team patrols, 492 Day and 836 Night squad patrols, 60 ambushes and set out 143 listening posts for a total of 1745 small unit actions during the month with no significant contacts.
2. Normal training was conducted consisting of at least six (6) hours per week of GMST classes and weekly weapons safety classes.
3. Two reaction drills were held in accordance with operation order 102-67 (Defense of I Corps POW Compound). Drills were marginally satisfactory. Revisions are being made to Bn. Operation Order 102-67 in order to improve reaction time and coordination of supporting arms.
4. Completed Air Base Defense Model problem for Lockheed Missile and Space Corps. Problem was completed on 19 May and forwarded on 20 May.
5. Attended Air Base Defense Seminars at FLC and at III MAF.
6. Normal staff functions were performed without significant problems.

S-4 LOGISTICS

1. During the month of May the two (2) cat walks on the I Corps Bridge were repaired and a pontoon foot bridge was constructed under the new bridge. One (1) additional 9.5 horsepower outboard motor was obtained on temporary loan for use by the bridge patrol boat.
2. Bunker kits were provided for C40 P. Also three (3) work requests for renovation of building, construction of new building and additional fortifications for C40 were initiated during the past months.
3. Supply. Shortage of parts for the M-109 and M-422 continues to be a problem.
4. Motor Transport. A maintenance supply contact team conducted an inspection/evaluation of the Motor Transport maintenance section. Upon completion of the inspection recommendations were made and instruction was given by the team in an effort to assist the section.

S-5 CIVIL AFFAIRS

1. General.

- a. There were no substantial changes in the civic action program of the 1st MP Battalion during the month of May.
- b. On 20 May two (2) Vietnamese Nationals were shot numerous times with a BB gun while walking to work north of the Air Base. The BB gun was fired by a Marine from this command.
 - (1) A condolence visit was paid to each victim.
 - (2) Solatium was paid to each victim.
 - (3) The matter has been turned over to the Battalion Legal Officer.
- c. On the 6th of May a battalion photo trip was taken in Hoa Quong Village south of the air base. Approximately fifty Marines attended. It was an interesting experience and was coordinated through the Village Officials. The trip included many different stops (a school, the village headquarters, a home with altar, an old pagoda with courtyard, market place, graveyard). The trip was well received and interest was expressed in more. A trip through the large textile factory south of the air base is being planned for June.
- d. On the morning of 16 May a civil affairs team under the guidance of this office assisted the screening team during a sweep of a hamlet near NSA. (See Pay Ops).

e. Liaison was initiated with other military units to consider the possibility of a Civic Action Council for Hoa Tho. This will be continued during June.

f. The Civil Affairs Office, with assistance from the S-4 prepared a request for building materials to use in bringing the Combined Action Platoons living quarters to an acceptable standard. The idea is that the materials can be justified as civic action since they will become the property of the local governments upon the end of the war or displacement of the CAP.

g. A written justification of the Civil Affairs Section was submitted for a change in the battalion's T/O.

h. A Buddhist Temple was given one truck load of scrap lumber to help them in the celebration of Buddha's Birthday. This is one of the temples which allowed us to take pictures on the photo trip.

i. The Civil Affairs Officer, with help from SSgt. FINN of "A" Co., is conducting a Vietnam Assignment Survey of the battalion for III MAF Personal Response Officer.

2. Education.

a. Although the schools are presently in the midst of Summer vacation, the battalion is still teaching nine (9) English classes. This testifies to the interest in these programs.

b. The battalion has been supporting a self-help project in Ap Ba Hamlet, Hoa Cuong Village for the construction of a school.

(1) Numerous meetings with local officials concerning the project have been held.

(2) There has been complete cooperation on the part of the local populace.

(3) Four (4) copies (two in English and two in Vietnamese) of the Project Submittal Sheet plus an additional endorsement by the hamlet and village chief have been turned in to Hoa Vang District for approval and action. To date, however, nothing has been heard.

(4) There is a definite need for cement, tin, and some iron for this project.

c. Bravo Company has been assisting a self-help project of the rebuilding of a school in their TAOR near the Naval Hospital.

d. CAP F-2 has painted and constructed benches for a school in Phu Loc II. In addition they are assisting the Mayor of Danang and an RD Cadre in the building of one school in Phu Loc I.

e. Preliminary work has begun on the scholarship program sponsored by the Marine Corps Civic Action Fund.

f. Alpha Company and Golf CAC assisted in the painting of three (3) schools.

g. Delta Company has continued the physical education classes at the Binh Khue Cam elementary school. Games and exercises are taught.

3. Public Health.

a. Sick call was held at each CAP daily. 16,700 treatments were administered by battalion Corpsmen during the month.

b. Health posters were obtained for posting throughout the TAOR.

c. During the sweep of 16 May a Corpsman was present to treat the Vietnamese as they were taken to the collection point.

d. A detailed Health Education Program is being started by Bravo Co. in the hamlet of Son Thuy.

e. The battalion continued to provide MEDEVAC facilities for Vietnamese within the TAOR who required such.

f. Health movies are being shown at all Psy Ops movie festivals.

4. Public Works.

a. CAC G aided Vietnamese in the construction of two bridges in Danang East.

b. Schools were painted and self-help projects were supported.

c. CAP's F-7 and F-3 continued work on experimental garden plots. These projects are being supported by this office.

d. CAP F-5 was given assistance in obtaining building materials for PF living quarters compound buildings.

e. CAP F-4 constructed latrines for Hoa Phat School.

f. CAP G-2 constructed flag pole at My Khe Village Headquarters.

g. Studies have been started on possible locations and equipment for a playground.

5. Welfare.

a. Soap and clothing were distributed by the CAP's on an "as - needed" basis.

b. CAP M-6 supplied a family with building materials to include lumber and cement to help in the reconstruction of his home which was ravaged by fire.

c. Two refugee families in Ap Mot were supplied with scrap lumber.

d. The PF's of CAP G-5 were supplied with one bag of rice per week. These PF's are working under special conditions which necessitate this allowance.

6. Civic Action Training.

a. The Civil Affairs Officer gave a "grass roots" civil affairs lecture for the III MAF Civic Action Orientation Course. The course was given twice during the month of May. Henceforth it will be given once a quarter.

b. Office routine and office procedure SOP's were written for the Civil Affairs Section.

c. The revised Civil Affairs SOP was written and is in the process of being readied for distribution.

d. The monthly meeting for Company Civil Affairs Officers was conducted on the 10th of May.

PSYCHOLOGICAL OPERATIONS

1. During the month of May PayOps movie festivals were held at fourteen different locations throughout our TAOR.

a. Approximately 10,000 people are directly reached by these programs.

b. The Audio/Visual team is furnished by 244th PayOps Co.

c. Security and coordination is effected by CAP's.

d. These programs are being coordinated through the Vietnamese Information Service. (VIS).

(1) The programs for June were scheduled by the VIS agencies in our TAOR.

(2) VIS speakers were present and gave speeches between reels.

e. Tu Do newspapers and Chieu Hoi pamphlets were passed out at each movie.

f. Posters and leaflets were obtained to be used by CAP's in announcing PayOps movies.

2. On 16 May a sweep was held of Da Me hamlet (053737) by battalion personnel.

a. As the people were collected, Psy Ops magazines and newspapers were distributed.

b. Support was given by the 244th PsyOps Company to include tape recorders with music, loudspeakers, and a Hoi Chanh.

(1) The Hoi Chanh was particularly effective mixing and talking to the people. When the sweep was concluded, he gave a speech about the VC and propaganda leaflets which were found.

3. Posters were obtained from the 244th PsyOps Company commemorating Buddha's birthday. These were received two days before the holiday, therefore the posting was rushed.

4. On the 19th of May the Psy Ops Officer met with VIS agents from Hoa Vang and Ngaio. Discussion was held as to how we could assist them and they supplied us with the movie schedules for June. Some Vietnamese books and magazines were supplied to them for distribution.

5. On 15 and 16 May the clerk from battalion operations attended the Psy Ops school at 244th Psy Ops Company.

6. On 23 May the GySgt from CAC G met with the VIS agent from Dong Giang District to schedule movies and talk.

7. On 31 May the Psy Ops Officer attended the III MAF Psy Ops Conference.



2 MAY 1967

a. At 021030H a patrol from CAC G-5 apprehended eight (8) detainees (1 male and 7 females) at coord. BT 057728. These personnel were gathered in a group in a rice paddy. Three of the women had no ID cards. The other four (4) women and one (1) man had ID cards from another district. All were taken to Hoa Vang District HQ's. Eight (8) detainees.

b. At 021305H Gen. Walt's chase plane (a UH-1E) crashed on the helipad at coord. BT 058777. Personnel from CAC G-2 were dispatched to the scene to keep the area under control and assist in any way possible. The H&S Co., III MAF reaction force assisted in keeping the local populace under control. There were no casualties and no civilian property was damaged.

c. At 021830H a B Co. post at BT 060855 observed a VN boat landing on the beach at approx. coord. BT 057875. A swift boat patrol was called and several warning shots were fired. The boat shoved off and got away before the swift boat arrived. The area was checked by a patrol on 3 May with neg. results.

4 MAY 1967

a. From 042100H to 042300H a sweep was held by CAC GOLF, PF's and National Police in Nia Hien Dong Village coords. (BT 041796) to (BT 039806). 1 deserter and 7 illegal residents were apprehended. 8 detainees. All were taken to Danang Garrison.

5 MAY 1967

a. At 052015 an alert for MSG was sounded by S-3. At 052035 MSG arrived at S-3 with 42 men. At 052035 S-3 alerted Maint. Bn. which arrived at 052055 with 42 men. At 052100 the alert was secured.

b. At 051330H May a VN civilian was reported to be selling C rations and cement at BT 020732 from an NSA truck. A patrol was dispatched which apprehended the VN & turned him over to Natl. Police. NSA was notified; they picked up the truck & sent an investigator. The VN escaped but his ID card & trip ticket were turned over to Hoa Vang Dist. HQ's.

6 MAY 1967

a. At 061130H B Co. apprehended 13 detainees (11 females, 2 males) for being in an unauthorized area (BT 063825). The detainees were turned over to VN A. F. authorities.

b. At approx. 062300H USAF personnel from 366th Air Police Sqdn. and USA personnel from the 37th Signal Battalion reported hearing a large explosion from the area of GS 0275. Patrols checked the area with neg. results.

9 MAY 1967

a. From 090330H to 090700H a sweep of Nai Nam Village, coord. BT 038 755, was conducted by Marines, PF's, and Natl Police. Three (3) detainees were apprehended, two (2) females and one (1) male. The male was identified as a draft dodger or deserter. One (1) female was identified by Natl Police as a VC the other as her sister. Dtrses taken to Natl Police HQ's.

12 MAY 1967

a. From 120400H-120700H Mar's from CAC G, PF's, QC's, and Natl Police conducted a sweep of An Hai Village in Dong Giang Dist. (BT 043764-BT 042 782) and the boats along the river near An My and An Vinh Hamlets. The search produced five (5) illegal residents, one(1) VCS, one (1) draft dodger, and one (1) deserter. These dtnees were taken to Dong Giang Dist. HQ's. Eight (8) dtnees.

13 MAY 1967

a. At approx. 130200H a special patrol from CAC G apprehended thirty eight (38) dtnees at approx. coord. BT 059782 for having improper ID cards and being out after curfew. The dtnees were taken to Dong Giang Dist. HQ's. Thirty-eight (38) dtnees.

b. At 132015H a patrol from CAC G-2 apprehended 2 males and 2 females with improper ID cards at approx. coord. BT 058783. Dtnes taken to Dong Giang Dist. Hqtrs. for interrogation.

c. At 132130H a patrol from CAC G-2 apprehended 2 males with improper ID cards at approx. coord. BT 058783. Dtnes taken to Dong Giang Dist. Hqtrs. for interrogation.

d. From 132000H to 132345H B Co., CAC G-5, H&S Co. Reaction Plt., and Nat'l. Police held a sweep in area bounded by coords. BT 053736, BT 055736, BT 062727, and BT 061725. Five (5) dtnees taken to III MAF POW Compound. All are VCS and they're known to have helped VC in the past.

14 MAY 1967

a. At 140800 to 141000H, area bounded by coords. BT 053736, 055736, 062727, 061725, a search by G-5 with two (2) Dog Plt. in Khue Bao Hamlet was conducted. Two (2) Marines, PF's and Dogs searched area. Neg. results.

b. At 142015H, BT 058732, G-5, GA-36, pick up one (1) VCS in rice paddy. PF says he's a VC because his name is on black list.

c. At 142220H two (2) grenades observed detonating near moving vehicle at BT 012724. Patrol dispatched to check area with neg. results.

Reaction Platoon (reinforced), National Police, Scout Dog Teams, and a Combat Loud Speaker from 244th Psy War Co. conducted a house to house search of the area bounded by BT 053736, BT 055736, BT 062727, and BT 061725. Negative Results.

a. From 170400 to 171715, one sqd Marines from CAC-G, three pita. PF's, one sqd ARVN Naval Force, one sqd VN Air Police, one sqd. ARVN Air Force, conducted two sweeps on Monkey Mt. bounded by coord. 071854, 071859 to 091853, 087854 and 123842, 123839 to 129839. Negative results.

b. 87 CAC personnel schooled on M-16 by Air Force and fam fired on FLC Range.

a. At 181155, in the vic. of coord. BT 041765, a patrol from CAC G-2 apprehended 1 VN male with no ID card. Detainee was sent to Danang Garrison for questioning. Result: 1 detainee.

b. From 182200 to 182400 CAC-G, National Police, QG's and PF's conducted a sweep in Nian Hien Dong (V) and Nhueng Negia (V) from coords. BT 040805 to BT 048805. Apprehended 7 illegal residents, and 5 VN civilians with no ID cards. All detainees taken to Dong Gaing Dist. Hq. for questioning. Results 12 detainees.

19 MAY 1967

a. At 191510H, F-6 apprehended three Vietnamese at coord. BT 009720. Vietnamese were not of this area and did not have travel permits. Taken to Hoa Vang District Headquarters.

21 MAY 1967

a. At approx. 211100H Lt. Col. T. R. HILL relieved Lt. Col. P. G. STAVRIDIS as C.O., 1st MP Bn. at a formal change of command ceremony.

22 MAY 1967

a. 20 of the Bn. officers attended a 2 hour class on legal problems held by FLC Legal Office.

24 MAY 1967

a. At 242000H at grid coord. BT 028731, 125 rounds of .50 caliber ammunition were found in the Song Cau Do River. Surveillance was maintained throughout the night. A search of the river was made at daybreak.

25 MAY 1967

a. From 252200H to 252345H CAC G, QC's, National Police, and additional PF's from Dong Gaing District conducted a sweep in An Thuong (H), An Hai (V). c. At 261905, AT 993748, a patrol from D Co. detained five (5) uniformed VN having incorrect identification. One (1) was armed with carbine, one (1) M-26 Frag, and 120 rounds. They were questioned and one (1) determined to be a member of CAP F-4, remainder turned over to Hoa Vang District HQ's. The remaining four (4) were members of PF Platoon in Phong Bao (Vic. coord. AT 998712).

d. "Jailbreak" practice alert held for defense of PW Compound. At 261405H received a call from B switch, at 261407H, notified 3rd Bn, 1st Marines and requested clearance for artillery. At 261422H B Co. was in position and at 261429H 1st Tanks was in position. At 261435H the alert was secured.

29 MAY 1967

a. At 290830H a sweep by B Co. in East Danang (BT 065712) picked up one (1) dtnee as being a VC messenger who obtained information on patrolling in East Danang. Dtnee taken to III MAF Brig. One (1) dtnee.

b. Twenty (20) of the 1st MP Bn officers attended a two (2) hour class on legal problems given by FLC legal office.

30 MAY 1967

a. At 301230H B Co., at check point (BT 059742) apprehended one (1) VN female for improper ID. The dtnee was taken to Hoa Vang Dist. HQ's.

31 MAY 1967

a. At 311750H Bravo Co. apprehended one (1) VN male for improper identification. The dtnee was apprehended at approx. coord. PT 058742 and taken to Hoa Vang Dist. Hq's.
