PART II

NARRATIVE SUMMARY

1. (S) October was marked by the withdrawal, stand down and redeployment of the major tactical elements of the 3rd Marine Division. Corresponding readjustments were necessitated in Operations Company. In the beginning of the period, the test of the Balloon-borne Low to Medium HF and VHF System was conducted. The results of this test were favorable in most respects, the VHF portion being considered the most noteworthy. Certain system limitations evidenced themselves, most notably in the HF component, after attempting several field expedients with varying degrees of success, recommendations were submitted for the improvement of the HF Antenna. Germane associated system limitations bear further investigation and are presently under consideration; among these were balloon night navigational hazard markings and tether illumination. Six days after the conclusion of the test, loss of the balloon occurred due to the parting of the tether, when it rapidly ascended to approximately five thousand feet. Due to the increase in pressure density and the resultant over-pressurization, the balloon burst. In the ensuing recovery operation, all of the antennae and pre-amplifier equipments were recovered. Throughout the month, there were many periods when atmospherics adversely affected radio communications for varying lengths of time; however, they were not as severe, intense or prolonged as those which occurred in September. Early in October, the First Platoon worked on a new operations bunker which was completed and preparations have been made for the move next month. The new bunker is situated adjacently to the S-2 in the 5th Marines Command Post and will facilitate the passing of timely special intelligence in support of the Regimental Commander. Due to the redeployment of the 3rd Marine Division, the 1st Radio Battalion foresaw the movement of U. S. Army Units northward in Northern I Corps. In an attempt to assist Army Direct Support SIGINT units in becoming familiar with the role of SIGINT in that Zone of Action, III MAF proposed the forming of a Joint Tactical Processing Center (JTPC) at Dong Ha. The Army units welcomed the opportunity and by the end of the month, Army Direct Support Units had phased 9 personnel in with the Operations Company at Dong Ha. In the event of further Marine Corps redeployments the Army Units would have trained personnel that are familiar with the SIGINT problems for utilization in Northern I Corps. The JTPC is under the direct control of Operations Company, 1st Radio Battalion. The Center is located in the 3rd Platoon Operations Bunker and is the second of its type under Marine Command. The JTPC was established to provide initially, semi-processed SIGINT Support to a resident Army Representative, who in turn passed this information to attached Army DSUs with elements of the 101st Airborne Division. The 101st was conducting a screening operation in support of the 3rd Marine Division's withdrawal. SIGINT support assumed a major role in keeping Tactical Commanders apprised of enemy locations and disposition of forces during this most vulnerable period. During the middle of the reporting period both Army analytic and collection personnel were infused into the JTPC and at outlying sites. Due to the redefined boundaries and perimeter of Dong Ha Combat Base, Operations Company closed their command post and quarters area and relocated to the 3rd Platoon Area.

This collocation required dismantling, removal and rebuilding of several structures to accomodate the additional personnel in the 3rd Platoon Area. Throughout this reporting period, considerable progress was made in the improvement of existing structures and facilities along with minor construction accomplished in three of the Battalion's areas. With the cessation of major friendly offensive operations and the level of combat reduced throughout I Corps Tactical Zone, all platoons continued in-place general support of III Marine Amphibious Force. The 1st Platoon provided direct SIGINT support to the Commanding Officer, 5th Marines. A detachment of the Sixth Platoon provided support to the Commanding Officer, 7th Marines. The Sixth Platoon itself, provided direct SIGINT support to the Commanding Officer, 1st Marines.

2. (C) A significant decrease in the total hours of Transmission Security Monitoring is reported for this reporting period. The total is 54 percent of last month's total which is attributal to the closing of 4th Platoon and the resultant loss of its two Transec Posits and the relocation of 2nd Platoon's Transec Posit to 6th Platoon. The move was necessitated because of other operational commitments. The total number of hours monitored for the period was 579.5 Hours. The total number of violations was 27 percent of last month's total, the overall number was 98 violations. Spot Reports increased by 50 percent with a total of 41 reports issued. Aggregate losses in total reported statistics can be anticipated to remain approximately half of the previously reported totals due to the redeployment of the 3rd Marine Division. One Transec Orientation Lecture was conducted for the Officers and SNCOs of Headquarters, 26th Marines.

3. (S) A decrease in enemy activity was reflected in the number of direction finding fixes over last month's total. Total Direction Finding Fixes for the month of October were: 3058 and further broken down as follows: Airborne Direction Finding, 2873 and Short Range Direction Finding, 185. Of these totals, 597 of the fixes were identified to entity. A total of ten fixes were taken under fire by artillery and results are unknown on all except one. This fix resulted in 15 rounds of 155mm being placed on the target and a subsequent search of the area revealed 3 bunkers destroyed and blood trails from the area. A reduction in the number of fixes acted upon is attributed to reduced enemy activity and the withdrawal of 3rd Marine Division Artillery Resources.

4. (U) During the reporting period, the Communication Section relocated and operated 14 circuits from 2 AN/TGC-37 Vans, a temporary shelter AN/TSQ-5 and the existing communication center. The relocation was a result of renovation in the spaces to accomodate the new equipments and the installation of same. Ten circuits were terminated in the AN/TGC-37 Vans, three in the communication center and one in the operations space. A message was initiated to the Director, Naval Security Group, Pacific, requesting continuation and substantiating the requirement for the Navy Communication Operator Augmentation Program.
