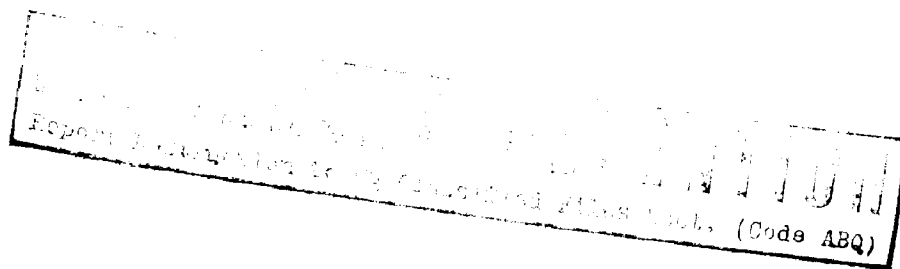

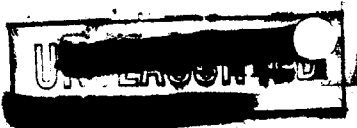

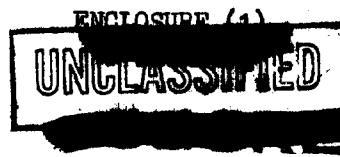
PART II

NARRATIVE SUMMARY

1. (S) The month of December was characterized by low levels of enemy activity at the beginning of the month and accelerating to a point where significant encounters were noted toward the middle and end of the month. In the North, the tactical situation remained fairly static with the Joint Tactical Processing Center, Operations Company and the subordinate platoons providing Signal Intelligence which was acted upon, primarily by artillery fire missions. Throughout the month, The Joint Tactical Processing Center issued sixty three Tactical Reports. With the further dispersal of tactical forces in Northern I Corps, continuing improvements to the defenses of the First Radio Battalion Installations progressed and were paramount next to the performance of the primary mission. Among the improvements recently added was the installation of sonic intrusion devices with the sensing pickups concealed in the ground beyond the perimeter wire. The other major improvement consisted of installation of 500/1000 Watt Floodlights to intermittently illuminate the perimeter wire. The roving sentry, at random intervals energizes the lights, observes and then switches them off. In addition to being highly effective, it will greatly reduce the number of parachute flares consumed during the course of a month. As previously reported, a Night Observation Device completes the surveillance measures. A program of Harassing and Interdiction Fire using the M-79 Grenade Launcher was also implemented during the month. Additional Grenade Launchers were requested and received.

Due to the changing disposition of forces and tactical areas of responsibility, a determination was made to close the Short Range Direction Finding Site at Charlie 1. In an effort to provide better siting for the Control Station at Dong Ha, the physical location of the DF Set was changed. This move also located the set away from possible sources of reactance. A system of shooting check bearings on a known located transmitter was instituted this month in an effort to improve SRDF Fix Accuracy. This will insure that all variances in the individual stations of the Northern Net are within the prescribed tolerances. On the basis of information passed from the JTPC and the SRDF Network, one of the fire missions ordered resulted in a large secondary explosion.

In the South, the effects of the rice denial operations began to outwardly evidence themselves. This was readily apparent from the enemy's communication pattern and from prisoners of war captured out of their normal foraging areas. Because of shortages in his life staple, he had to move out of his base camps to search for food. On the basis of intelligence provided by elements of First Radio Battalion, the enemy was successfully interdicted in several of his attempts to refurbish his dwindling supply of rice. There were indications that the enemy would become active along Route 540. In the ensuing ambushes set up on the basis of this information, 42 NVA were killed, 3 POWs taken and no U.S. casualties were sustained. The information was provided to the 1st Marines by 6th Platoon. In another action, on the basis of information

and additional intelligence provided by First Radio Battalion, a series of air strikes was called into an area on two successive days. Later, 80 enemy were observed fleeing from the area of the air strikes and were further interdicted by artillery fire. In another situation based on special intelligence information, it was correctly predicted that Mike Company, 3rd Battalion, 1st Marines would be attacked. The Company was subsequently attacked, but because they had been forewarned and were ready, they sustained no casualties. Three NVA KIA's and numerous blood trails were found in the area of a mortar barrage called in by Mike Company. Tactical activity increased and remained significant for the remainder of the month except for the Christmas and New Years Cease Fires. During the latter part of the month, a system of feedback messages from tactical commanders covering use, plans based upon and success of operations resulting from communication intelligence was initiated. Concurrently forthcoming operations or movements are made known to the cognizant Platoon(s) in order to assist in appropriate areas of emphasis and communication security tasking.


One Short Range Direction Finding Site was installed at the Command Post of 1st Battalion, 1st Marines and plans were made to activate another site early in the next reporting period. The permanent detachment at Fire Support Base Baldy continues to function well and was further increased in personnel with the assignment of an additional ARVN (Dancer) Linguist.

During the reporting period, serialized product reports were authorized for the Battalion by the Director, National Security Agency. By this authority, First Radio Battalion is now a recognized regular contributor in the Signal Intelligence Community to commands and intelligence units out of country.

Renovations in the various First Radio Battalion Unit Areas continued throughout the reporting period with primary attention given to those projects concerning security and defense in anticipation of increased enemy activity in the coming months. The Maintenance Contact Team concluded its circuit of the Battalion after completing and returning from Operations Company and subordinate platoons. The team visit/inspection of each area was most productive and the results most useful in establishing areas which require additional maintenance attention. The budget estimates for FY 70 and 71 were submitted. Plans for the Maintenance Facility were completed and will be retained at the China Beach Public Works Facility. The Maintenance Facility and the Motor Transport Hardstand have been cancelled. The Force Allowance Modification Report was updated to reflect the entire Battalion returning to Hawaii. The new Motor Transport Facilities were occupied during the month and thus far, have been far superior to those formerly used.

First Radio Battalion closed out 1969 as a most successful year with many lessons learned and experience gained in all corners of

 I Corps Tactical Zone. We face the new year with much resolve as there is yet, much to be done. In terms of accomplishments and the faith special intelligence has earned, it was a most successful year.

2. (C) During the month of December, an increase was realized in the total number of hours monitored by the Communication Security Section. This increase was 47.7 Hours over the previous month's total and was computed at 417.1 Hours for December. The total number of transmissions monitored and analyzed was 32,645, an increase of 6,994 from November's Total. Violations warranting issuance of a spot report numbered 89 for the month. Two Transmission Security Presentations were given during the month of December. The first was presented to MASS-3 and the other, to the Regimental Staff, 1st Marines.

3. (S) The relative increase in enemy activity was reflected in an increase in the number of Direction Finding Fixes obtained during the month of December. The total number was 3,825 or 809 more than last month. This total is broken down to indicate that 3,604 were derived from Airborne Radio Direction Finding and 221 Short Range Direction Finding Fixes. The total number of combined fixes used as the basis of fire missions were 242. Battle Damage Assessments were unavailable except that two of the fire missions resulted in large secondary explosions. The total number of fixes identified to area or entity numbered 1,035.

4. (U) The building expansion project in the Communication Center was completed on 12 December and was occupied on that date. The Tempest Hazard Inspection Team arrived on the 13th and completed their inspection of the Communication Equipment Installation on the 17th of December. There were no discrepancies noted in the Tempest Inspection therefore, the communication center and new equipments were accepted from the contractors on that date. The first message was transmitted at 161128H. The remaining circuits were established by 172200H. The Navy Communication Operator Augmentation Program continues in effect.
