PART II

NARRATIVE SUMMARY

1. (S) First Radio Battalion's platoons, deployed throughout the Southern I Corps Tactical Zone, continued their direct support to the regiments of the 1st Marine Division and general support to the whole of the III Marine Amphibious Force. The direct support role was highlighted by the timely provision of intelligence information which aided in the launching of successful helicopter-borne assault missions, fire missions, ambushes, counter-ambushes, and also provided warnings of impending attacks upon Marine and other friendly forces. The end result of the above actions has been not only the loss of equipment and personnel by the enemy, it has also denied him freedom of movement to his forward base areas and has prevented him from obtaining local provisions and supplies.

In the Northern I Corps Tactical Zone, the Joint Tactical Processing Center continued its successful provision of timely intelligence information to tactical commanders and the provision of general intelligence support to the III Marine Amphibious Force. During February, elements of the 407th Radio Research Detachment, USASA, relieved the 4th Platoon on Dong Ha Mountain and the 5th Platoon at Con Thien as the First Radio Battalion began phase-down operations in the north. With the withdrawal of the 4th and 5th Platoons, Marine SRDF and ARDF operations were also deactivated in the north. Plans for the deactivation of the JTAC and Operations Company and the assumption of their missions by elements of the 407th RRD continued through February. The AN/TSQ-88 continued its successful operation at Dong Ha and, with the imminent withdrawal and deactivation of Operations Company, plans were formulated to deploy the AN/TSQ-88 to a location in Southern ICTZ.

The search for suitable locations for the expansion of the SRDF Net within the 1st Marine Division TAOR continued throughout February. Such an expansion will facilitate more accurate fixing of targets for fire and Helicopter assault missions.

The last two weeks in February witnessed the preparation of a detachment of 20 personnel and 42 pieces of rolling stock loaded with equipment for a retrograde movement by ship to Hawaii. By 28 February, all preparations for embarkation were completed with personnel and equipment staged to go aboard ship.

General upkeep and maintenance of the individual Platoons and Company areas continued throughout February. Improvements were made to defenses of the various areas and work continues on projects dealing with immediate operational necessity or health and welfare of the personnel.

2. (C) During the month of February a decrease was noted in the number of hours of monitoring of Marine Tactical Circuits by the Transmission Security Elements of First Radio Battalion. Four TRANSEC monitoring positions were in operation. A total of 498.4 hours, 82.1 hours less than the total for January, were logged for February. Total transmissions monitored was 46,205,

an increase of 2,900 over January. Violations warranting issuance of a spot report numbered 44 as opposed to 71 for January, a significant decrease attributable to the active transmission security program in force by the III Marine Amphibious Force and its subordinate units.

3. (S) Enemy activity as reflected through the number of Direction Finding fixes showed a slight decline in February. The total number of fixes was 3,499. 160 of these fixes were obtained from the organic ground-used Short Range system of First Radio Battalion. 3,339 of these fixes were obtained from airborne resources. 1,021 of the aggregate number of fixes were identified. Fixes used as a basis for fire missions totaled 77.
