PART II - NARRATIVE SUMMARY

2 Oct - Maj ALLEN, Hq 1st Logistic Command, U. S. visited FLSG to discuss Inter-Service Supply Support.

5 Oct - Guard Dogs and handlers assigned to augment the security of ASP #1.

7 Oct - Gen McCUTCHEON visited FLSG Ration Dump.

7 Oct - Alert drill coordinated with the Air Base 1 Bn. conducted for Provisional Rifle Company under the command of Capt J. K. MILLER, Headquarters Commandant.

Time 2120 - Lt BALDWIN, BLACK BOX 3, reported breakthrough in Victor Sector 001737 (DRILL).

Time 2130 - Truck Co reported nine (9) trucks with drivers manned and ready.

Time 2140 - Provisional Rifle Company armed, assembled and mustered.

Time 2142 - 1st Plt and Co CO moved to Motor Pool.

Time 2150 - Last of the company moved to the Motor Pool.

Time 2158 - 1st Plt and Co CO arrived at objective.

Time 2200 - Last truck departed Motor Pool with troops.

Time 2205 - Drill completed.

9 Oct - Commanding General, FMFPac visited FLSG and toured the FLSG area with the Commanding Officer.

13 Oct - Rewarehousing of Class II supplies completed. Photographs of the new Class II warehouse are attached as enclosure (3).

15 Oct - BGen R. R. VAN STOCKUM, CG LFTUPac visited FLSG and was briefed by the Commanding Officer.

15 Oct - Senator BREWSTER of Maryland was briefed by the Commanding Officer.

20 Oct - The Commanding Officer briefed RAdm H. J. GOLDBERG, SC, USN, Chief Bureau of Supplies and Accounts at the III MAF Headquarters.

25 Oct - MajGen S. S. WADE visited the FLSG and was briefed by the Commanding Officer.

31 Oct - The combined strength of the Force Logistic Support Group and Logistic Support Units increased by 9 officers and 199 enlisted personnel during the month. 8 Marine Corps officers, 1 Navy officer, 198 Marine enlisted and 1 Navy

enlisted were joined. During the same period, 2 Marine officers, 2 Navy officers, 55 enlisted Marines and 4 enlisted Navy were transferred.

31 Oct - A recap of other Force Logistic Support Group functions follows:

- a. Data Processing key punched 84,375 cards, transceived 32,748 cards and processed 79,696 transactions during the regular supply updating runs. Testing of the transceiver net to Phu Bai and Chu Lai continued throughout the month. The Phu Bai tests have been successful, but the Chu Lai net is not yet established due to inadequate communications facilities.
- b. Clothing in the amount of \$49,558.62 was provided on an in-kind issue basis. Sales to Navy personnel amounted to \$5,180.10 and other Cash Sales were \$6,640.00. A total of \$12,190.69 in clothing was sent to the stores at Phu Bai and Chu Lai.
- c. EOD destroyed 4,592 assorted rounds and recovered 506 rounds.
- d. Shipping and Receiving processed 760 S/T 49,316 cube of outgoing materiel and 1,115 S/T 76,299 cube of incoming materiel (This does not include tactical organizations).
- e. Maintenance Company dispatched 175 Maintenance Contact Teams. A total of 4,825 items were evacuated to 3d FSR for 4th echelon maintenance or overflow 3d echelon. In addition, 2,306 work orders were received and 1,617 were completed during the period. The breakdown of work orders by commodity group follows:

f. The Fleet Stock Account processed 31,517 cu month.

g. The Fleet Stock Account held 56,054 obligations at the end of the month. All priority 02 and 05 requisitions have been passed by the Fleet Stock Account. Positive results have been obtained by placing critical requirements on Red-Ball.
